

#### Summary of the main achievements of the charity during the financial period

**Beavers (aged 5-8)** Have fun with recreational events, arts & crafts, and exciting activities.

**Cubs (aged 8-10)** Expand further their competence in a broad range of skills, including photography, science, basic first aid and sports. Short camps are used to get the young people active in the outdoors.

**Scouts (aged 10-14)** Longer camps and short expeditions help the young people develop their scouting skills. There is a broadening of interactions with other scout groups, which build leadership skills and citizenship. Scouts provide help for our annual senior citizens' Christmas dinner.

**Explorers (aged 14-18)** Undertake more advanced activities such as climbing, mountaineering and skiing. Explorers help with younger sections as part of our Young Leader programme.

The Trustee Board is to provide a safe environment for the activities of the group. The trustee's manages the group's hall and minibus and raises funds for ongoing maintenance and utilities. The trustee's also plans social events to bring parents together.

The group continues to develop our hall (Coppermine Community Centre) to the benefit of the wider community, including a large scale Netzero project in 2025.

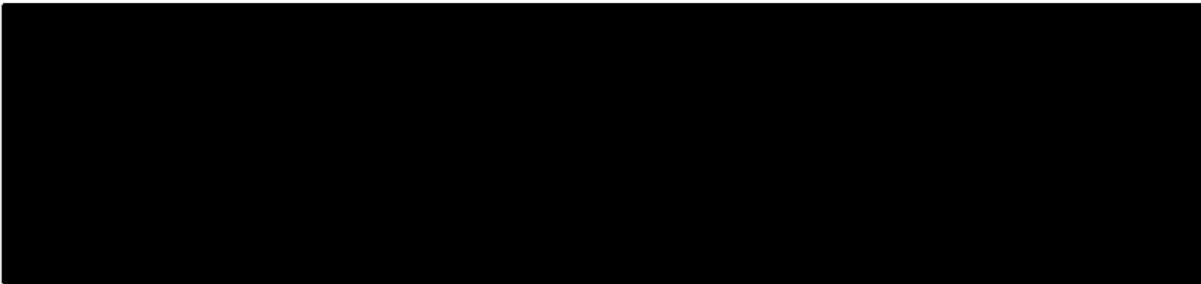



The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. **Basis of independent examiner's statement**  
 My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.
