COMMITTEE'S REPORT

The Committee, who are the trustees of the charity, are pleased to present their report and financial statements to members together with the independent examiner's report for the year to 31 July 2025, in accordance with section 10 of the society's Constitution.

ACTIVITIES, ACHIEVEMENTS, PLANS and FINANCIAL REVIEW

During the year, the Friends continued to support the Library and finances remain strong. The Visiting Research Fellows panel, convened by the Siobhan Convery, Director of Library Collections, awarded a total of 13 Fellowships. Support from the Friends directly enabled four of these awards, helping to ensure that scholars from around the world can engage with the Library's outstanding collections. Friends-funded Fellows this year included Rebecca Gould, Steven Livesey, Jodie Marley, and Emma Nuding, whose projects ranged from a study of Mary Queen of Scots, an analysis of medieval medical texts in the Ferguson and Hunter collections, through to research into the career of 19th-century Glasgow painter and engraver, David Scott. The Committee's continued support plays a vital role in sustaining high quality research and extending the international reach of our collections. Our membership remains supportive, however, the committee diminished significantly over the year and recruiting active committee members remains a significant challenge. For this reason we are bringing a proposal to an EGM, immediately following the AGM, on the future sustainability of the Friends.


Appointment of members of the Committee

INDEPENDENT EXAMINER'S REPORT

Independent Examiner's Report to the Committee of the Friends of Glasgow University Library

I report on the Accounts of the charity for the year to 31 July 2024 which are set out on pages 5 to 7.

Respective responsibilities of Trustees and examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity Trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement



NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 JULY 2025

1. Basis of Preparation

These accounts have been prepared on the receipts & payments basis in accordance with:

- (a) The Charities and Trustee Investment (Scotland) Act 2005
- (b) The Charities Accounts (Scotland) Regulations 2006 (as amended).

The activities of the Friends of Glasgow University Library are all exclusively charitable activities.

2. Continuing Funds

The Friends continuing funds are held in support of its ongoing charitable activities.

- (a) Unrestricted funds are those that can be used at the discretion of the Committee in the furtherance of the objects of the Friends.
- (b) Restricted funds are those that shall only be used for the purposes specified by the donor or trust deed.

As shown on page 6, there is only one restricted fund, known as the McKenna Fund; the interest from its capital to be used towards Library staff training.

3. Bank movement of funds

No remuneration was paid to trustees or any persons connected with them during the year. No payments were made to trustees in respect of their own expenses.
