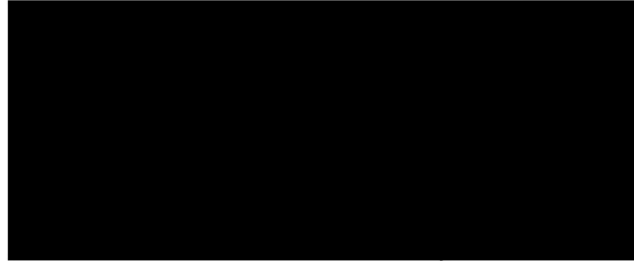

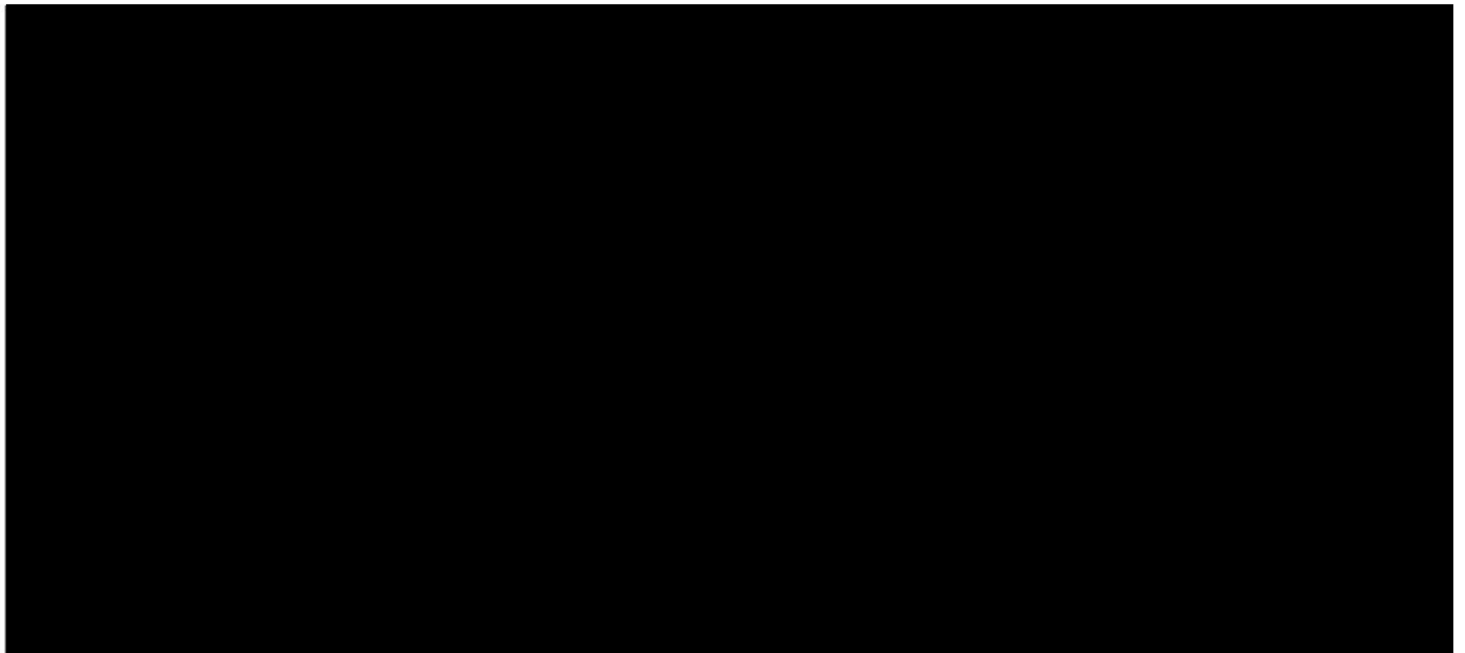

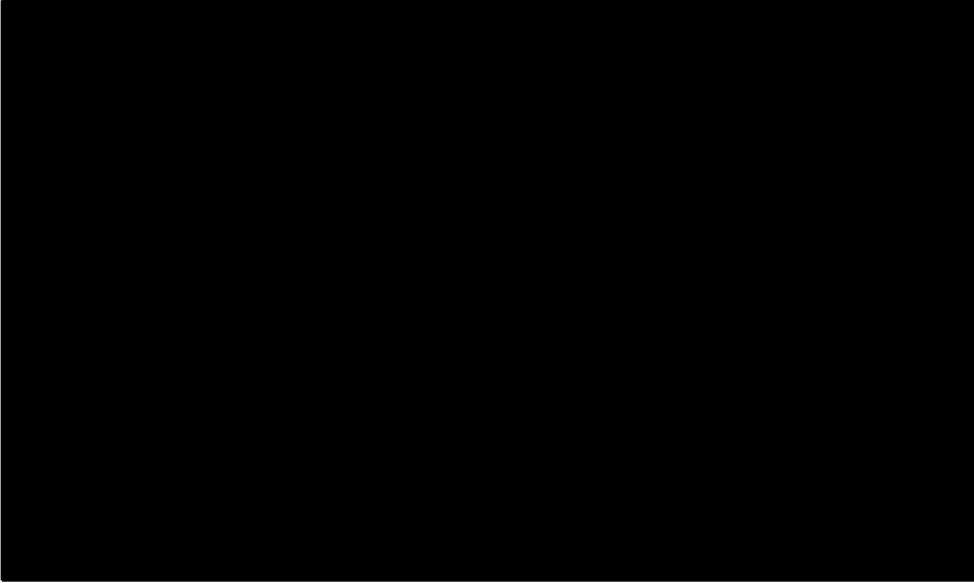

## TRUSTEES' ANNUAL REPORT YEAR ENDED 31 DECEMBER 2024

### Structure, Governance and Management

#### Governing Documents

The Church is administered in accordance with the terms of the Church of Scotland's Model Deed of Constitution.

#### Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Board Members are then appointed at the Stated Annual Meeting and serve for a period of three years, after which they must seek re-election at the next Stated Annual Meeting.

#### Organisational Structure

The Congregational Board is chaired by the minister and meets six times in a year. Certain responsibilities are delegated to the Finance Committee and the Fabric Committee as appropriate. The Kirk Session, which meets twelve times a year, is responsible for spiritual affairs within the church.

#### Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The normal service of worship is held each Sunday at 11.00am. The Women's Guild meets on alternate Thursday afternoons, the Carpet Bowling Club on Monday afternoons, the Scrabble Club on Wednesday afternoons, and Thursday Cafe takes place over lunchtime on Thursdays. Our Bible Study Group meets on alternate Thursday evenings and, on the second Saturday of each month, a coffee morning is held in the church hall and a service of prayers for healing in the church.

#### Achievements and Performance

2024 has seen further progress in our efforts to comply with Glasgow Presbytery's Mission Plan. We continue to maintain good relations with our friends at West and Wardlawhill and, during the year, a small group comprising of members of both Kirk Sessions has been meeting regularly to discuss the way forward. We have also continued to hold regular joint Sunday services. While our minister continues to be on medical leave, we are particularly grateful to our locum, [REDACTED] for keeping the life of the congregation running smoothly. She goes above and beyond the call of duty, involving herself in all of the activities of the congregation. Thanks are also due to [REDACTED] who was appointed Interim Moderator in May and has already made her mark

in guiding and supporting us as we work towards fulfilling the Mission Plan.

We continue to live-stream our services, in our efforts to keep in touch with those within and outwith our parish who, for whatever reason, are unable to attend church. The church website is regularly maintained and updated as necessary, and the quarterly Church Newsletter, even in this digital age, continues to be distributed to all members of our congregation.

Sunday lunches in the Greenhill Hall are eagerly anticipated by the congregation and never fail to disappoint. One only has to hear the sound of laughter and conversation to appreciate how successful these occasions are. This year, congregational lunches took place at Easter, Harvest & Christmas, and it is probably fair to say that folks enjoy the fellowship at least as much as the food.

Our regular monthly coffee mornings, incorporating Prayers for Healing, continue to attract visitors from within and outwith the congregation, and seem to be getting busier. While the fundraising for church funds and outside causes is an important aspect of the coffee mornings, once again the fellowship enjoyed by those who attend should not be underestimated.

The church was, as usual, open on Landemer Day for teas, coffees & the customary rolls and sausage, making our presence felt at the heart of the festivities on Main Street. We also continue to exploit our position on Main Street with our Thursday Cafe, when the church is open to members and visitors over lunchtime for prayer and quiet reflection in the sanctuary, and/or tea, coffee and good company in the Greenhill Hall.

In October, we had a good turnout of members in the Greenhill Hall for an afternoon of Dominoes and Donuts. The primary aim had been to raise funds for our church but, yet again, the fellowship shared by those who attended, whether novices or 'old hands', was just as important.

In November, as we have done for many years, we offered support to visitors at our All Saints Service and, one week later, on Remembrance Sunday, the Civic Remembrance Service took place. When civic dignitaries and representatives of the armed forces, local churches and organisations joined us in church and, later, at the cenotaph. This year, the sanctuary was beautifully and sensitively decorated with hundreds of knitted poppies, made by members and friends.

December rounded off a busy year with Burgh Primary pupils visiting for Christmas Unwrapped, and Gathered Voices Community Choir joining us at our Service of Carols and Lessons. Finally, as is our tradition, our Watch-night Service was a joint one with the Salvation Army.

Throughout the year, our members continued to look beyond our four walls with membership of the local Christian Aid Group and Rutherglen Churches Together, and in their donations of groceries, toiletries (and Easter Eggs) to the Lodging House Mission and the Rutherglen & Cambuslang Foodbank. In addition, in spite of the current cost-of-living crisis, they are to be commended for their financial support of various causes including Christian Aid, the Lodging House Mission, Leprosy Mission Scotland, Poppy Scotland, the Reachout Trust, the Red Cross, the Council of Christians and Jews, Rutherglen & Cambuslang Foodbank, and Lanarkshire Cancer Care Trust. Members of our congregation continue to support and participate in the life of our church in varied ways, and we sincerely thank them for giving their time, talents and money to this end. Naturally, we encourage them to continue to do so, enabling us to continue God's work in Rutherglen.

#### Financial Review

A General Fund deficit of £7,579 (2023 deficit £18,256) was incurred during the year. A deficit of £1,043 (2023 deficit £10,696) was incurred in the Fabric Fund during the year, and a surplus of £235 in the Youth Fund (2023 £0).

#### **Reserves Policy**

It is the Trustee's policy to hold reserves of between 6 and 12 months of expenditure including designated funds. At the year end the Church held unrestricted funds of £58,070, of which £12,788 been designated for a variety of purposes as specified in Note 2. This represents approximately 6 months of expenditure.

#### **Statement of Trustees' Responsibilities**

The members of the Kirk Session / Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session / Congregational Board are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2016. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

**Independent Examiner's Report to the Trustees of Rutherglen Old Parish Church of Scotland**

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 8 to 13.

**Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

**Basis of independent examiner's statement**

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006 (as amended). An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

**Independent examiner's statement**

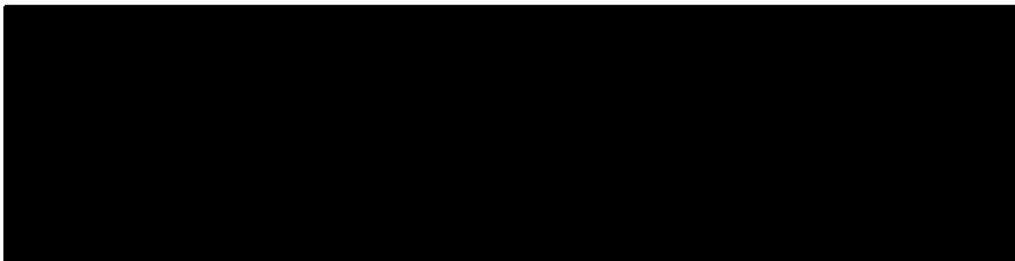

### **2. Purpose of Unrestricted Funds**

#### **General Fund**

The General Fund, together with the Designated Funds represents the free reserves of the congregation. The trustees are free to use the General Fund in furtherance of the Church's objectives.

#### **Designated Reserves**

##### **Fabric Fund**

Repairs and improvements to fabric and property are charged to the Fabric Fund

##### **Youth Fund**

The Youth fund is used to record the activities relative to the youth of the church.

#### **Purpose of Restricted Funds**

##### **Kirk Session Benevolent Fund**

This fund is used to assist those in need in the parish and is used at the discretion of the Minister

##### **Coffee Morning Fund**

This fund is to supply the organisations with equipment and supplement church funds.

##### **The Guild**

The Guild Fund is used to record the financial activities of the Guild.

##### **Flower Fund**

The Flower Fund is used by members of the Church Flower Committee to purchase flowers for display within the church and at other church events.

##### **Switch On**

The Switch On Fund is used to record the activities of the youth organisations in the church.

#### 5. Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £31,642 ( 2023: £30,135) and the maximum stipend (in the fifth and subsequent years) £38,884 ( 2023: £37,032)
