(b) To make such building available for educational, cultural, social and recreational activities of a community nature, and as a meeting-place for the local people, without restriction or discrimination of any kind on religious, political or other grounds. And (c) To apply such funds, both capital and income, as may become available to the Association from time to time, in the maintenance of and improvements of the said building and its facilities, and for such other purposes consonant with the foregoing objects, as shall be deemed by law to be charitable.

Independent Examiner's Report to The Trustees of the Skeabost Memorial Hall Association

I report on the accounts of the charity for the year ended 31 March 2025, which are set out on pages 2 to 8.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.



Type of Governance Document	<p>The Skeabost Memorial Hall Association is a charitable unincorporated association and the purposes and administrative arrangements are set out in the Association's Constitution.</p> <p>The policy and general management of the affairs of the Association shall be directed by the Skeabost Memorial Hall Committee.</p> <p>The title to all heritable property or properties which may be beneficially owned by the Association from time to time, shall be taken and held in trust for and on behalf of the Association by Trustees who shall be the Chair, Treasurer and Secretary for the time being of the Association and their successors in office. Up to two further Trustees may be appointed at an AGM. These Additional Trustees shall not be members of the Committee but shall meet with the Committee-based Trustees as and when necessary.</p>

Achievement and Performance – Continued

The most significant achievement of this year was the reroofing of the Hall which had begun to show signs of deterioration and ingress of rainwater. We applied for, and were successful in obtaining, grants from the National Lottery Fund and from the Highland Council which cover the main part of the cost. We gratefully acknowledge the assistance given by both those bodies. Specific mention must also be made of the contributions made by Skye u3a and personal anonymous donations by two of our own members. (Note – all of this fundraising was accounted for in the 23/24 accounts.) The remaining amount was found from within our own funds.

Financial Review

Brief statement of the Charity's policy on reserves

The Association held unrestricted funds of £7947 at the end of the year which represents, in the Committee's view, a sufficient amount to allow us to continue running effectively, covering day-to-day expenses and foreseeable maintenance etc.

Details of any deficit

The deficit shown is entirely due to the costs of reroofing the Hall and was covered by reserves.
