The Trustees present their report for the year ended 31 December 2025.

Gospel Literature Outreach Charitable Trust (SC007355) is a religious charitable society that began in Australia in 1965. The autonomous UK/ European division was formed in 1974 and was recognised as a Scottish Charity operating under its own Trust Deeds. The Trustees' application to change Gospel Literature Outreach Charitable Trust (SC007355) legal status from an unincorporated entity to a Scottish Charitable Incorporated Organisation (SCIO) was approved by OSCR on 24 October 2019 and GLO Europe was registered as a new Scottish Charity (No. SC049681).

The process to transfer Gospel Literature Outreach Charitable Trust assets to GLO Europe has taken a number of years to complete but the Trustees are pleased to advise that this was completed on 23 May 2022.

Therefore, for year ending 31 December 2025 no activity was carried out by Gospel Literature Outreach Charitable Trust and no annual accounts are included with this Trustee Report. All bank accounts associated with the charity are now closed and it would be the intention of the Trustees to fully close the charity by 31 December 2026 to allow the charity to be removed from the registrar.

A full Trustee Report and Annual account for GLO Europe (SC049681) along with the annual submission will be filed with OSCR where full details can be seen.

Objectives

Gospel Literature Outreach Charitable Trust is an autonomous Christian charity committed to the furtherance of the Christian Gospel. The main objectives are as follows and are now carried out by GLO Europe (SCIO) from 1st January 2025:

- To spread the Gospel of the Lord Jesus Christ especially in Europe and the UK.
- To establish resident teams of Christian workers to assist existing churches and establish new ones.
- To stimulate missionary vision, particularly by providing opportunities for short-term participation in missionary projects.
- To provide facilities for training those wishing to be actively involved in missionary work.
- To engage in the production, sale and distribution of Christian literature both in service to the Christian church and as a means of evangelism.
- To establish centres of Christian witness and community involvement where people can find help and encouragement.
