TRUSTEES REPORT

YEAR ENDED 31ST DECEMBER 2024

Trustees' Report

The Trustees present their Report and the Financial Statements for the year to 31st December 2024.

Principal Activity

The purpose of the Charity is to hold and administer the Trust funds:

"for the benefit of any one or more of the elderly disadvantaged resident in the geographic area in the former Royal Burgh of Dumfries who are by reason of poverty, indigence, illness, disability or age in need of relief or support, but for the purpose of such relief or support and not otherwise and in supplement of and not in substitution for public funds and services."

Structure Government and Management

The Trust was originally set up under a Deed of Declaration of Trust dated 27th November 1739. The terms of the Trust have been varied to recognise changing needs and circumstances. The last variation of the purposes of the Trust to those set out above was made by an interlocutor from The Court of Session on 19th December 2000.

Recruitment and Appointment of Directors/Trustees

The Directors of the Trust are Charity Trustees within the purposes of the Charity Law. The Trustees are drawn from four sources. From:-

- (1) Dumfries & Galloway – 6 Councillors are eligible for nomination.
- (2) Kirk Session of St Marys/Greyfriars – 3 members are eligible for nomination by the Kirk Session. Due to the closure of St Marys/Greyfriars and its transfer to Troqueer, which is to take effect in 2024, the nominations will be drawn from nominations by the Kirk Session of Troqueer.
- (3) St Michaels Church – 4 members are eligible for nomination by the Kirk Session.
- (4) Lastly, from the Community. At present there are 3 members from the Community.

With effect from 22nd September 2024, the Church of St Mary's/Greyfriars held its last service and in accordance with re-organisations carried out by the Church of Scotland, the responsibilities for the former parish of St Mary's/Greyfriars were being transferred to Troqueer Church. The Trustees for St Mary's/Greyfriars who are currently appointed will remain as the named Trustees until such time as confirmation is received from the Church of Troqueer as to whether those Trustees are being reaffirmed or new Trustees appointed.

The Directors/Trustees delegate the Management of the Trust to a Factor and a Management Committee, the Management Committee being made up of Directors nominated by the Annual General Meeting. Those nominated for the Management Committee have a tenure of a maximum of 3 years sitting on the Management Committee.

The Management Committee, in normal circumstances, meet not less than two times a year to determine Grant Applications which are invited from individuals or organisations who meet the Trust criteria. Advertisements are placed each year in local papers circulating in Dumfries in January and February, inviting applications to be lodged by 31st March and then in August and September for applications to be lodged by the end of September.

Financial Review

The Trust had a deficit in the current year of £17,835 (2023: surplus £28,904) and held reserves of £49,559 (2023: £67,394).

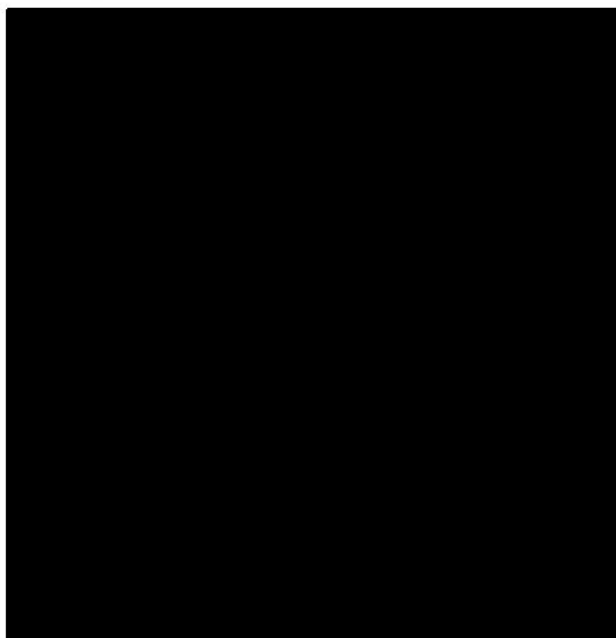

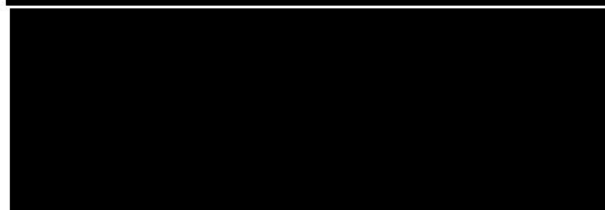

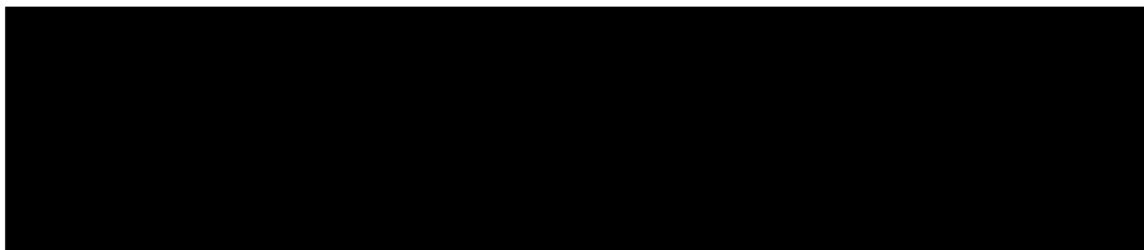
Activities and Achievements

Independent Examiner's Report to the Trustees of Moorheads Hospital Trust

I report on the unaudited accounts of the Charity for the year ended 31st December 2024 which are set out on pages 5-7.

Respective Responsibilities of Trustees and Examiner

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The Charity Trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under Section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent Examiner's Statement

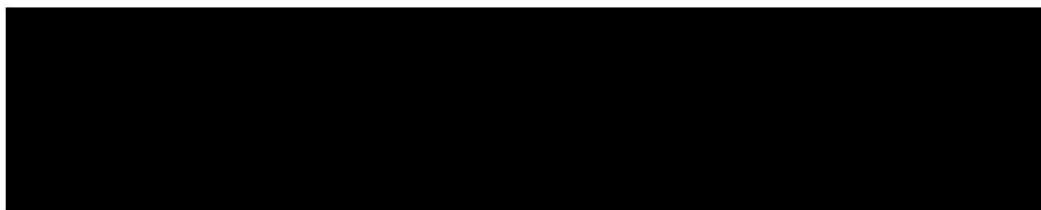
