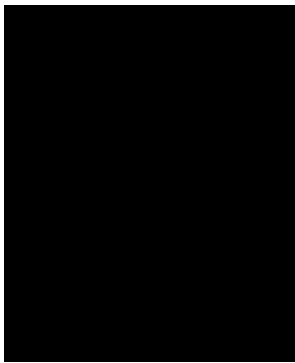
The trustees present their report and the independently examined financial statements of the Charity for the year ended 30 June 2025.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Rotary Club of Edinburgh Jubilee Charity Fund was established by trust deed dated 1961, amended 19 September 2002, 6 March 2008, 26 June 2014, 16 June 2016 and 11th May 2023. The management of the fund is the responsibility of the Trustees who are elected under the terms of the trust deed.

The Trust is a charity and was originally recognised as such by the Inland Revenue for taxation purposes. As a result there is no liability to taxation on any of its income. The trust now appears on the register of the Office of the Scottish Charity Regulator under Scottish Charity No. SC008757. The charity can be contacted at the business address shown.

Recruitment and Appointment of Trustees

The trustees consist of the President and Honorary Treasurer of the Rotary Club of Edinburgh (the Club) as ex-officio trustees and six Club members appointed as ordinary trustees at the Annual General Meeting of the Club. Two ordinary trustees retire annually by rotation. Retiring trustees shall be eligible for re-election, provided that they do not serve more than three consecutive terms of three years.

Trustees' Induction and Training

Trustees are encouraged to attend relevant training courses which deal with the subject of trustees' responsibilities. The trustees meet at least three times per year and receive no remuneration or expenses for their services to the charity. The charity employs no staff.

Risk Management

The trustees actively review the major risks which the charity faces and believe that maintaining the investment portfolio at its current level, combined with the policy adopted for making grants, will provide sufficient resources in the event of adverse conditions.

Related Parties

The Rotary Club of Edinburgh is deemed to be a related party and, as noted above, all trustees are members of the Club. The Club has its own Constitution.

OBJECTIVES AND ACTIVITIES

At an extra-ordinary general meeting of the Club held on 11 May 2023 the objects of the Trust were amended to reflect modern conditions and terminologies. These objects now are:-

- (a) To assist those in need, either directly or by giving grants to other organisations equipped to do so, especially:
 - the poor
 - the young
 - those with special needs, because of illness and/or disability
 - those concerned with the welfare of animals
 - those affected by disasters or major emergencies
- (b) To provide support for the advancement of:
 - education
 - religion
 - medical research
 - improvements to the environment
- (c) To give consideration to supporting any of the above that is:
 - located or based in or around the City of Edinburgh
 - located or based in a country without developed support structures
 - projects that are co-ordinated with Rotary International or other Rotary Clubs.

The trustees make grants and decide on the amount payable on the basis of written applications for funding or sponsorship.

Members of the Club and their families act as unpaid volunteers for the charity.

ACHIEVEMENTS AND PERFORMANCE

No specific targets for fundraising were put in place but fundraising activity raised £23,571 (2024, £16,034). The aim would be to maintain or enhance this level of activity in the future.

Grants distributed and projects supported totalled £32,362 (2024 £29,084) as listed in Notes 5 & 6 to the financial statements.

FINANCIAL REVIEW

Total revenue of £32,806 was up by £7,410 largely due to the May Challenge receipts and District Grants awarded. The trustees were able to award grants and project funding amounting to £32,362, an increase of £3,278 compared with last year.

Also, the investment valuations at 30 June 2025 exceeded the prior year valuations by £25,676. The trustees are satisfied that the financial aims were broadly achieved.

INVESTMENT POLICY

This is being achieved by the funds being invested in a spread of investment trusts and similar pooled investment vehicles. As a result of an investment review carried out in 2021, the portfolio was rebalanced to give more weight to income producing investments. This has largely been successful and has resulted in an increase in investment income.

RESERVES POLICY

The Reserves of the charity comprise the Endowed Fund and the Revenue Fund. The current Reserves policy was established at a meeting of trustees held on 5 September 2013 and, while both Capital and Income may be distributed, they agreed as follows:-

1 Endowed Fund

The Endowed Fund will be represented by the components of the investment portfolio held by Stocktrade on 1 April 2013. The only movements in the fund will be as a result of market value changes and additional funds invested.

2 Revenue Fund

The Revenue Fund will be represented by other funds at 1 April 2013 and will be credited with investment income, fundraising and donations received less grants, awards and other expenditure approved by the Trustees.

The Trustees aim to maintain revenue reserves of approximately 50% of annual outgoings. The results for the year are shown in the Statement of Financial Activities on page 7.

PLANS FOR FUTURE PERIODS

The trustees plan to continue the activities outlined above including fund-raising and making grants to a variety of deserving causes.

RESPONSIBILITIES OF THE TRUSTEES

The charity's trustees are responsible for preparing the Trustees Annual Report and the financial statements in accordance with applicable law and regulations.

The law applicable to charities in Scotland requires the trustees to prepare financial statements for each financial year. Under that law the trustees have elected to prepare the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards and applicable law). The trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charity and the income and expenditure of the charity for that period.

In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and accounting estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charity's transactions and disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

RESPECTIVE RESPONSIBILITIES OF TRUSTEES AND INDEPENDENT EXAMINER

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). In connection with my examination, no matter has come to my attention:

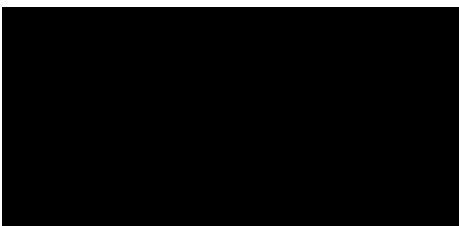
(1) which gives me reasonable cause to believe that in any material respect the trustees have not met the requirements to ensure that:

1 ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared under the historical cost convention, except for investments which are included at market value, and in accordance with applicable United Kingdom accounting standards, the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005 (SORP 2005) and the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

Investments

Investments are included at market value. Gains and losses on revaluation of investments are charged or credited to the SOFA.

Investment Income

Income from investments is accounted for in the year in which it is received.

Incoming Resources

All incoming resources are recognised once the charity has entitlement to the resources, is certain that the resources will be received and the monetary value of incoming resources can be measured with sufficient reliability.

Income represents donations and collections from the charity's ordinary activities.

Resources Expended

Liabilities are recognised as resources expended as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. These are allocated as between charitable expenditure and governance costs.

Charitable expenditure is incurred in direct pursuance of the charity's principal objects through fund raising activities carried out by The Rotary Club of Edinburgh.

Governance costs comprise all costs involved in compliance of regulation and good practice.

VAT

The charity is not registered for VAT and accordingly expenditure includes VAT where appropriate.
