Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session meets four times a year and is responsible for the spiritual affairs within the church. Certain responsibilities are delegated to the Finance Committee and the Property Committee as appropriate.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

Another year and another year older! We are gradually heading out of those wilderness years of the pandemic and all that it entailed, with the grief and sorrow as well as time to reflect and see where God is leading us. As we emerge, we see familiar faces returning and the joy of seeing new ones!

In this annual report you will see much of where we use our resources, what is necessary, what is important and what is vital to the life of the church.

Trustees' Annual Report (cont.)

Year ended 31 December 2024

My desire for us as we continue to grow as a church is to grow deeper with God and one another, but also to grow outwards and be known as "a church that loves".

We must continue to seek God in all we do, to continue to seek God's plan and purpose for our lives and that of the Church, to take risks and to enjoy the journey that God is taking us on, for the year to come, I hope we will continue to think about how we can grow to be more like Jesus, in relation to God, to each other and to the world around us.

Financial Review

The congregation is generous and continues to support the ongoing work of the Church both locally and nationally. Congregational giving decreased by £10k to £180k. This is entirely due to the late receipt of Gift Aid refunds (£18k). Ongoing expenditure excluding prior year loan repayments (£45K) increased by £28k. The General reserve deficit was (£42,315) prior to transfers and receipt of capital funds totalling £23,882. The Restricted funds surplus was £13,786.

Reserves Policy

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold reserves of approximately 6 months expenditure including designated funds. At the year end the Church held unrestricted funds of £30,026. This represents 3 months normal church expenditure. However a capital transfer of £30,000 will be received during the 1st quarter of 2025. Notwithstanding this transfer, and the trustees will continue to look at ways of building up this reserve.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Dalkeith, St John's and Newton Parish Church

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 7 to 12.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

2 Movement in Funds (Continued)

Audio Visual: This is a fund to assist with the cost of implementing new audio-visual equipment.

Church Energy Fund: This is a relates to specific restricted funds by member of the congregation to help meet energy costs following the substantial increase (300%) in tariffs following the expiry of the previous contract. The contract term is two years.

Energy Audit: Funds received to produce an Energy Audit for the church in order to reduce our carbon footprint.

Fabric Fund: This is a fund to assist with the cost of undertaking significant capital expenditure projects as well as ongoing property repairs and maintenance.

Local Ministry and Outreach staff: This fund supports the outreach and ministry of our family and youth workers.

Mens Group: Funds received to establish and support a men's group at Newton Church Hall, Danderhall

Missionary Fund: This is a fund to support children in third world countries to provide basic food needs and education.

Mothers of Primary School Children: Funds to allow mothers of pre-school children to meet, socialise and support each other.

Outreach: This is a fund to support people who require assistance with basic human needs of adequate food and shelter for themselves and their families.

Pioneer Ministry: Grant funds received to assist in the employment of an outreach worker to develop community initiatives in Millerhall and Shawfare. Funding received for two years commencing 1 April 2023.

St John's Small Hall Development: This is a fund to assist with the costs of refurbishing the small hall.

Youth Development: This is a fund that provides financial assistance for projects that will develop the young persons confidence and character.

Purposes of Designated Funds

Alpha: This fund is used to develop and run the annual church Alpha programme that freely explores the basics of the Christian faith.

Café: The café is managed by a church member and run by volunteers of the church and is used by the locals and communities within the area.

Rent: This fund accumulates the rent we receive for hall lets and is used to pay the salaries of the Caretakers

Holiday Club: This fund is used for holiday club contributions and expenses.

Sunday Club: This fund is used to assist with the costs of developing youth fellowship within the church and wider community.

5 Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £31,642 and the maximum stipend (in the tenth and subsequent years) £38,884.
