The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by the Presbytery.

### Organisational Structure

The Kirk Session meets six times a year. While the Kirk Session is responsible, and individual members of the Session as Elders, act and seriously accept their role as Trustees in relation to Charity legislation, the practice allows for greater flexibility in the manner in which allows Elders to manage their skills and talents in specific areas of interest. The Kirk Session makes its decisions, sets its priorities on behalf of the Congregation, and in the form of committees looks after the various aspects of the Congregation's life and witness (Finance, Property etc). The Kirk Session is responsible for preparing the remit of each committee. The members of the committees must include Elders, but do not need to comprise solely of Elders, and, therefore, a number of people, who would be unwilling or unable to accept the obligations and duties of Eldership, are able to be fully involved in the life of the Congregation and its organisation as circumstances allow.


## Statement of Trustees' Responsibilities

## Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, reformed in tradition, and Presbyterian in polity. It exists to glorify God, and to work for the advancement of Christ's kingdom throughout the world. As a National Church it acknowledges a distinctive call and duty to bring the ordinances of religion to the people of every Parish of Scotland through a territorial ministry. It operates with other churches in various Ecumenical bodies in Scotland and beyond.

As a rural parish, Kilmaurs: St Maur's-Glencairn thrives to be at the centre of Community Life, with services at 11.00am in Church on Sunday mornings. Family services are held regularly throughout the year, when the emphasis is aimed at the younger members of the family circle, and normally in association with Messy Church. Communion Services are held three times a year, on the first Sundays of March, June and October. Communion is also celebrated during the service on the last Sunday of the year. Throughout the year, Kilmaurs: St Maur's-Glencairn participates in celebrations and festivities; Mother's Day, when a daffodil posy is presented to every lady in Church on the day, courtesy of the Flower Committee; Holy Week services are held in conjunction with Crosshouse Church, with the 2025 Maundy Thursday service in Crosshouse Church, and the Good Friday service in St Maur's-Glencairn, with the retiring collection on both evenings being on behalf of the Scottish Bible Society. Being a rural parish, Harvest Thanksgiving is a big event within our calendar, and the Harvest Committee deserve great praise and thanks for the magnificent display within the Church. Harvest gifts collected before and during the service were presented to East Ayrshire Foodbank at the conclusion of the service. Remembrance Day saw a good representation from the Brownies and Guides, the Scout Group, and various other village associations and organisations. Colours were presented, and at the conclusion of the service several wreaths were laid, on behalf of the local associations at the War Memorial. A retiring collection on behalf of Poppy Scotland was also uplifted. The spontaneous Nativity Play, organised by Messy Church, was a great success, and congratulations should be heaped on all who helped create, write, direct and produce this play, and to all the children and adults who participated during the service, helping to bring the true meaning of Christmas to the village. The Christmas Eve Watchnight 'Carols by Candlelight' service was again held at 11.15pm in Church, with a retiring collection on behalf of Christian Aid.

Maintenance is an integral part of Kirk Session business, and Roan Rutherford regularly updates the Session on the Church and Manse Fabric. This year we had an integrated inspection of the Church by the Presbytery Building's Officer Esme Greenan, who produced a lengthy report on the interior and exterior condition of the building, and categorising the need for repair or replacement, which will act as a blueprint for further maintenance projects. During the year we repaired the two larger Rose Windows, and stripped the plaster from the stonework in the West vestibule to lessen the damage to the internal stonework. Work is still needing to be done to the tower, to comply with some of the more essential

repairs on the report. The list is lengthy, but, the Session will work through it and set out plans in respect of urgency.

The Church choir, ably led by David Hunter, continues to attract new members. The Introids and incidental music played are pertinent to the season or time of year, set the scene for Morning Worship, and bring another aspect of spiritual meaning to the service.

The Guild continues to meet in the Community Centre, and is much enjoyed by all members. Speakers come from all walks of life, and entertain, inform and educate members on matters local, national and international, with special emphasis on specific current Guild Projects at home or overseas, but always with the over-riding theme expressing the Guild motto of 'Whose we are, and Whom we serve'. Members of the Guild continue to remind us all that new members will always be made most welcome, and that membership is open to males as well as females !!!

Messy Church continues to be a Kilmaurs success story. The Messy Church committee should be heartily congratulated not only for their programs and syllabus, but also for their dedication and enthusiasm to promote such a worthwhile and enjoyable aspect of Kilmaurs: St Maur's-Glencairn Church Life. It is designed for children and adults, and aimed at all ages and families. Why not come along, and give your support to this dedicated group who continue to provide an excellent service to our Church and the wider Community.

The Flower Committee work extremely hard to ensure the Sanctuary has a floral display every Sunday morning, and during all Church festivities, or special occasions. All Sundays within the year are covered, and volunteers for distribution after the service is also well planned. Anyone wishing to be added to the Flower List or to assist with monthly distribution should contact the Minister, or any member of the Flower Committee.

The Action Group forms the social committee of the Church. Post Covid has been difficult for the Action Group, but they have again risen to the occasion promoting the monthly 'Tea, Coffee, Biscuit and a blether' sessions on the last Sunday of each month after the Morning Service. The Sponsored Walk 'roon the park' has also been reborn and enjoyed by all the walkers taking part. New members will be made most welcome, as they say new members bring new ideas.

We welcomed several well known Ministers for pulpit supply during the latter part of the year. Two of our own members, Rev James McCulloch and Rev Dr Samuel Lamarti stepped back into their robes to conduct several services, as did Rev Bill Jackson, Rev Scott Rae, Very Rev William Hewitt and Very Rev Dr David Lacy, and we thank them most sincerely for their experience, help and guidance during September, October and November.

Over the past year we lost many members who dedicated their lives to the work and witness of this congregation, and we surround their families with our love and prayers that they may know God's comfort in their sad bereavements.

We welcome Kenny Thomson as our new Roll Keeper, and wish him well in his appointment. Saskia Yates and Anne Barnaby are now involved in the joint post of Gift Aid Convenor and will be in consultation with HMRC for Tax returns due. We wish them well in their endeavours.

The Church of Scotland continues to change, the local Church is changing, but during all the changes taking place locally or nationally, within the Church or community, one thing is constant and that is the special relationship Kilmaurs has with its Minister and Manse family. We would, at this time, like to thank John and Barbara for their continual leadership, their friendship and affection, their dedication and support, their Spiritual Guidance to all within the Church and in the wider Community, and we hope and pray for very many years to come.

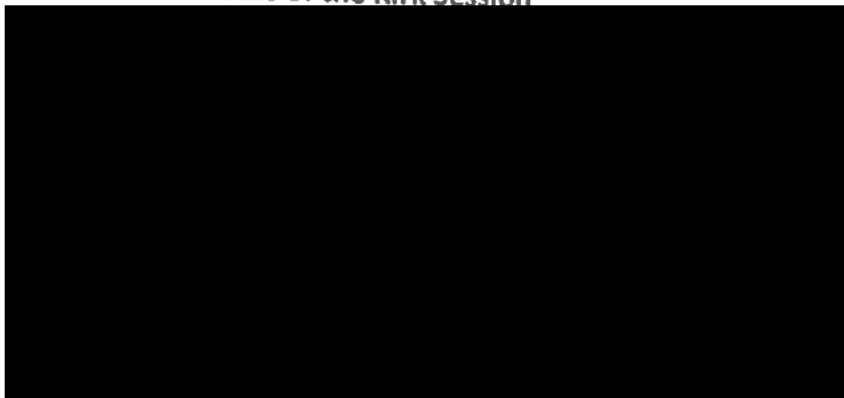

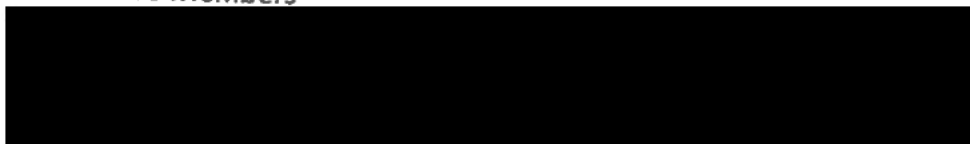

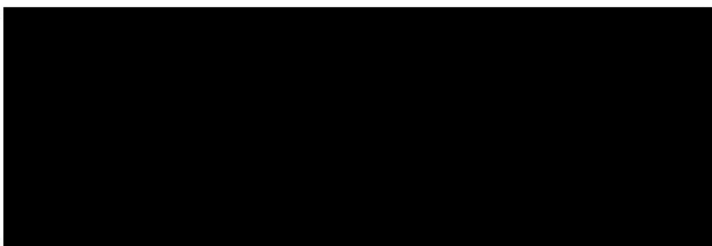

Mother's Day, when a daffodil posy is presented to every female in Church on that day, courtesy of the Flower Committee. Holy Week services, Maundy Thursday and Good Friday, are joint with Crosshouse Church, 2024 Maundy Thursday Communion service in Kilmaurs, and Good Friday in Crosshouse, with the retiring collection, for both services, being in aid of The Scottish Bible Society. The Messy Church team organised an Easter Egg rolling event prior to the morning service on Easter Sunday. The Harvest Thanksgiving team decorated the Church for the morning service. This is much appreciated by the congregation, and highlights the wonderful work of a Farming and Agricultural Community, deep in the heart of Ayrshire. The Harvest gifts in 2024 were split between East Ayrshire Foodbank, and Kilmaurs Primary School's Community Food Larder. The Brownies, Guides and Scout Group again presented their colours during the Remembrance Day morning service, and the Community was well represented at the wreath laying service at the War Memorial in Morton Park after the morning service. The Church was decorated by the Action Group for the Advent Season. The Action Group also supply the Advent Crown, which is lit during the four Sundays of Advent, with the centre candle being lit to welcome in Christmas Day during the Watchnight service. The Church bell is also rung on the stroke of midnight to indicate the arrival Christmas Day.

February 2024 saw us Ordain three new Elders [REDACTED] and re-admit [REDACTED]. The new Elders signed the Formula and were given the Right Hand of Fellowship from the Minister and Kirk Session. Districts were re-configured during the year, and Elders were assigned to a district in the latter part of the year.

Maintenance of Property is a big issue. During the year, extensive work was carried out to the Manse doors and roof, roughcast, insulation/render repairs and to the slabs around the Manse. These were all carried out in the Spring/Summer of the year. Some remedial pointing repairs was also completed at the Church. All in all, the Property is in good repair

throughout, and much appreciation is extended to the Property team for their diligence and concern.

One of the big issues in all organisations such as ours is Safeguarding. We are very fortunate to have [REDACTED] as our Safeguarding Co-ordinator. Since her appointment was confirmed, the majority of Trustees have completed their basic training renewal, and the Safeguarding Register has been completely updated to detail all changes. We await guidance from the Safeguarding Service re-the implications resulting from the Disclosure Scotland Act 2020, which may result in more advanced training of all Trustees, and PVG certificate holders, of which we will be notified in due course. We thank [REDACTED] for her sterling work since becoming Safeguarding Co-ordinator, and look forward to working with her in this most important role.

Church organisations continue to flourish. The Guild meets in the Community Centre and is dedicated to support themes, topics and strategies, set out at National level which for 2024-25 is 'Sure Foundations'. The Guild is open for women and men, and speakers are always open and entertaining.

The Flower Committee, which ensures there is a floral exhibit in Church every Sunday morning, and for special services, which is then distributed, on a rota basis to members of the congregation or community after the morning service.

The numbers in the Choir has again risen during the year. We are pleased to see our Organist [REDACTED] has recovered from his injuries, and is once again back in place. The choice of Introit and incidental music, is also to be commended. Could we at this time thank our Minister for deputising for [REDACTED] during his recovery.

The Action Group continues to host the monthly 'cuppa', after the morning service. We are also pleased to report on the Group's revival of the Annual Trip in August, and the Sponsored Walk in September. The Annual Blytheswood Shoebox Appeal was again organised.

Messy Church meets monthly in the Community Centre. Themes are Biblical based, and activities include art, crafts and stories. These are fun activities for parents, friends and children to do together, and there is always a time for Worship, before everyone shares food. Messy Church also organised the spontaneous Nativity Play, which for 2024 was outstanding.

In Kilmaurs: St Maur's- Glencairn, 2024 has undoubtedly been the year of [REDACTED] [REDACTED] joined us in firstly in 2020, during the Covid pandemic. He joined us again for his Probationer Training. In the Church of Scotland Probationers are candidates for the Ministry, who, after completing their studies, undertake a fifteen month placement in a Parish, supervised by a trained Minister, before seeking a first charge. This placement is set to provide practical experience and preparation for life in a Parish, with the object of preparing them for Ministry. Throughout this training, candidates attend Review meetings set to document training achieved, with the identification of areas for further development.

Interim and final Probationer appraisals are then conducted, and must be completed before they can seek a permanent appointment and Ordination.

David immersed himself fully in our Church community. During Sunday services, he firstly read the lessons, progressing to leading Prayers, and Preaching the Sermon, finally conducting full services. He dedicated his life to the life of our Parish, which was much appreciated by all who came into contact with him in this capacity. He attended the sick and housebound, he visited Nursing homes, hospitals and hospices. His progress was reported at Kirk Session meetings, where he would furnish the Session with first hand accounts of his work. He spoke at the Guild, he worked diligently with the Messy Church Team, and assisted setting out the program for the year, he attended Action Group meetings and joined in the Sponsored Walk, and conducted the evening service in Largs during the Annual Trip to Cardwell and Largs. He visited the school and assemblies. He spoke about his pilgrimage to Iona, and how this would affect his ministry. He introduced the congregation to various 'unknown' Saints Days, and world wide 'festivities'. During his time with us, he was able to achieve a long-held ambition of working in chaplaincy with NHS Fife, which he found challenging, but, so very worthwhile, and spoke about the 'power of Prayer' in real life situations.

He carried out his work in our Parish to great effect. This was evident on his last Sunday with us when he was presented with a very generous gift from our congregation, and our best wishes for future success.

Again we face challenges, again we are focussed on the challenges. The Kirk Session, through its Convenors and Committees, will continue to work for the benefit of the congregation.

The congregation is ever thankful for the devotion, dedication and commitment of [REDACTED] and pray for their continual leadership, friendship, support and guidance, which has been a great comfort, and we hope and pray for many more years to come.

on the view given by the accounts.


