Trustees' Annual Report for the Calendar Year 2024

#### Aims and Objectives

We are a church congregation. Our objectives, as enshrined in our constitution of 1st May 1961, as subsequently amended, are to proclaim the gospel of Jesus Christ as the Word of God in the strength of the Holy Spirit and on the basis of the Old and New Testaments.

Specifically, in its proclamation of the Gospel, its pastoral care and social work, the Congregation recognises its responsibility towards all German-speaking persons residing permanently or temporarily in Scotland, holding regular services in Edinburgh, Aberdeen and Glasgow.

#### Administration

The ultimate governing body of the Charity is its membership, in the form of the Congregational Assembly, which makes decisions at its Annual or Extraordinary General Meetings. The day to day management of the Charity's affairs is vested in a committee known as the Church Council. All members of this committee act as Trustees and thus as formal owners of the congregation's assets on its behalf.

Committee members are elected by and from among the membership to four-year terms of office. These elections generally take place at every second AGM in such a way that at each election approximately half the committee is elected.

On 22nd November 2023, consent from OSCR was given for us to change our name to "German Speaking Congregation in Scotland" to reflect the proposed union of our sister congregation in Glasgow (SC014274) with ourselves. Consent was likewise given for this union to go ahead by way of Glasgow congregation being wound up once all its assets were transferred to us.

Both our name change and the union took effect de facto from January 2024, and both were duly formalized at our first joint AGM held on 4th May 2024.

Membership stood at 113, including 20 from the former Glasgow congregation.

#### Activities

2024 was a year of major transition for our congregation. It began with the election of a new pastor, [REDACTED] who officially started in August. Another significant event was the union of the Edinburgh/Aberdeen and Glasgow congregations (see above).

In July, we bid farewell to pastor [REDACTED] after nine years in office. Throughout the year, our congregation celebrated many events across all three locations, including confirmation of nine young members at Pentecost, a service at Thanksgiving, the inauguration of [REDACTED] and numerous festive services and activities for Easter, St Martin, Advent and Christmas.

The bulk of our charitable expenditure goes towards maintaining our property (we own the church building and attached manse at 1 Chalmers Crescent, Edinburgh) and towards supporting the work of our pastors. Accordingly, we make a significant annual donation (£43,800 this year, including what would have been Glasgow congregation's share) to our parent charity, the Synod of German-Speaking Lutheran, Reformed, and United Congregations in Great Britain (registered in England No 266600), which acts as formal employer to our pastors, whose duties are divided between us and our sister congregation in Newcastle.

Expenditure on property maintenance was significant this year, with a major renovation of our manse necessary, no significant work having been done to the property since it was built in 1966. The change of pastor presented an ideal opportunity for this, but the duration of the works (which continued into 2025) made it necessary to house the new pastor and his family elsewhere temporarily. We were able to rent a flat from the Church of Scotland for this.

In keeping with tradition, 20% of the proceeds of our main fundraising event of the year, our annual Christmas Fair, (a sum of £500) was donated to a local charity (this year the Edinburgh charity Fresh Start). Other charities that we supported by way of collections from services included Unicef, Christian Aid, the Salvation Army, and Edinburgh City Mission.

#### Reserves

Our total reserves amount to approximately £1,685k.  
The committee regularly monitors the level of reserves.

The year 2024 saw a deficit of circa £188k.

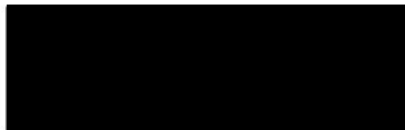

Independent Examiner's Report to the Trustees of the  
German Speaking Congregation in Edinburgh and Aberdeen

I report on the accounts of the above charity for the year ended 31st  
December 2024 which are set out on the attached pages.

The charity's trustees are responsible for the preparation of the  
accounts in accordance with the terms of the Charities and Trustee  
Investment (Scotland) Act 2005 and the Charities Accounts (Scotland)  
Regulations 2006. The charity trustees consider that the audit  
requirement of Regulation 10(1)(d) of the Accounts Regulations does  
not apply. It is my responsibility to examine the accounts as  
required under section 44(1)(c) of the Act and to state whether  
particular matters have come to my attention.

My examination is carried out in accordance with Regulation 11 of the  
Charities Accounts (Scotland) Regulations 2006. An examination  
includes a review of the accounting records kept by the charity and a  
comparison of the accounts presented with those records. It also  
includes consideration of any unusual items or disclosures in the  
accounts, and seeks explanations from the trustees concerning such  
matters. The procedures undertaken do not provide all the evidence  
that would be required in an audit, and consequently I do not express  
an audit opinion on the view given by the accounts.

In the course of my examination, no matter has come to my attention  
which gives me reasonable cause to believe that in any material  
respect the requirements [to keep accounting records in accordance  
with Section 44(1)(a) of the 2005 Act and Regulation 4 of the 2006  
Accounts Regulations, and to prepare accounts which accord with the  
accounting records and comply with Regulation 9 of the 2006 Accounts  
Regulations] have not been met, or to which, in my opinion, attention  
should be drawn in order to enable a proper understanding of the  
accounts to be reached.
