To feu, sell, manage, lease, mortgage, exchange, dispose of or otherwise deal with all or any part of the property, heritable or moveable, of the Company as may be expedient with a view to the promotion of the objects. 5 To borrow and raise money for the purposes of the Company in such manner as they may think fit. 6 To invest the monies of the Company not immediately required for its purposes in or upon such investments, securities or property as may be thought fit, subject nevertheless to such conditions or restrictions (If any) and such consents (If any) as may for the time being be imposed or required by law or the terms of grants or bequests from trust or other charitable bodies and subject also as hereinafter provided. 7 To print and publish any newspapers,

periodicals, books, leaflets, or advertisements, that the Company may think desirable for the promotion of its objects. 8 To undertake and execute any charitable trust which may be deemed necessary or convenient for any of the objects of the Company.
