Notes to the Accounts for the Year Ended 31 August 2025

1. ACCOUNTING POLICIES

The accounts are prepared under a receipts and payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

2. AWARDS

Lauder Award

The Lauder Award has been in existence since 1918. It has been made possible by a legacy left to the Society by the late Gertrude Annie Lauder, a member of the Glasgow Society of Lady Artists. The annual investment interest provides the Award which is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

McCredie Award

Miss Agnes C McCredie, who was also a member of the Glasgow Society of Lady Artists, died in 1987 and left a sum of money to the Society. In 1990 this sum was increased by her three nieces. The annual investment interest provides an Award which is restricted to Applied Art exhibitors particularly those in Textiles and Embroidery in which Miss McCredie specialised. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

The Flora Wood Award

Flora Wood was a painter and sculptor member of the Society who died in 1998 leaving a sum of money to fund an award to be known as "The Flora Wood Award for the Most Original Work" at exhibitions. The annual investment interest provides the Award which is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

GWSA Special Award

The GWSA Special Award which commenced in 1996, is open to all exhibitors and is funded by the Society. The value is determined in line with the other award amounts applying at the time. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

The Scottish Amicable Award

The Scottish Amicable Award originated in 1989 as a gift from Scottish Amicable Life Assurance Society. The annual investment interest provides the Award which is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

The Blytheswood Square Quaich

In 1989 the Royal Scottish Automobile Club, whose Blytheswood Square headquarters in Glasgow lie adjacent to the original Lady Artists' Club, presented a silver quaich to be awarded annually at an Exhibition of the Society with the recipient's name inscribed. The award is known as the Blytheswood Square Quaich and is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years. In 2015 it was agreed that the Society would supplement this Award with the sum of £100.

The Jan Bruce Award

Jan Bruce was a highly respected artist member of the Society who died in 2004 leaving a generous sum of money which it was agreed by members should form an Exhibition Award to be known as the Jan Bruce Award. The annual investment interest provides the Award which is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years.

The Louise Annand McFarquhar Award

Loise Annand McFarquhar, twice President and latterly an honorary member, died in 2012 leaving a sum of money to the society with which it decided to purchase a silver salver to be awarded annually at an exhibition of the Society and inscribed with the recipient's name. The award is known as the Louise Annand Salver and is open to all exhibitors. There is no stipulation that an award be made each year, and no Exhibitor may receive the Award on more than one occasion within three years. In 2015 it was agreed that the Society would supplement the Award with the sum of £100.

**Report of the Independent Examiner to the Trustees of

I report on the accounts of the Charity for the year ended 31 August 2025 which are set out on pages 1 to 7.

Respective Responsibilities of Trustees and Examiner

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The Charity Trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under Section 44(1)(c) of the Act and to state whether particular matters have come to our attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the accounts.

Agenda circulated by email prior to the meeting and Accounts circulated at the meeting.

Minutes of the previous meeting having been circulated were approved by all.

President's Report (see appendix) was delivered by Lynn Howarth, our outgoing president and she highlighted the activities of the society and how it had been a privilege to serve as president for over three years, as she had risen to the need as Vice President when Carol Dewart had to resign over illness.

Statement of Accounts and Treasurer's report.

Helen Thompson had received the accounts from the Independent Examiner only hours before and had not had time to fully assess them. She reported in brief that while we had a deficit on the year, it was mainly due to two factors. One was doubling the fee we now pay to our guest speakers, and the other was the removal of the GSWA 10% commission on sales at the annual exhibition at the Maclaurin gallery. She reports that the society had sufficient funds to continue its purposes.

Vote to re-appoint the Independent Examiner of accounts: Ann McLaren BA CA was unanimous.

Vote to re-appoint the Treasurer, Helen Thompson, the Membership Secretary Sheila Tandy was unanimous.

A presentation bouquet of flowers was made to Lynn Howarth, along with a cash gift made up of contributions collected from the members.

Election of a new president: Carol Moore was proposed by Lynn Howarth and seconded by Julia Gurney

Election of a new secretary: Margaret Burnell was proposed by Lynn Howarth and seconded by Carole Allan.

Vote of thanks to Susan Reid who steps down after her three-year term on council. She held responsibility for the co-ordination of the lunches at each of the Monday talks. Additionally, Susan inaugurated the Plein air group.

Lynn Howarth and Fiona Wilson were elected unanimously to serve on council.

The AGM business having concluded, Michelle Ives was invited to give a demonstration of painting in Acrylic colour on wood panel.
