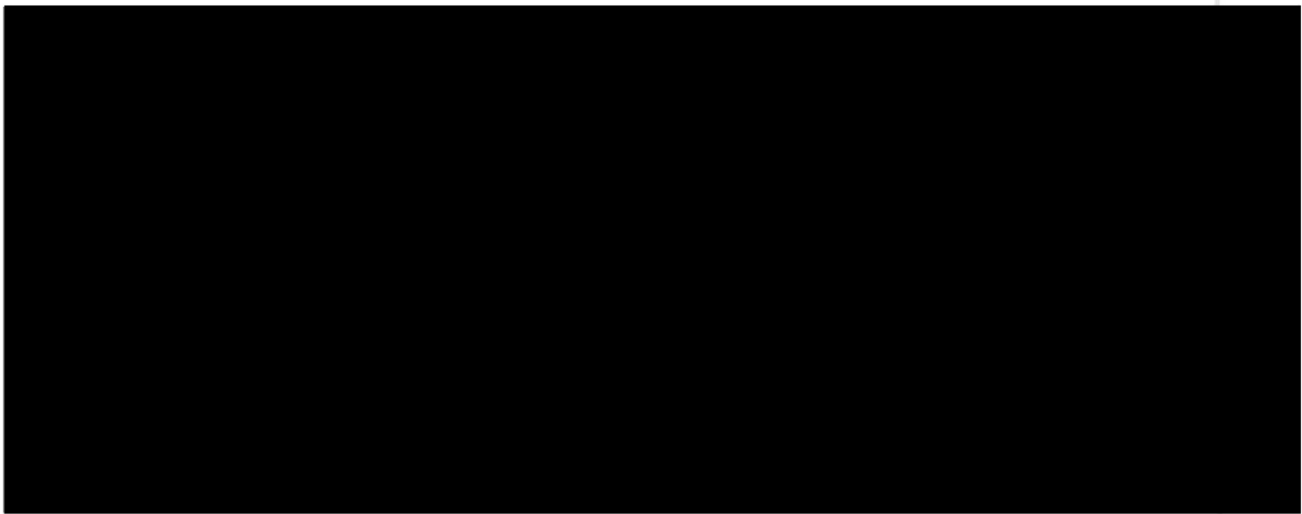

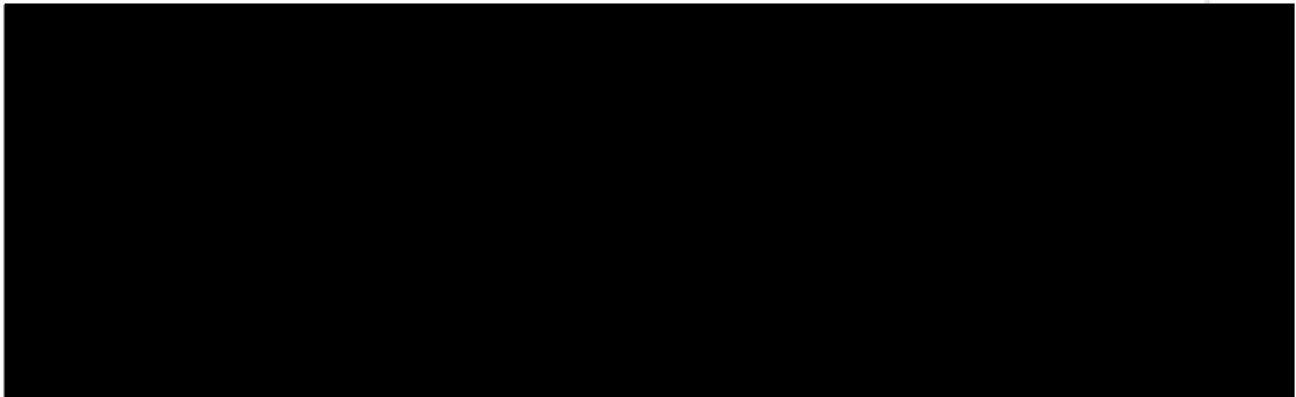

## **Trustees' Annual Report**

### **for the year ended 31 December 2024**

## **Structure, Governance and Management**

### **Governing Document**

The Church is administered in accordance with the terms of the Unitary Constitution.

### **Recruitment and Appointment of Trustees**

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. In a ministerial vacancy, Presbytery appoints an Interim Moderator who is also a trustee.

### **Organisational Structure**

The Kirk Session which meets nine times a year is responsible for all affairs within the Church under the Unitary Constitution. The Kirk Session appoints work groups from time to time which consider specific areas such as Mission, Membership, Spiritual Maturity, Worship, Youth, Ministry and Property.

### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

### **Achievements and Performance**

Our Church has been working together with Burns and Old congregation having joint monthly services and other joint functions which are bringing the congregations together towards a union in December 2025. We also take a very active part in the Kilsyth and District Churches Connecting together to co-operate with other denominations in providing a loving and Christian Mission to the local community. Our BB and GB continue to work towards the higher awards available through these organisations. The Church hosted a number of holiday club events - one week long and a couple of day events. Our roll is currently 198 members, 73 adherents (many of whom are regular attenders and supporters) 12 children attending Jam club and around 84 young folks involved in BB and GB. 17 Funerals were conducted.

### **Financial Review**

The principal source of receipts is weekly offerings and donations together with gift aid tax refund. During the year 2024 total receipts amounted to £110,334 (year 2023 - £106,497). Total payments amounted to £115,606 (year 2023 - £91,494). That resulted in a reduction in cash this year of £5,272 compared with a surplus last year of £15,003. However, the 2024 payments included the purchase of £25,000 of investments and when one excludes that there was a surplus of £19,728. Fuller details of the receipts and payments are given in the accounts.

**Reserves Policy**

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold reserves of approximately 6 months expenditure including designated funds. At the year end the church held unrestricted funds of £50,335 of which £25,181 had been designated for the Fabric Fund. The remaining balance of £25,154 is held in the General Fund which, overall represents about seven months expenditure. They also have unrestricted investments of around £184,000.

The church also held £4,911 of restricted funds which have been provided for the purposes specified in Note 2.

**Statement of Trustees' Responsibilities**

The Trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The Trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2016. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

**Basis of independent examiner's statement**

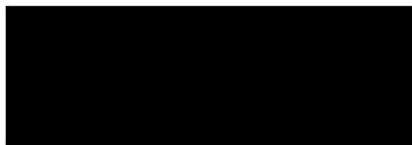
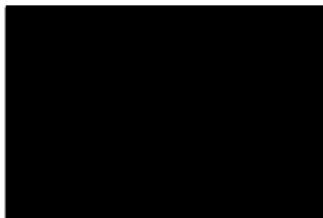

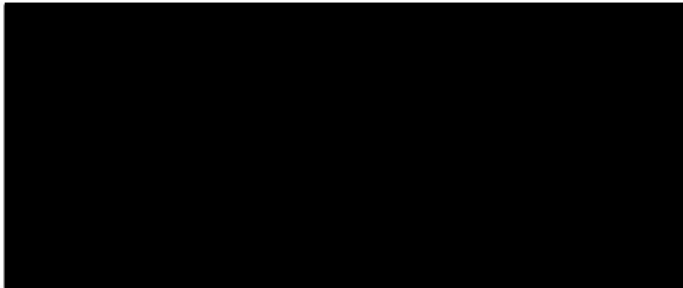

**6 Minister's Stipend**

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review, the minimum stipend was £31,642 and the maximum stipend (in the fifth and subsequent years) was £38,884.
