Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Unitary Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

Stranraer Parish Church was formed by a union of Trinity Church and the High Kirk in January 2020. The Kirk Session was chaired by our Minister, Rev. Andy Muir. The Kirk Session normally meet four times a year, however, we hold extra meetings as and when required. Certain responsibilities are delegated to the Finance and Property Team as appropriate. The Kirk Session is now responsible for spiritual and temporal affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Rev. Andy Muir leads worship on Sunday mornings at 11.00 a.m. The attendance at weekly worship continues to rise with up to 140 attending Sunday services. We celebrated the Sacrament of Holy Communion four times this year within the morning service. In 2025 we started an Evening service once a month. This is a Contemporary Worship Service and has been attended by 30 people made up of some from our church and some from other churches in the area and some visitors to the area. We hosted a Service for the Bereaved in December 2025. The Community Carol Service was in our church in December 2025 with Stranraer Brass providing the music and the South West Signers taking part in the service along with readers from local churches. During the Christmas period our Minister held a service in the church for a group from a local Day Centre for the Elderly and he conducted a service in a local Day Care Facility.

Rev. Andy Muir and members of the congregation attended the Memorial Service for the MV Princess Victoria. The Sunday Club continues to grow with up to 15 regular attenders. The Sunday Club is led by members of the congregation. In 2025 they held a Family Picnic. During the Easter season we held an Agape Supper on Maundy Thursday with Communion, Good Friday service with an Early Morning Easter Service held on the local waterfront. This was followed by breakfast in the church hall and was attended by members of the local community as well as church members. The Congregation collected Easter Eggs which were distributed to residents of the local Care Homes and housebound Members of our Congregation by the Pastoral Care Team. Bible Study groups and Prayer groups have continued during 2025. Alpha Courses have been held throughout the year and were very well attended and resulted in new members by profession of faith. We held a Remembrance Service in the church with Primary 6 & 7 pupils from all local primary schools in attendance and taking part in the service. We also held a Remembrance Service for local Veterans. Our Families and Children worker continues to assist with services for all local schools as well as leading the All-Age Talks in church and organised a Light Party in October. In the Summer we held a summer fete to raise funds for church projects and at Christmas we held a Christmas Wreath Workshop with the proceeds from this event and various Christmas Services being donated to four local charities. The Congregation collected items for the Blythswood Appeal and delivered approximately 60 boxes and bags of additional items to the collection point in November 2025. A Men's Breakfast meets once a month at a local golf club.

There were 37 funerals, 5 Baptisms were carried out in 2025. We have had 6 new members by profession of faith and 3 new members by Certificate of Transference.

The Minister and the Pastoral Care Team continue to provide Pastoral Care in the Parish. Members of the Pastoral Care Team have been visiting members in their homes and in the local care homes and hospital. The Pastoral Care Team also held services in the local Care Homes during the year. The Congregation donated Easter Eggs which were gifted to all residents of the two local Care Homes.

All church groups continue to meet with good attendances at all groups.

Church Groups: Senior Members, The Guild, Knit and Natter Group, Tuesday Tots.

Members of the Congregation and the Mission and Worship Team have taken some of the services during 2025 with Rev. Chris Fulcher assisting with Pulpit Supply. Three of our local schools, Belmont, Sheuchan and Park Schools have visited the church for their Harvest and Christmas Services and Rev. Andy Muir also carried out services for Rephad Primary School.

The church halls are used by the Blood Transfusion Service, a local Cheerleading Group, the Women's Institute and The Advisory Group (adults with additional needs) on a regular basis.

The Church has supported various collections for charity throughout 2025.

The Kirk Session support and encourage members to become involved in various community groups as part of our outreach to the local community.

We were privileged to host an evening with the Moderator of the General Assembly which was attended by members of local churches.

Achievements and Performance

As shown by the above statement, the Minister, Kirk Session and Church Groups work together with other local churches to fulfil our objectives in a wide range of activities. These include Stranraer Baptist Church, Stranraer Reformed Presbyterian Church, St. Joseph's Roman Catholic Church and St. John's Scottish Episcopal Church.

We offer assemblies and chaplaincy to Stranraer Academy along with the Baptist and RPC church, and we do various fundraisers with the remaining churches, sharing Armistice commemorations in the town. We also do a lot to help prevent food poverty amongst children and adults without work with the local foodbank, and we hold retiral collections for various charities throughout the year.

Financial Review

The principal source of income for our congregation is Gift Aid and FWO Giving. This is underpinned by contributions from the McDouall and Gillespie Bequests.

Reserves Policy

It is the Trustees' policy to hold adequate reserves and as such we have sufficient funds to support our reserves policy.

The church also held £510 of restricted funds which have been provided for the purposes specified in Note 2.

Year Ended 31 December 2025

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which on request, must reflect the financial position of the Church at that time. Independent Examiner's Report to the Trustees of Stranraer Parish Church

I report on the accounts of the charity for the year ended 31st December 2025 which are set out on pages 7 to 12.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. 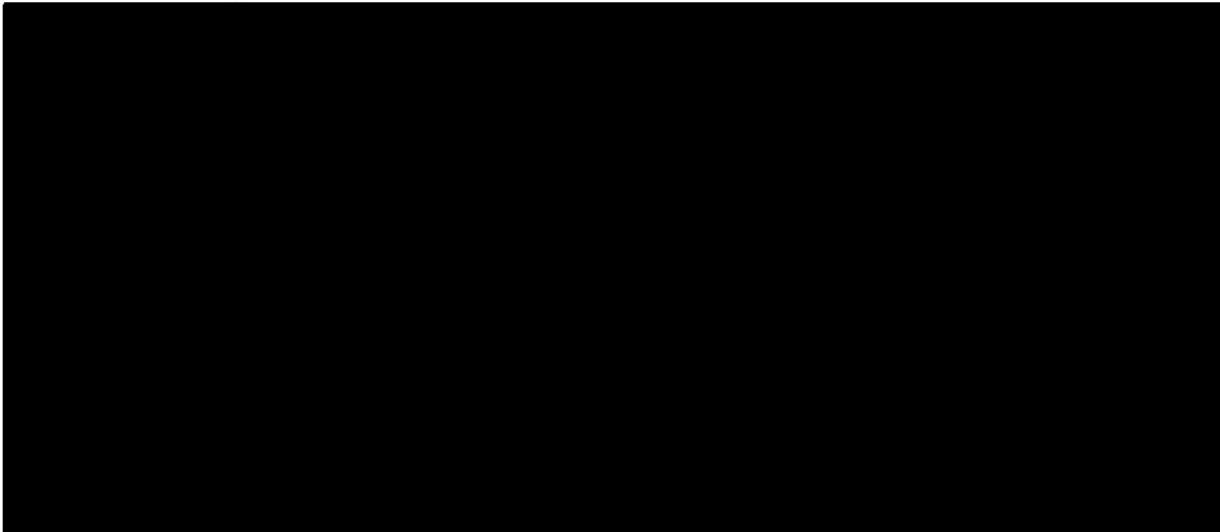

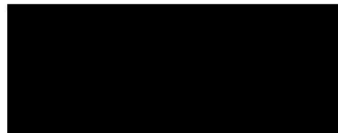

As shown by the above statement, the Minister, Kirk Session and Church Group work together with other local churches to fulfil our objectives in a wide range of activities. These include Stranraer Baptist Church, Stranraer Reformed Presbyterian Church, St. Joseph's Roman Catholic Church and St. John's Scottish Episcopal Church. We offer assemblies and chaplaincy to Stranraer Academy along with the Baptist and RPC church, and we do various fundraisers with the remaining churches, sharing Armistice commemorations in the town. We also do a lot to help prevent food poverty amongst children and adults without work with the local foodbank, and we hold retiral collections for various charities throughout the year.

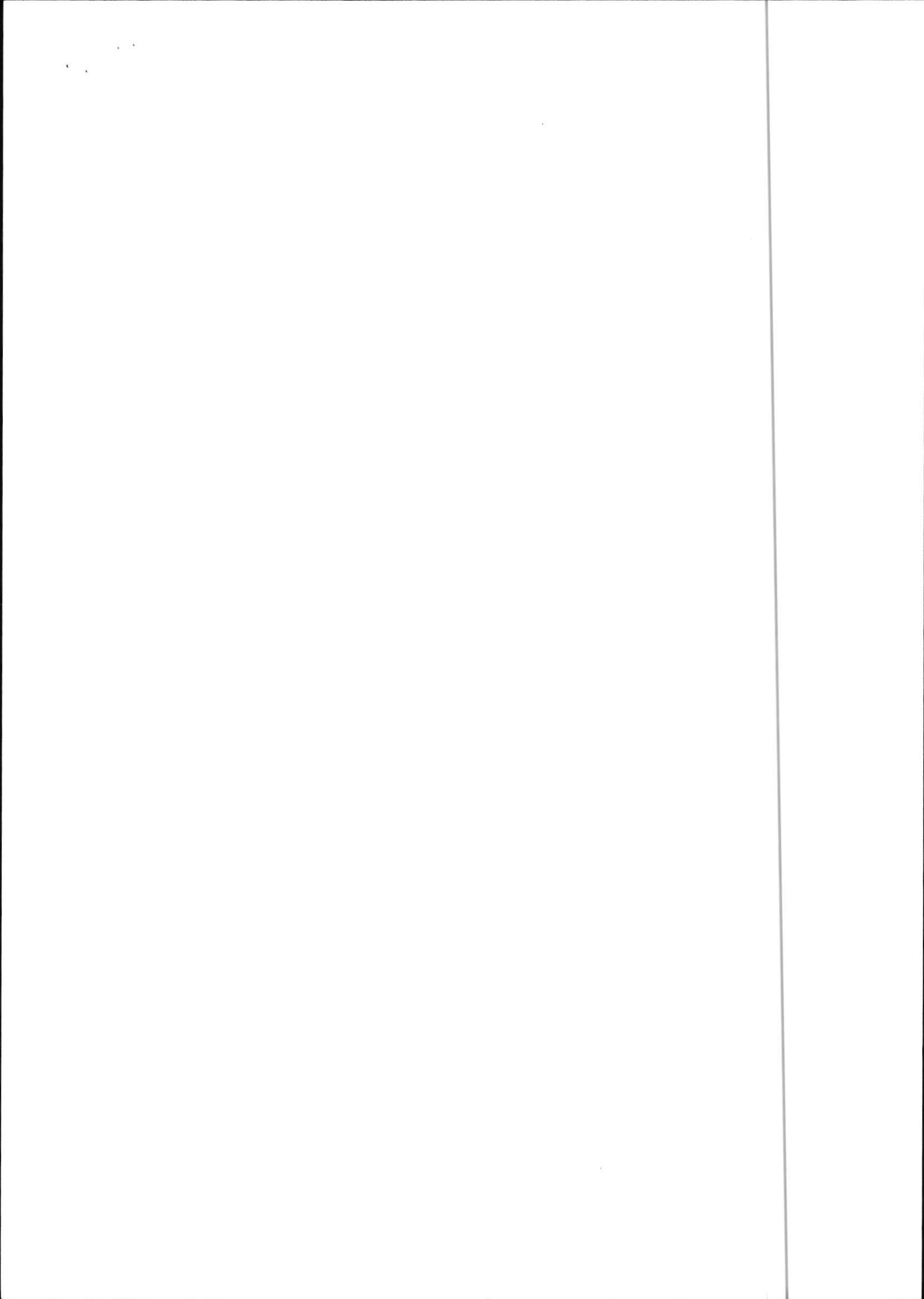
Financial Review

The principal source of income for our congregation is Gift Aid and FWO Giving. This is underpinned by contributions from the McDouall and Gillespie Bequests.

Reserves Policy

It is the Trustees' policy to hold reserves and as such we have sufficient funds to support our reserves policy.

The church also held £348 of restricted funds which have been provided for the purposes specified in Note 2.

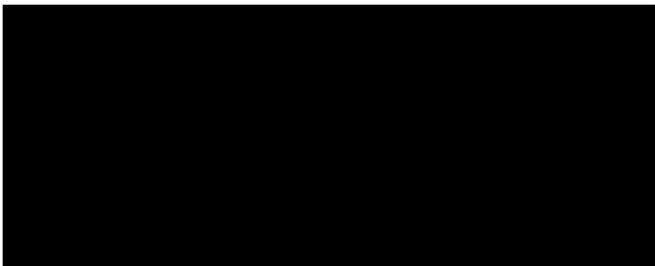

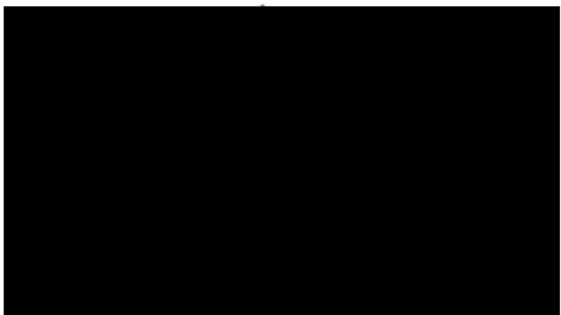
Basis of independent examiner's statement

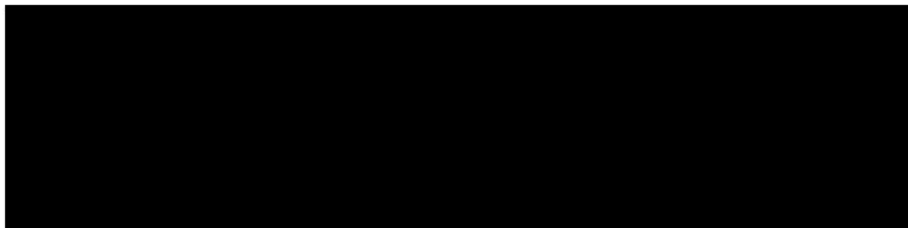
