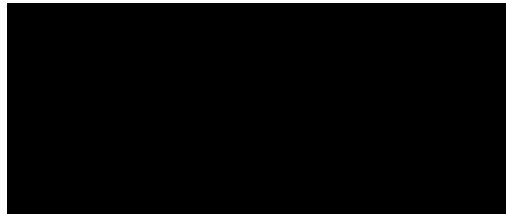

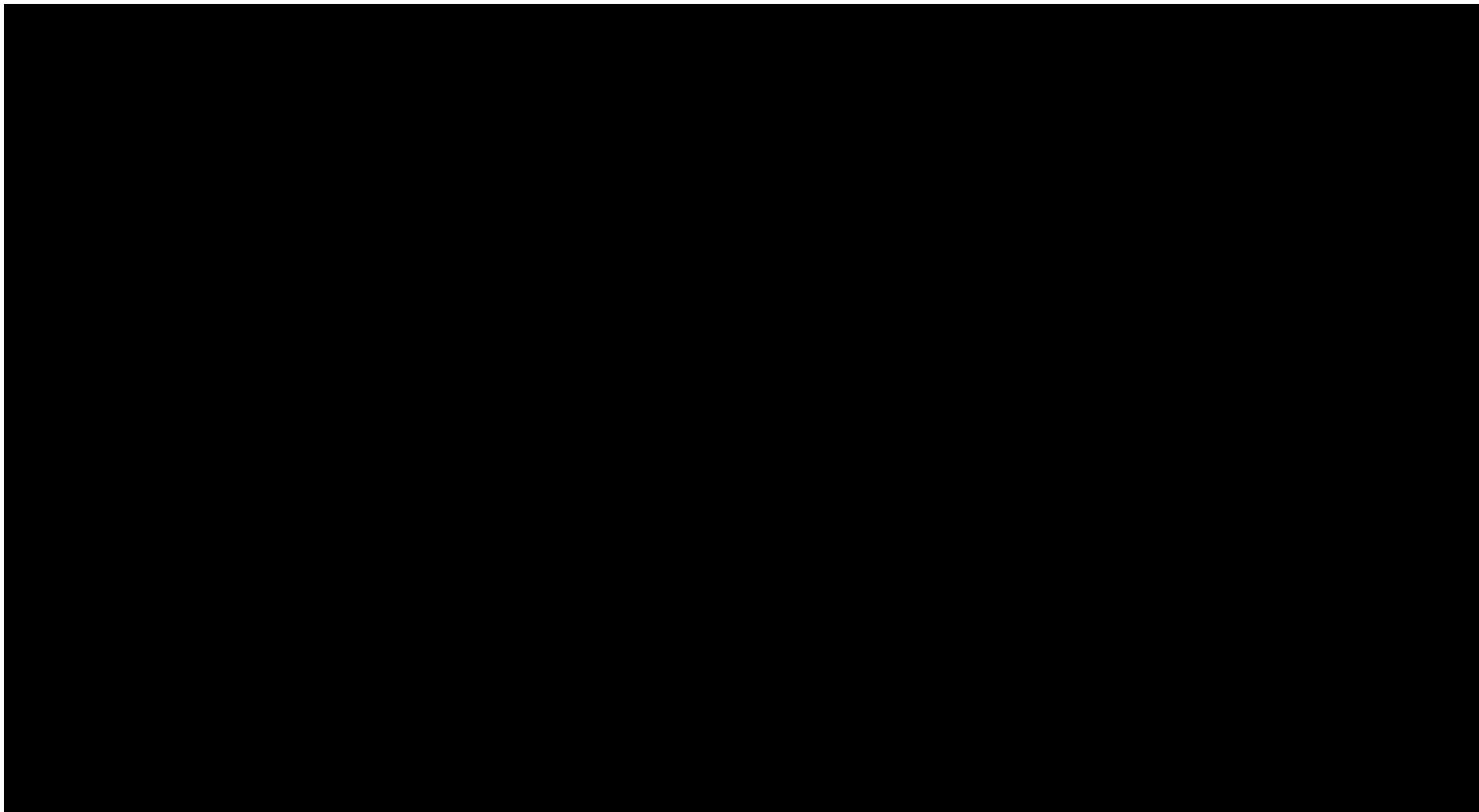

Trustees' Annual Report Year ended 31 December 2024

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. During periods when the charge is vacant, an Interim Moderator is appointed by Presbytery. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Board Members are then appointed at the Annual Stated Meeting and serve for a period of three years after which they must seek re-election at the next Annual Stated Meeting.

Organisational Structure

The Congregational Board is chaired by the Minister and meets six times in a year. Certain responsibilities are delegated to the Finance Committee and the Property Committee as appropriate. The Kirk Session which meets six times a year is responsible for spiritual affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Findochty Parish Church holds services of worship every Sunday morning. Organisations within the Church are Bible Study Group, Church Guild, Prayer Group and Saturday Morning Kids Club. The Church is linked with Portknockie Parish Church and members of our church regularly join with this church in various activities.

Achievements & Performance

2024 enabled us to continue to build on our work of bringing the word of God to those within our local community. The stability we had achieved the previous year under our Interim Moderator was built upon as our congregation continued to see new attenders at our weekly services and activities. We enjoy fellowship in our church hall following morning worship which is enjoyed by all. Four communion services were held during the year as well as a Sea Sunday service and a "Songs of Praise" evening featuring the choir attached to the church. The annual Easter Sunrise Service in March and the Service of Remembrance in November, both held at our local war memorial, was led by our Minister assisted by the leaders of the other churches in the area. The Sunrise Service was followed by breakfast in the church hall. Our Christmas Watchnight service was led by our Elders. We celebrated Easter, Harvest and Christmas with the congregation from our linked church, Portknockie. Other activities were held throughout the year included a fundraising Coffee Morning and 'New to You' sale and community Christmas lunch. Our Kids Club continues to thrive with between 12 and 20 children attending each month. The Guild, although small in numbers, meets monthly from September to March and have held a varied programme as well as hosting a praise evening with Moray Male Voice Choir.

Trustees' Annual Report (cont)

Year ended 31 December 2024

Financial Review

Total income for 2024 remained at a similar level to that of 2023 which the Trustees were delighted with in view of the current cost of living crisis. Our weekly non gift aided donations saw an increase of £1,105 due to a combination of change in the way some members gave and increased giving. The open plate donations reduced by £626, largely as a result of this. Gift aided donations reduced by £85. Tax recovered on gift aid increased by £31. Fundraising activities raised £2,875. Hall lets increased in 2024 which was reflected in an income increase of £380. Our largest expenditure items were our Giving to Grow contributions of £5,410, pulpit supply of £4,063 and heating, lighting and telephone costs of £5,530 an increase of £1,627. Having spent considerable monies on fabric repairs to our church in 2023, only £644 was spent in 2024. Staffing costs relate to the employment of our Organists. No Trustee was paid any remuneration or any expenses during the year.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure.

Statement of Trustees' Responsibilities

The members of the Kirk Session / Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session / Congregational Board are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Findochty Parish Church

Respective responsibilities of trustees and examiner

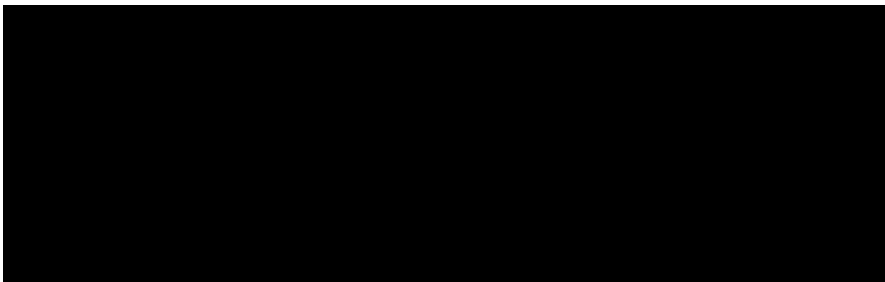
Basis of independent examiner's statement

An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.



