What the charity does: The Maxwell Memorial Hal was built in 1906 to promote active citizenship within the parish of Terregles and surrounding areas and to provide safe and secure facilities in the interest of social welfare for recreational, leisure, social and educational activities, and such other activities that may be deemed acceptable to the committee.

Beneficiaries: 'No specific group, or for the benefit of the community'

Objectives: For the payment of the expense of obtaining a site for the hall and grounds after mentioned on the Estate of Terregles and of erecting thereon and suitably furnishing a hall of a size and description suitable for the needs of the inhabitants of the Parish of Terregles for use as a hall for the holding of public meeting and entertainments, the housing if the Parish Library, and generally for the purpose of recreation, instruction and improvement. Should the said Trustees deem it expedient and practicable, having regard to the amount of funds available, to lay out the grounds attached to the hall as a bowling green, or in such other way as the Trustees shall think fit. To invest the sum remaining over after payment of the foregoing purposes, and to hold the same as a permanent endowment for meeting the annual upkeep and maintenance of the said Hall and furnishing and grounds, including the reasonable remuneration of a suitable caretaker, for assisting in the maintenance and improvement of the Parish Library.

Structure, Governance and Management

Constitution/Governing Document

Maxwell Memorial Hall, Terregles has been a registered charity since 1918. It is administered in accordance with the Deed of Trust, 1906, and the Management Committee Constitution which was updated in 2010.

Recruitment and Appointment of Trustees

Maxwell Memorial Hall was, in 1906, gifted in perpetuity for use as a parish hall by Mrs Lucy Lloyd as a memorial to her husband Captain Alfred Peter Constable Maxwell of Terregles. Trustees appointed in the deed of trust to hold the land or property on behalf of the trust. The Trustees are non beneficiaries of the Trust as individuals, but act in a fiduciary capacity only and are unpaid volunteers and have no personal financial interest in the Trust or the Trust Funds.

In accordance with the deed a Management Committee were appointed to manage the day to day running and maintenance of the hall on behalf of the Trustees. The Management Committee of Maxwell Memorial Hall has its own bank account to manage the running of the hall and the fundraising to achieve this. They are recruited and voted onto the Management Committee at the Annual General Meeting.

Objectives and Activities

To promote active citizenship within the parish of Terregles and surrounding areas and to provide safe and secure facilities in the interest of social welfare for recreational, leisure, social and educational activities, and such other activities that may be deemed acceptable to the committee.

To maintain and manage the hall for furtherance of the above activities.

The committee shall not be political, sectarian, or discriminatory in its practice.

The committee shall have power, with the trustees' approval, to affiliate to other organisations with similar objectives.

Activities

Terregles Community Council meetings, Terregles SWI meetings, Badminton games being used by local families, Family functions, Weddings, Dumfries & Nithsdale Pony Club Meetings & Events, Annual Terregles Flower Show, Dumfries & Galloway Burns Association, Craft Club, Private hires. Church Xmas Mince Pies & Coffee, Church Big Breakfast, Hall Committee Fundraising Events - Christmas Coffee Morning & Annual Burns Supper.

Financial Review

Our main source of income is from the fundraising events, planned and provided by the Management Committee, along with the hall rentals to various groups and private rentals.

Reserves Policy

Funds are held in trust by the Trustees. The Management Committee's remit includes raising funds for the day to day management requirements of the hall. Any large development/maintenance needs are subject to specific fundraising and grant applications.

Plans for Future Period

The Management Committee and Trustees have managed to acquire grant funding over recent years to upgrade the hall to a good standard. For the immediate future, fundraising and events are planned in line with covering the running costs of the hall, increasing community involvement and ensuring adequate funding for any future maintenance issues for the hall.

As Chair, I thank the Trustees/Management Committee for their hard work and commitment over the last year.

**Independent Examiner's Report to the Trustees of Maxwell Memorial Hall, Terregles

I report on the accounts of the charity for the year ended 28 February 2026 which are set out on the attached 2 pages.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement
