Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Model Deed of Constitution.

Recruitment and appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

The Congregational Board is appointed from within the congregation. Members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management of the affairs of the church, to become members of the Board. Members are then appointed at the Stated Annual Meeting and serve for a period of three years after which they may seek re-election.

Organisational Structure

The Congregational Board is chaired by the Minister and meets six times per year. Certain responsibilities are delegated to the Church Treasurer and Fabric Convenor.

The Kirk Session which meets six times per year is responsible for spiritual affairs within the church.

Additional meetings of both Board and Session are convened as necessary.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other churches in various ecumenical bodies in Scotland and beyond.

Details of some local activities

Services of Worship Sunday services, which are open to all, are held at 11 a.m. and all services are also broadcast via Zoom. Additional services are held to celebrate events such as Christmas and Easter.

Sunday School The Sunday School meets every Sunday for the Christian training of young children from all sections of our community.

Bible Study Group The Bible Study and Prayer group meet weekly this is also broadcast via Zoom and is open to all members of our community for group study of the Bible and both individual and group prayer.

The Guild The Guild meets once per month from Autumn to Spring and caters for ladies of all ages from within our community. Meetings are instructional and entertaining including bible readings and prayers. The Guild offers practical and financial support to both national and international needy causes.

Prayer Meeting Every Saturday morning for one hour there is a Prayer Meeting this is open to all members of the community.

Warm Hub Each Friday from October to May we provide a hot meal at lunchtime and anyone who wishes may come and receive a hot meal and fellowship.

Achievements and Performances

Attendances at services of worship throughout the year both via Zoom and in Church have been falling, as our membership consists largely of senior members although we do have a staunch group of younger members. Any church activity is well supported both by our members and from the wider community. Fund raising has been minimal.

Financial Review

Income in 2025 showed a decrease of 10.4% from 2024 and direct giving through the Free Will offerings, Plate and Gift Aid decreased by 12.7% Fund Raising this year has been minimal and only for third parties.

Expenditure in 2025 showed a decrease of 6.7% on the 2024 figure.

The church had an operating deficit for the year.

Reserves Policy

It is the Trustees policy to hold reserves of some six to nine months expenditure including designated funds. At the year end the Church held unrestricted funds of £147,441 of which £70,201 has been assigned for fabric purposes and eventual replacement of our organ. It is felt that this is a reasonable amount as presently we are only allowed to maintain the building to a wind and watertight standard, and as we are facing a union this would be sufficient but if not an appeal or special fund raising would be made.

Restricted funds of £4,427 were also held as described in the Statement of Funds.

Statement of Trustees' Responsibilities

The members of the Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the church during the financial year. The members of the Board are responsible for ensuring that proper accounting records are held which, on request, must reflect the financial position of the church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustees Investment (Scotland) Act 2005, The Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and / or the detection of fraud and other irregularities.

The day-to-day duties of all record keeping, and preparation of financial statements are normally delegated to the church treasurer who will submit reports and statements to the Board at their bi-monthly meetings.

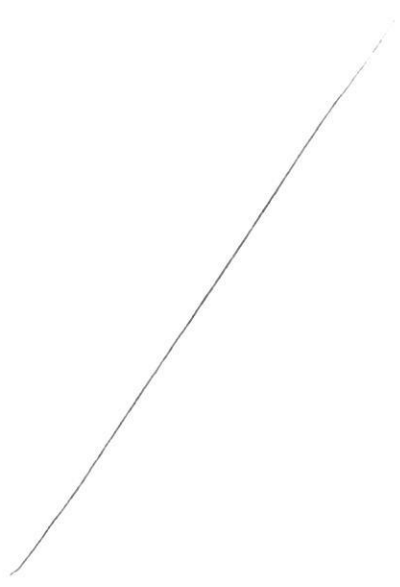

We have £33,167 in the Consolidated Fabric Fund – Revenue Account also the Manse was sold in June 2019 for the sum of £223,182 these are held centrally by the Church of Scotland in Edinburgh. We have no property apart from the Church and Hall (one building) which belongs to the Church of Scotland the title deeds are held centrally in Edinburgh.

All Expenditure from the Fabric Fund was for wind and watertight repairs only.

This year there is a Deficit in our Church Income, and it is predicted that next year there will again be a Deficit, considering the situation giving will probably not increase but if needed some fund raising may be undertaken.
