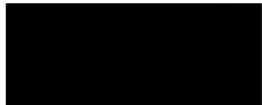

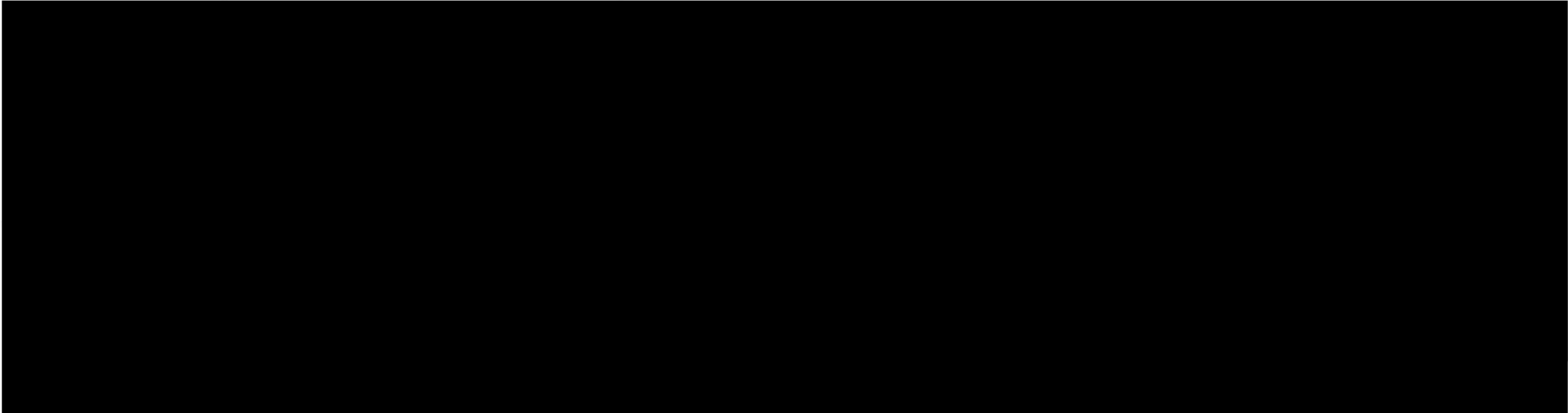
**KIRK SESSION**

**Structure, Governance and Management**

**Governing Document**

The Church is administered in accordance with the terms of the Deed of Constitution (or Deed of Constitution (Unitary Form)). The Unitary Constitution was issued by the Delegation of the General Assembly on the 24<sup>th</sup> August 2023 and the Congregational Board held its last meeting on the 3<sup>rd</sup> October 2023.

**Recruitment and Appointment of Trustees**

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Interim Moderator who is appointed by Presbytery is the Moderator of the Kirk Session.

**Organisational Structure**

The Kirk Session which meets at least 5 times a year and when required at other times throughout the year and is responsible for spiritual affairs within the church and also all financial and property related matters.

**Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement on Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

**Reserve Policy**

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held cash funds of **£2,380**.

**Statement of Trustees' Responsibilities**

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

**Report of the Independent Examiner**

**Respective responsibilities of trustees and examiner.**

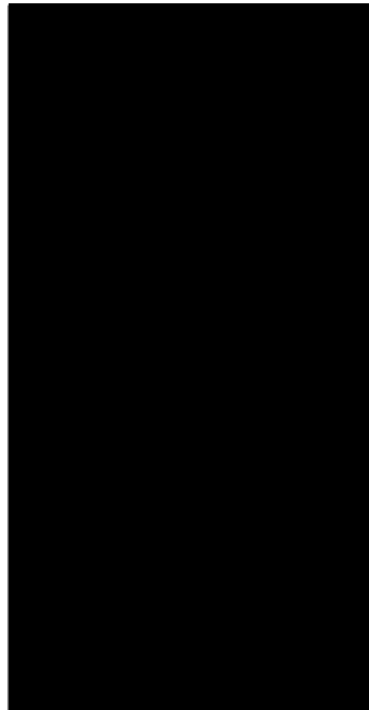

### Worship

The main service of worship is at 11am every Sunday morning. Special services are held at Christmas such as an All-Age Christingle service on Christmas Eve, Easter and Holy Week (Thursday and Friday evenings in collaboration with another Church of Scotland congregation in Kilmaurs). As we are part of the Fellowship of Kilmarnock Churches, we invite our members to attend the ecumenical monthly services and occasionally host one of these when asked. Crosshouse Primary School and Communications Centre come to the church at Harvest, Christmas, Easter and Summer pre-holiday services. An active choir practices every week under the direction of our organist, and contributes in leading worship every Sunday and special choir items from time to time.

### Youth

Young people are catered for within Crosshouse Parish Church (Church of Scotland) On a nominated Sunday each month from August to June, the Young Church invites children of pre- and primary-school age to meet first in the Hall and gather with the worshipping church for the first part of the morning service, continuing in our Hall with appropriate adult leadership. We are always seeking to find new ways to engage with the children and youth of the community through their families.

### Safeguarding

Our Safeguarding Panel, consisting of the coordinator and two others, act of behalf of the Kirk Session to keep us up to date with Safeguarding requirements and ensure that every one has the relevant training for the roles that they are involved in.

### Devotional Activities

There is a telephone prayer chain involving several members of the congregation who will regularly pray for those who are in need of prayer. There are occasional home groups or bible studies that take place where a small group of people will gather for fellowship and for bible study.

### Wider Church Involvement

We are a member church of the Fellowship of Kilmarnock Churches which brings the local denominations together through shared worship and ecumenical events. We have also recently appointed a Partner Plan Correspondent who keeps the Kirk Session and Congregation up to date with our Mission Partner who is based in Rome. We are also involved annually in the Blythwood Shoe Box appeal.

### Community Engagement

We work closely with local community through involvement with the Community Council, Crosshouse Action Now and the School Parent Council. Last year the Poppy Project was born which led to a group called Needles and Natter which is attended by church members and non-church members and brought together various groups to make a tremendous poppy display for remembrance Sunday.

**Stewardship**

Stewardship is managed by the Kirk Session. A planned Giving Campaign was normally carried out throughout our membership every four years, but the Covid19 pandemic prevented this in 2020/21. Since the Pandemic we adopted a new process of looking at Stewardship in other contexts and engaged with the National Stewardship Team of the Church of Scotland and will continue to look at ways we can take ideas initiatives forward. We also seek and act on ways of promoting the Church to the Community. These include: visitations and leaflet drops to new housing estates; church website; engaging with the community through social media, e.g. Facebook.

**Ways Forward Group**

The Ways Forward Group consists of members of the Kirk Session who co-ordinate and organise events for social occasions for the congregation and also fundraising activities to raise funds for the church. Last year fundraising events included a fashion show and a Snowman Drive.

**Guild**

We have 10 regular members who meet every alternate Wednesday at 7.30pm in the church hall. The current projects support by the Guild 2021-2024 are There is Hope (*BEAT*), Chocolate Heaven: South East Asia, (*Pioneers*), *Finding the light in every child*, *Uganda* (Starchild), *Kazania Village of Hope (The Trust)*, A home for good: Scotland *Home for Good*, Hear our Voice' Brazil (*Trindal*). Our syllabus various from bible study, interesting speakers to fun nights, demonstrations and musical evenings.

The Guild aim is to encourage men and women to commit their lives to Jesus Christ and to enable them to express their faith in worship prayer and action. New members are always welcome

**Woman's Group**

Currently about six to eight in number, meet on the Wednesdays between Guild meetings to socialise and assist with various activities going on in the congregational life, e.g. providing hospitality, food and drinks etc
