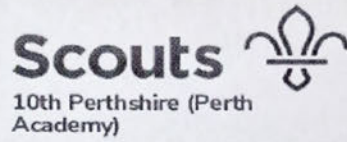

Constitution and Purpose

The Scout Group is constituted in terms of the Rules of The Scout Association, which is a charitable body incorporated by Royal Charter. The Group is a registered Scottish Charity - No. SC011697

The purpose of The Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

Trustees are recruited and appointed in accordance with the Policy, Organisation and Rules ('POR') of the Scout Association.

The Group comprises Squirrel, Beaver, Cub and Scout sections and is also partnered with West Perth Explorers who share the building and are supported by our Trustees.

The aim of the Group is to promote the purpose of Scouting which is to actively engage and support young people in their personal development and empowering them to make a positive contribution to society. The Group is organised in line with the Values of Scouting, and as Scouts we are guided by these values:

- Integrity - We act with integrity; we are honest, trustworthy and loyal.
- Respect - We have self-respect and respect for others.
- Care - We support others and take care of the world in which we live.
- Belief - We explore our faiths, beliefs and attitudes.
- Co-operation - We make a positive difference; co-operate with others, make friends.

We are proud to own our own headquarters, which each week serves nearly 250 youth members aged 4 to 18. Our team of 45 volunteer adults provide a full and varied Scouting program, including camps and trips, all helping the members to build skills for life, develop friendships and contribute positively to our community. We owe a huge debt of thanks to all the volunteer leaders who give up so much time and enthusiasm to support our sections.

When not used by our sections, our headquarters is utilised by a wide range of local community groups of all ages and is a valuable local amenity. We are constantly reviewing the building to improve and maintain our excellent facility.

We are fortunate to have a team of keen and supportive Trustees and other adult supporters who ensure there is excellent back up for the uniformed volunteers and that our Group assets are well managed and maintained.

Reserves Policy

Given the ongoing running costs of the Scout Hall, the trustees believe that around £15,000 is an appropriate level of group reserves at this time.

Independent Examiner's Report to the Trustees of the 10th Perthshire (Perth Academy) Scout Group
I report on the accounts of the 10th Perthshire (Perth Academy) Scout Group ('The Group') for the year ended 31st March 2024 which are set out on pages 4 to 6.

Respective responsibilities of the Trustees and Examiner

The Group's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ('the Act') and the Charities Accounts (Scotland) Regulations 2006 (as amended) (the 'Regulations'). The Group's Trustees consider that the audit requirement of Regulation 10 (1)(d) of the Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Regulations. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent Examiner's Statement

Other Assets

1. The Group built a Scout Hall in the grounds of Perth Academy in 2008/09 at a cost of £304,394, including furnishings. In 2009/10 a further £22,238 was spent, in 2014/15 an additional £124,176 was spent on an extension, and in 2015/16 a final £6,536 was spent, bringing the total cost of the hall to £457,344. The ground on which the hall is built is leased from Perth & Kinross Council under a 50 year lease that commenced on 1 July 2008 with a rent review every five years thereafter.
2. The Group owns the usual tents, camping equipment and items that are required to run the programme for all sections.

Liabilities

The Group has no liabilities outstanding at the year end other than the timing of the receipt of summer camp deposits.

1 Funds

The Group maintains a single undesignated general fund for all its financial transactions. Each Section also holds its own bank account and figures are consolidated at year end.

The Group maintains an Activity Support Fund. Confidential grants are made from the fund to allow any member of the Group to join in any Scouting activity that they might otherwise miss.

The group raised a fund to extend the scout hall and the work was completed in the previous year. The final retention monies were paid in the year and the fund has been closed.
