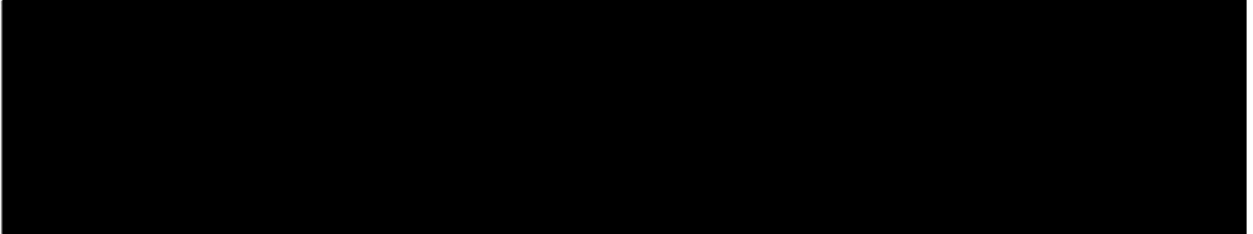

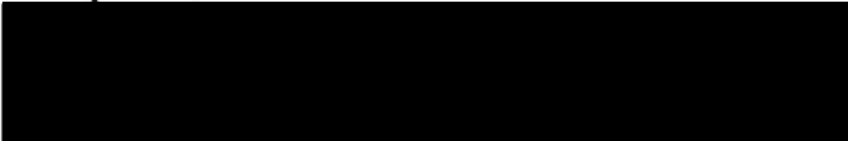

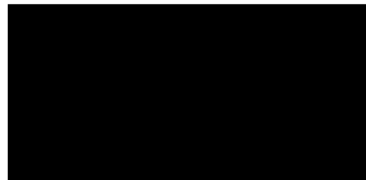

Structure, Governance and Management

Governing Document

The Church is administered in accordance with a Unitary Constitution adopted with the approval of the Church of Scotland and The Presbytery of Greenock and Paisley. The administration of the Church is undertaken by the Kirk Session.

Trustees

The Members of the Kirk Session are the charity trustees. The Kirk Session Members are the Elders of the Church who are considered to have the appropriate gifts and skills.

Tom McConnell and Barbara Jackson were readmitted as Elders and Trustees in September 2024. All other trustees held Office throughout the year.

Organisational Structure

The Kirk Session is chaired by the Minister and meets at least six times a year. The Kirk Session has various Committees and Support Groups which report back to the Kirk Session on various matters within their remits. The Members of these Committees and Groups are formed from Members of the Kirk Session along with Members of the Congregation. The Committee structure comprises, worship, pastoral, outreach, communications, property, finance, stewardship and safeguarding.

Objectives and Activities

The Church of Scotland is a Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond. Services of Worship are held on a Sunday morning on Wednesday mornings on a regular basis and on other special days throughout the year. Communion Services are held in March, June & October. On Sunday mornings children attend the Young Church Group. A Scout Group is affiliated to the Church. For adults there are the Guild, Monday Café, Craft Groups, Badminton Club and Men's Club. A Book Bug Group for young children also takes place regularly. A Café (the Meeting Place) is run on a Wednesday and The Gathering and Tue'ing the Fat Groups also meet regularly. There is a Tea Bar after the Service on Sunday mornings which give opportunities for a get together on a regular basis. The Church also holds services for and has links with the local Primary School and Little Inch Care Home located in Inchinnan. The Kirk Session has undertaken a Five Year Review to plan for the future.

Achievements and Performance

Successful fundraising events were held throughout the year and also a number of social events including theatre trips. During School holidays fun events were held for children to enjoy.

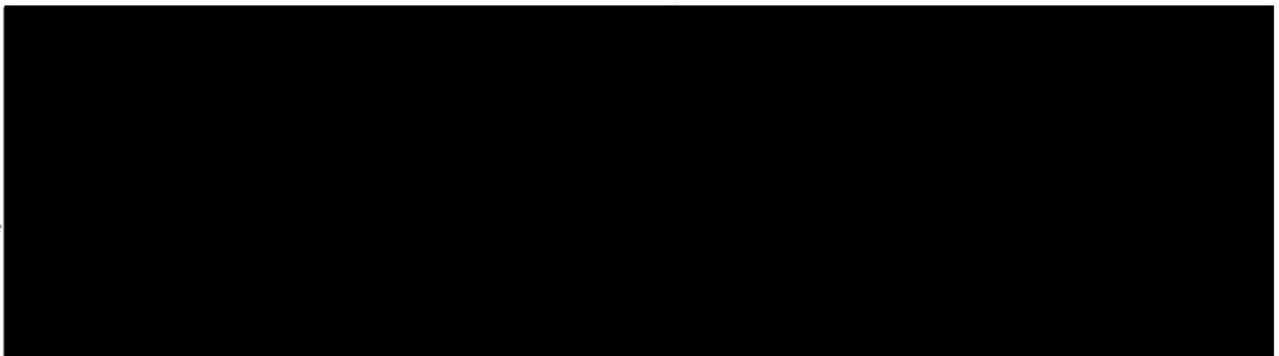
Financial Review

Total income of over £77,000 including fund raising and contributions from Church organisations of over £17,000 and over £8,500 for the use of the premises by outside organisations. In addition to this a claim for £7,000 has still to be processed and paid by HMRC for the Gift Aid claims for April 2024. Our expenditure of over £77,000 included over £15,000 on repairs and maintenance of the Church and Hall buildings. We paid all our allocations of over £36,842 to the Church of Scotland in full. Donations to various Charities during 2024 amounted to over £3,624. At the end of the year our reserve was over £48,000 and this can be used for ongoing repairs and maintenance and maintaining our commitments for the coming year. Investigations are still ongoing in conjunction with the Church of Scotland for repairs to the Chancel window and the drainage system.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records, which on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Agent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Inchinnan Parish Church

Respective responsibilities of trustees and examiner

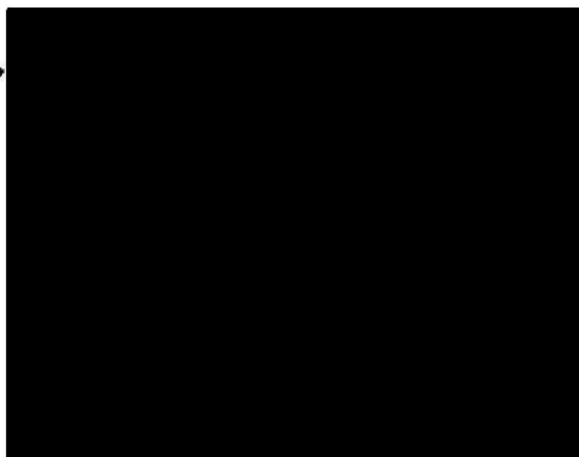
Basis of independent examiner's statement

An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

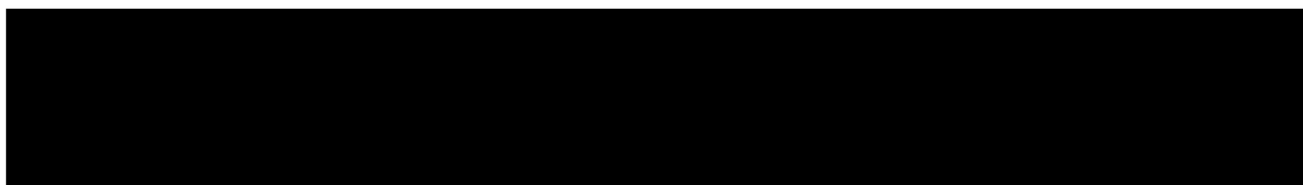

If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This discretion has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Fabric Fund: The Trustees have set aside funds for the maintenance of the Church property.

Flower Fund: This is a fund to provide flowers for display during services of worship.

Purposes of Endowment Funds

Income from Jane Stewart Bequest is transferred to the Fabric Fund

Income from Jessie A Smith Bequest is for the use of the Sunday School.

5. Ministers' stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the cost of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £31,642 and the maximum stipend in the ninth and subsequent years of service was £38,884.
