Regular users are local sports, youth and church groups, the local school and the field studies group and the Burra Playgroup. There are now an increased number of groups and individuals from the wider Shetland community hiring the bus.

Financial review

Brief statement of the charity's policy on reserves

The trustees have examined the charity's requirements for reserves in light of the main risks to the organisation. They have established a policy whereby the unrestricted funds held by the charity should be between one to three months of expenditure. However, the trustees recognise this sum may only be achieved by building on reserves through operating surpluses that may be subject to funder grant condition restraints.

There is a small deficit this year owing to essential maintenance work required on the bus.
