(b) the provision of recreational facilities, and/or the organisation of recreational activities, which are primarily intended for persons who have need of them by reason of age, ill-health, disability, financial hardship or other disadvantage, but which are available to members of the public at large. (c) the promotion of health and wellbeing and the relief of suffering. (d) the promotion of education, the arts, heritage, culture or science.
