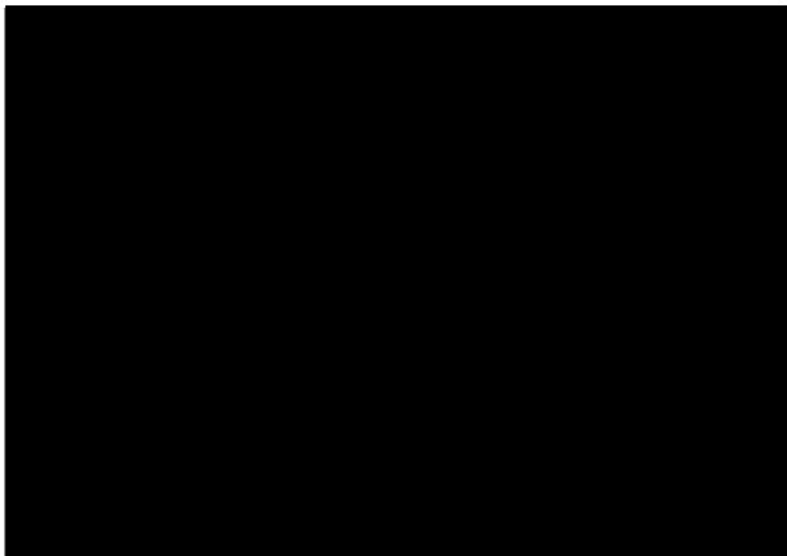
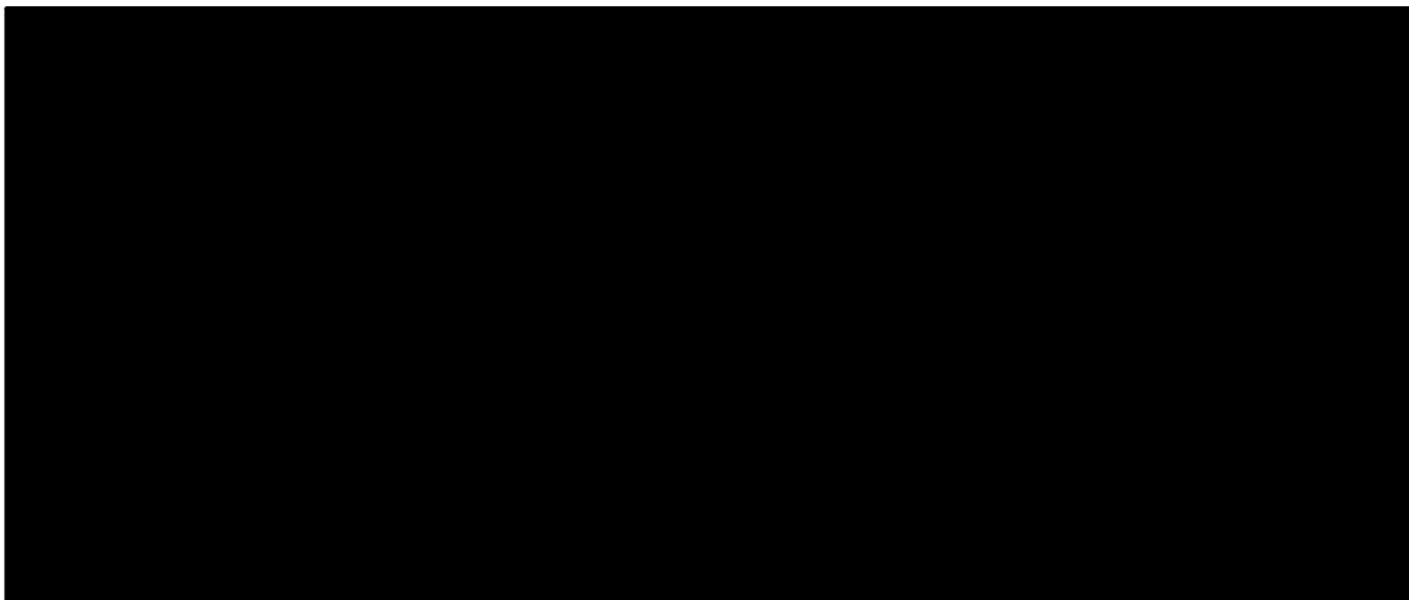

Structure, Governance and Management

Governing Document

Wishaw, Cambusnethan North Parish Church of Scotland is administered in accordance with the terms of the Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. Under the Unitary Constitution the Finance and Property Committees make recommendations to the Kirk Session and report back on actions that have been carried out on the recommendations.

Organisational Structure

Our Church adopted Unitary Constitution in January 2020 and certain responsibilities are delegated to the Finance Committee and the Property committee as appropriate. These committees make recommendations The Kirk Session, which meets seven times a year which is moderated by the Interim Moderator and is responsible for spiritual affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish in Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

We have one service of worship each week at 11.00am on Sundays. We also have the facility to Live Stream the service which was advantageous during lockdown. We have active Youth Organisations and can boast a Boys' Brigade Company (5-18yrs); Brownie Pack (7-10yrs); Rainbow Group (5-7yrs); and The Children's Church (4-11) during Sunday Service. Children's Church began in August 2021 and we look forward to this venture being an ongoing success in 2024.

We also have an active Social Group who organise various social events including our Cafe Church, themed afternoon teas and fund raising. Our Outreach Group have organised events for our Christian Festivals and a Christmas Concert which involves our Choir and Newmains Band with the community and members from our neighbouring church coming along to enjoy a musical evening. For adults there is our Ladies Group; Friendship Club (for the over sixties) and a Walking Group which involves our neighbouring church and members of the community. We also hold a Café Church on Wednesday afternoons where members of the community can come along and join with members of our church in fellowship. Our Prayer Group is called the Missing Link and offers prayers for people in our community as well as church members who are in need of support by prayer. This year we received a Grant of £2000 funding which enabled us to fund events to celebrate our 175th Anniversary. We also received an anonymous donation of £16,360 which was specified for missional work which has allowed us to expand our outreach into the community.

We are a very active congregation with a Choir who provide concerts at other churches and care establishments as well as leading public worship.

We are active in the Ecumenical Group – Wishaw Churches Together and are members of Forth Valley and Clydesdale Presbytery's Local Area Mission Committee (both groups promote social and worship activities of which we are a part).

Along with our neighbouring congregation a community venture called MADE4U IN ML2 is now well established and successful – this has been formed into a Limited Company, has full time employees and offers activities, care, counselling and support to young people and families.

Financial Review

The principal source of income is through the weekly giving of members by Weekly Free Will Offering Scheme (by envelope – 55; by standing order – 49) and Open Plate (varies). There are 98 members using The Gift Aid Scheme. There has been a decrease in offerings this year of £3,392 due to a decrease due to liberality. Fund raising initiatives have now resumed and we have seen many of our usual events taking place once again.

We have still, as a congregation, financial concerns regarding the large increase in running costs generally; we have however completed the installation of vision monitors around the sanctuary and these are used to enhance worship. Our Sound System was upgraded to enable us to Livestream our Sunday services. Other fabric work of a maintenance and repair nature have also been completed and all major works are now complete and recorded in previous reports. Over the year we transferred £10,000 from James Graham Legacy to augment our General Fund to ensure we are able to meet our monthly commitments and £12,000 from our Fabric Account to Fabric Account held for repairs (both held in 121 George Street). The receipts of £38,798.00 is made up of other receipts noted in the statement of balances and not shown under the £65,049. The Fabric Account Balance shown as £38,111 is made up £2,409 held in our Fabric Current Account and £35,702 held in our Fabric Account held in the Investors Trust 121 George Street.

During the year donations were made to 500 Miles £421, Paul's Parcels £421, Erskine Hospital £150. Combat Stress £150, CHSS £309, Lanarkshire Cancer Care £300, Living Well Foodbank £100 and others. See (Note 6 page 10)

Reserves Policy

It is the Trustees' policy to hold reserves and these are principally associated with the Fabric and General Account, the Fabric Fund and Reserve Account. At the year end the church held unrestricted funds of £165,173 of which £38,111 is for Fabric £2,409 of which is held in our Fabric Current Account and the balance of £35,702 held at 121 George Street and £3,781 for use of Church groups. The remaining balance of £123,281 set aside for concerns mentioned above. It could be considered that these reserves are higher than normally expected, however the Trustees are aware of the age of our premises and see it as prudent to hold monies for future renewals and repairs.

Giving 2 Grow Contributions

These have been paid in full and are paid in ten equal payments by standing order.

National Stewardship Campaign

As a congregation we have completed Stewardship of Time, Talents and Money however we continue to promote the Stewardship of Time and Talents on an ongoing basis and it is planned to have a Congregational Financial recommitment in 2025 if circumstances allow.

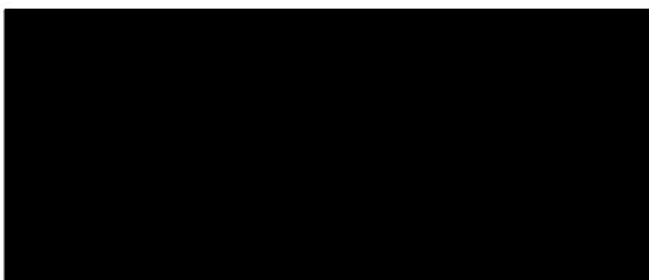
Statement of Trustees' Responsibilities

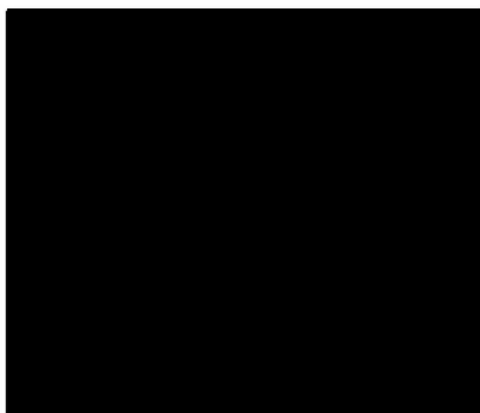
Basis of independent examiner's statement

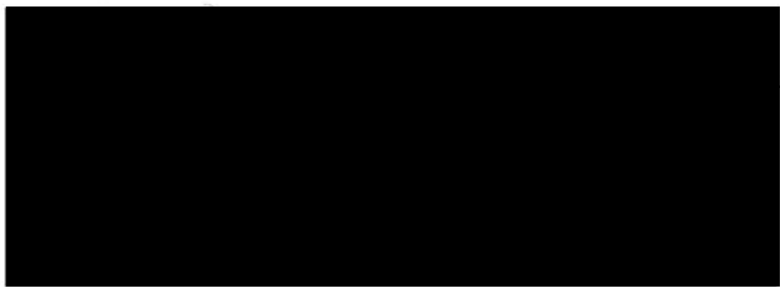

Purposes of Restricted Funds

Flower Fund : This is a fund to provide flowers for display during services of worship and to members of the congregation

Missional Fund Donation to reach ou to the community

Presbytery Grant for 175th Anniversary

Purpose of Unrestricted Funds

General Fund: to cover general running costs of Wishaw Cambusnethan North Parish Church of Scotland.

Reserve Fund: funds set aside to offset any shortfall in general fund expenses and to cover expenses incurred with unexpected renewals and repairs

Purposes of Designated Funds

Fabric Fund: Funds for the maintenance of the church property.

James Graham Legacy: For fabric and general congregational purposes.

Choir Fund: Funds to purchase music resources for use in worship and to cover choir expenses.

Friendship Fund: To cover expenses of over 60's club incurred with meetings, speakers, outings etc.

Ladies' Group Fund: To cover general expenses of Ladies' group; savings for outings and nominated charity.

Children's Church:- To purchase materials and cover general running costs for children
The children also collect 5ps from congregation for minor church projects.
