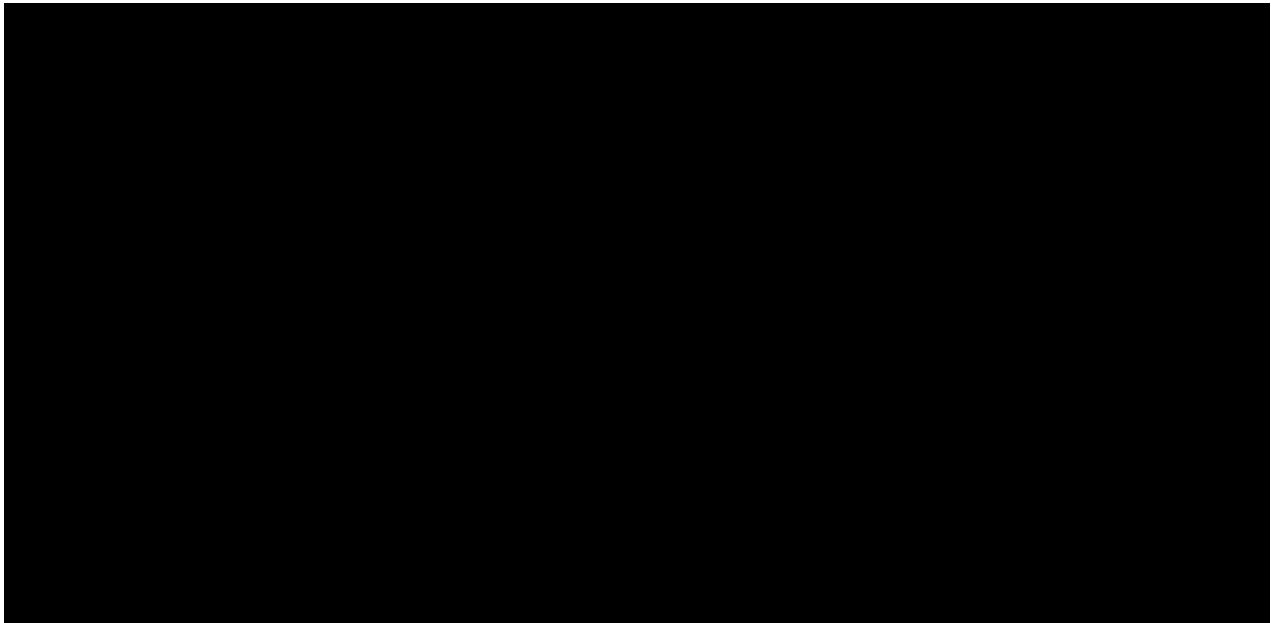

Financing


Reserves Policy

Independent Examiner's Report on the Accounts

As independent examiner I report to the trustees of Bathgate Community Centre Association, registered charity no SC013090, on the accounts of the charity for the period 1st April 2024 to 31st March 2025, as set out on pages 6 & 7.

Respective Responsibilities of Directors and Auditors

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiners Statement
