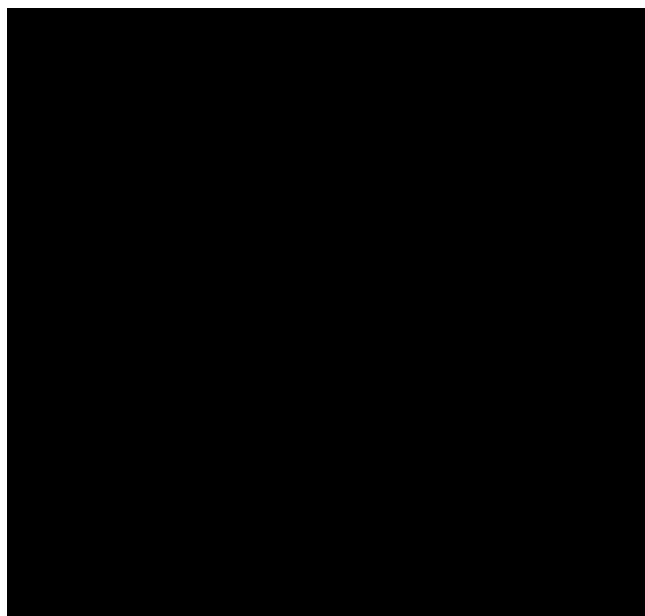

Structure, Governance and Management

The West Renfrewshire Young Farmers Club is an unincorporated registered charity, registration number SC013102. As governed by its constitution, the objectives of the Club shall be:

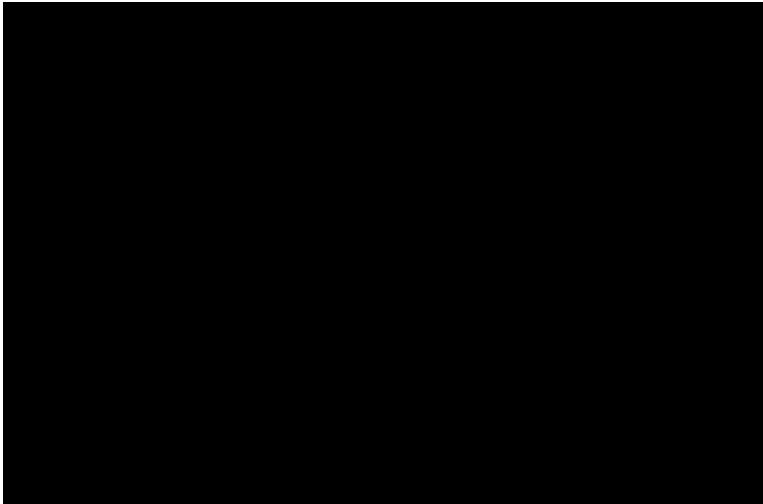
- a) To further the cultural education and training of young people: to promote their knowledge of country life; to create a fuller realisation of the duties and responsibilities of citizenship and to produce a greater interest and efficiency in agriculture in all its branches;
- b) To make rural life more attractive to the young members of the community by providing social amenities and a means of healthy recreation;
- c) To co-operate with the colleges of agriculture, education authorities and any other bodies engaged in agricultural and rural education; and
- d) To take in co-operation with the Scottish Association of Young Farmers Club any other action calculated to further the aims of the Young Farmers' Clubs movement.

The Club is administered by a management committee, who are elected at the Annual General Meeting of the Club.

The Club is affiliated to the Scottish Association of Young Farmers' Clubs, to whom the affiliation fees are payable. We then went on to do many more meetings including, stockjudging, bowling (ten pin and carpet), laser tag, our yearly night at the panto and of course our annual variety concert.

A number of our members successfully took part in many district, regional and national competitions this year of which the club are extremely proud of all titles and placings gained. Well done to [REDACTED] who successfully got selected for the Clyde and Central teams for Stockjudging at the Highland Show. A special mention must go to [REDACTED] who was part of the junior team who placed 1st.

Future Developments

The Club will continue to organise meetings and activities which meet the objectives of the Club. These will be decided by the new committee in due course.

Next year's Summer Syllabus will remain similar apart from obvious changes i.e. hosts, venues etc.

The next Winter Syllabus is open for club members to suggest new ideas for meetings that they would like to see being held. The obvious theme meetings such as stockjudging, Panel Night and the Root, Seed and Produce Show will remain, but the majority will change to meet the needs and wishes of the club.

The club will continue to support and encourage members to participate in competitions and activities at national level.

Financial Review

The financial position of the club is secure. Whilst a deficit was reported this year, this was entirely as a result of making a large charitable donation to our local hospice.

Reserves Policy

There is no set reserves policy but club's reserves position is regularly reviewed to ensure the sustainability of the Club.

Independent Examiner's Report to the Trustees of West Renfrewshire Young Farmers Club

I report on the accounts of the charity for the year ended 28 February 2025 which are set out on pages 6 to 11.

Respective responsibilities of trustees and examiner

Basis of independent examiner's statement

An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

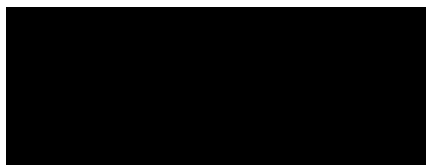
Independent examiner's statement

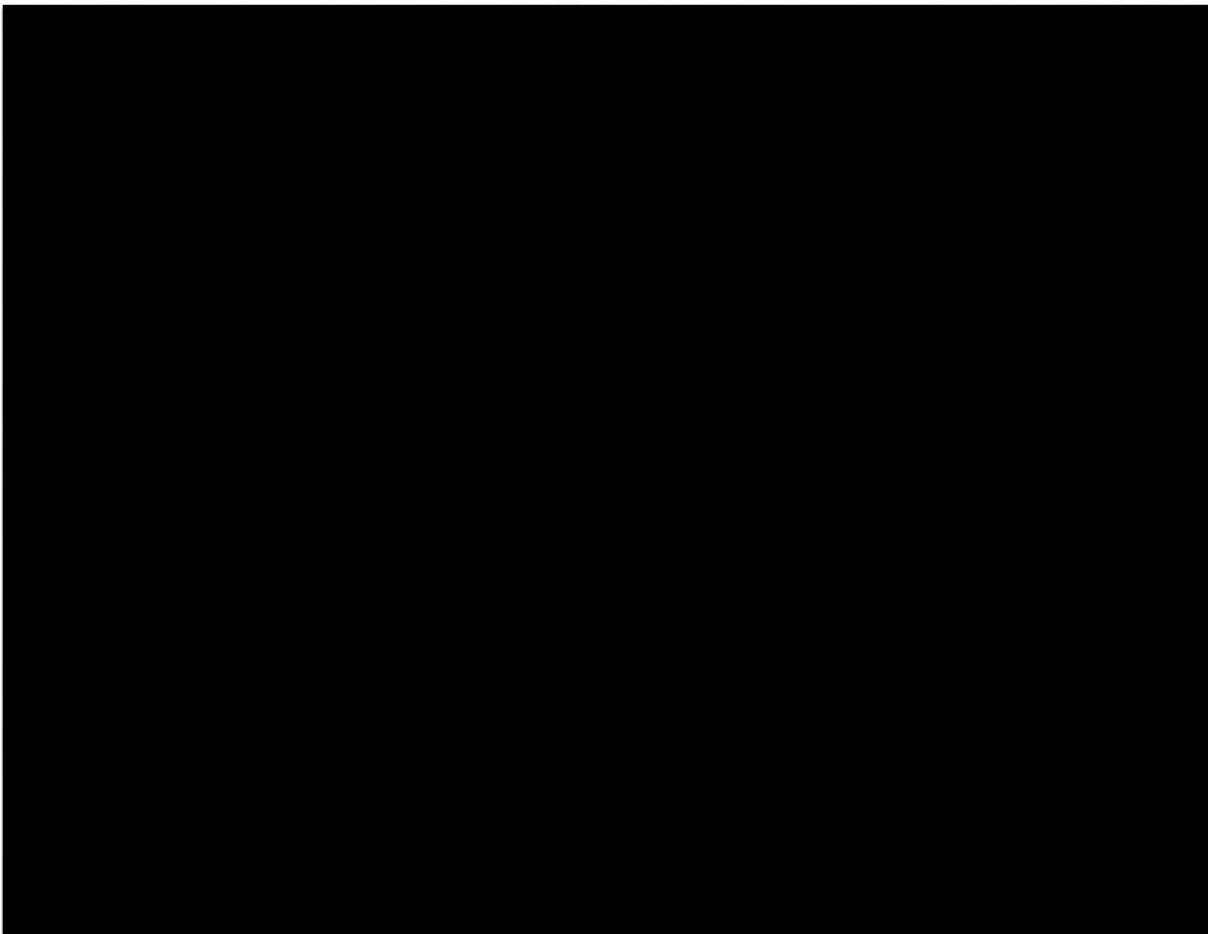
