Notes to the Accounts

1. The General Fund is the Church's main fund and is used for meeting the day to day running costs of the Church including the payment of the costs and expenses of employing a part-time minister.
2. Affiliation Fees are payable annually at the rate of £23 per member and are collected in four quarterly instalments. These fees accumulate in the Affiliation Fee fund and are used to pay fees arising from the Church's membership of the Congregational Federation. Any excess monies are available for general purpose use.

3. The Benevolent Fund is earmarked for the receipt of monies collected for the purpose of supporting charities other than the Council for World Mission and the monies in this fund are not available for any other use.
4. The Fabric Fund is intended essentially for the setting aside of monies which are nominally earmarked for the purpose of renovation and upgrading of the Church buildings and manse. It would be possible, however, for all or some of the monies accumulated in this fund to be used for other purposes should the need arise at any time.
5. The Legacies Fund exists for the purpose of receiving any monies bequeathed to the Church. Monies in this fund are used to comply with any instructions laid down with the bequest or, where the bequest was made without any particular instructions for its use, for general purposes.

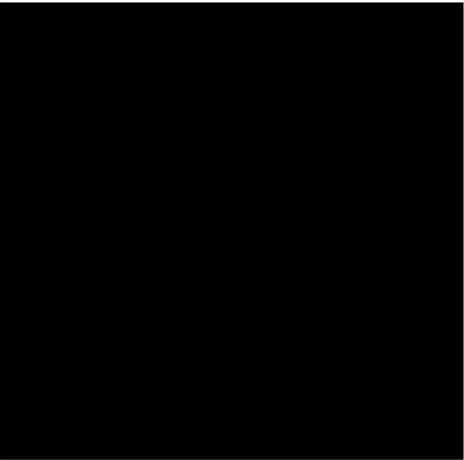

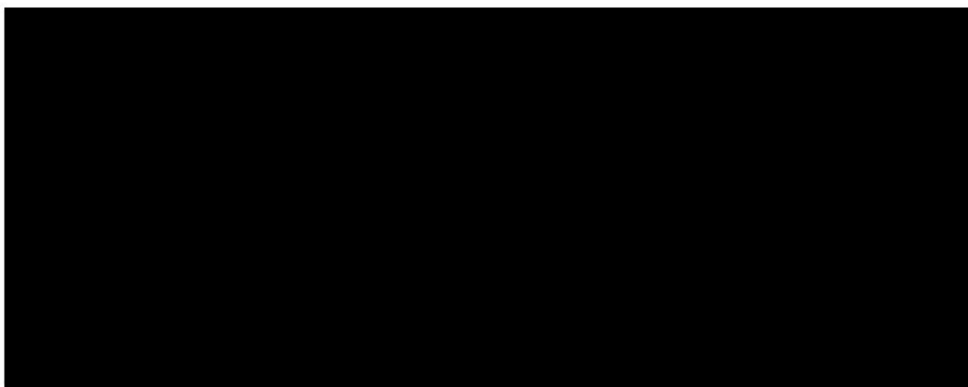
