## **Trustees' Annual Report Year ended 31 December 2025**

### **Structure, Governance and Management**

#### **Governing Document**

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

#### **Recruitment and Appointment of Trustees**

Members of the Kirk Session are the charity trustees. They are elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. They cover the spiritual affairs and management affairs of the church.

The Minister is elected by the congregation & inducted by the Presbytery of South West Scotland.

#### **Organisational Structure**

The Kirk Session is chaired by the minister & normally meets 10 times in a year. This year the Kirk Session met 9 times.

#### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Services of Worship are held each Sunday morning with Communion taking place twice this year - once in April & once in November.

#### **Achievements and Performance**

This year has been a difficult year for the congregation with the loss of 3 of its much respected members.

Sunday Worship continues to be held at the Institute Building. Attendance remains somewhat variable, ranging between 12 and 20 and is very much weather dependant. Our joint Christmas Eve Service at Auchinleck Parish Church, attracted in excess of 40 persons. The actual Church Building at Chapel Brae in Catrine is still up for sale and as such our Insurers require weekly checks to be carried out and records kept. Three teams of Church members have taken on the duty, via a rota system, of carrying out these checks and the Church Elders continue to express their thanks.

The Congregational AGM took place, after the morning service, on 12/02/25.

Over the final 3 months of the year we hosted several visitors from Presbytery who presented the proposal details for the Union between both Auchinleck & Catrine Parish Churches. The communications and discussions were well received by both the Session and Congregation and the decision to commence the Union on the 1<sup>st</sup> of January 2026 was agreed.

## **General Comments**

The accounts have been prepared in a similar layout as last year, this reflects to requirements made by the Office of the Scottish Charity Regulator (OSCR).

Overall in our General Fund, our balance decreased by £1090. This decrease was due to several factors including slightly less offerings, no income from the sale of church assets etc. However, with the December Insurance Premium of £1028 still to be reclaimed then this would help eradicate this deficit. Catrine have still to settle combined costs with linked charge at Auchinleck for 2025 and this is expected to be in the region of £1550. Thus overall expectations would be down circa £1600.

The general income was up some £1136 in comparison to 2024. The 2025 expenditure also decreased by some £1435 in comparison to 2024. The major contributors to the income increase was the reclaim of Insurance from the Consolidated Fabric Fund plus a small increase in Tax received back from HMRC from Gift Aid and Gasds - Gift Aid Small Donations Scheme. The decrease in general expenditure was due mainly to no major Manse maintenance being carried out and the costs square up with Auchinleck not yet having happened.

In 2025 the Giving to Grow contribution required also decreased thus helping expenditure. .

There continues to be no interest added from the Bank to the General Fund, however the Fabric Fund shows a healthy increase in Bank Interest of £877.

## **Comparisons**

### **Payments:**

There was a decrease of £1435 in the general account payments. The Giving to Grow contribution required decreased this year to £8846 from £8953 in 2024. Other payments include Electricity in the Church which has to be kept on to allow the sump pump to operate should any ingress of water reach a set level. Increased Insurance payments due to the Church Buildings being unoccupied & the Community Hall rent also all contributing to costs. Several donations to other Charitable Organisations were made & Ministers Travelling Expenses showed a reduction this year.

### **Income:**

The general account income / receipts were £20176 and increase of £1136 on 2024. The FWO and Plate Income were down £127 & Gift Aid Offerings also fell by £45. Other contributors to income included, an increase of approximately £100 in donations and slight increases in Refund from HMRC and Special Collections. Apart from the Offerings the other major source of Income was the reimbursement of Insurance and energy costs from the Consolidated Fabric Fund. This reimbursement is to offset the amount expended throughout the year. December expenditure for Insurance and Energy has still to be reclaimed. There continues to be zero income from weddings and funerals.

## **Reserves Policy**

The Trustees consider it prudent to try and hold reserves (including designated funds) to cover 12 months of normal expenditure. In addition, the Trustees seek to hold additional funds for unexpected expenditure on the Church and Manse buildings. These designated funds, known as the Fabric Fund, have gained some £877 in Bank interest taking the balance of the account to £79431.

EON Next are the preferred & agreed supplier, for electricity, set up through the Church of Scotland Scheme. Although the Church in Chapel Brae is vacant there is still a Smart meter and Direct Debit system in place with costs averaging just over £11 per month. There is no oil fuel requirement in 2025 as the congregation are operating out of the Institute Building.

**Statement of Trustees' Responsibilities**

The members of the Unitary Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Unitary Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

## Independent examiner's Report to the Trustees of Catrine Parish Church

I report on the accounts of the charity for the year ended 31st December 2025 which are set out on pages 7 to 13.

### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

### Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

2. to which, in my opinion, attention should be drawn in order to enable a proper understanding of the accounts to be reached
