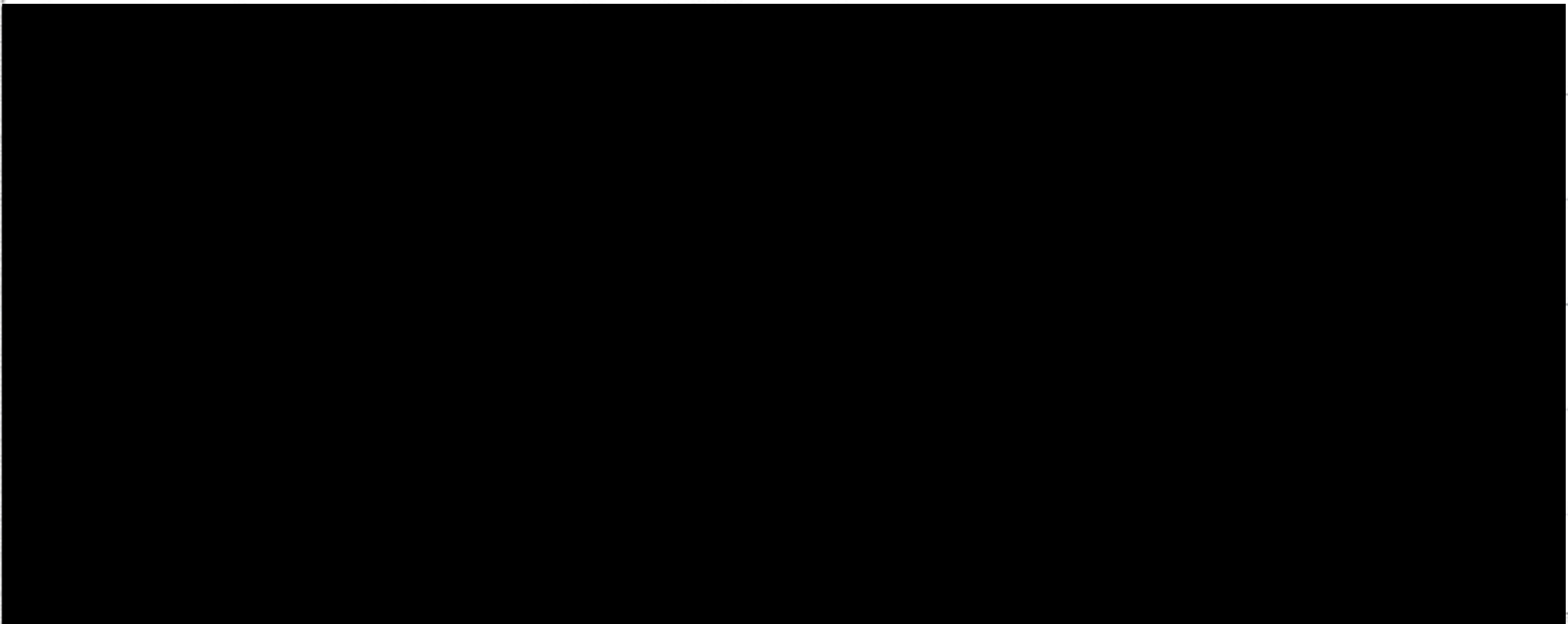

Structure, governance and management

Type of governing document

Evangelical Church Hamilton is established by constitution. The church is a Scottish Charity (number SC013970).

Trustee recruitment and appointment

The Elders of the church are its Trustees for the purpose of charity law and throughout this report are collectively referred to as the Trustees.

The church is independent and congregational. Its policy and its day-to-day running is undertaken by the Trustees.

The offices of Chairman and Secretary are, in terms of the constitution, appointed from the Trustees.

The church has Elders, recognised by the church as fitted for such roles, and appointed from time to time by the Trustees in accordance with the Constitution.

Objectives and activities

Charitable purposes

The advancement of religion and any other purpose regarded by the Church as analogous to this purpose.

Summary of the main activities in relation to these objects

The main activities of the church over the year were:

Sunday:

Communion Service, Family Worship Service, Bible Teaching Service & Sunday School (All open to visitors).

Midweek:

Toddlers group, Craft Class, Prayer meetings and Missionary Focus meetings (regular presentations from missionaries and mission organisations). We have also operated a drop in coffee morning twice monthly to encourage connections between Church members and the local community. There is no charge for this café so that no member of the community should feel excluded.

Other ad hoc activities took place including a Ladies Supper Club, Easter and Thanksgiving Breakfasts and Christmas Carol Service.

Achievements and performance

Summary of the main achievements of the charity during the financial period

During the year the church met regularly for worship and was actively involved in achieving the above stated aims through a wide variety of services and events from September onwards. This was due to the easing of Covid restrictions.

- Elders convened monthly for the purpose of assessing the spiritual welfare of the church members. Specific tasks, within an overall policy, were delegated to other groups and individuals for appropriate action.
- Regular meetings took place to raise the awareness of worldwide mission and the activities of other bodies engaged in meeting the needs of less privileged sections of society.
- Financial contributions were made to organisations in the UK and abroad. Organisations and individuals included The JAM Club (a youth centre based in East Kilbride), Operation Mobilisation, Barnardo's, African Missionary Fund, CMCT (India), Haven Missionary Home, Good News for Everyone, Scottish Bible Society, Opal Trust, Brass Tacks and the Trussell Trust.
- In addition to all the above, Selkirk Street Evangelical Church achieved the following in the financial year:
 - Maintenance, repair and refurbishment of the church property are under constant review. In the year the majority of fluorescent lighting has been replaced with LED.

Financial review

Brief statement of the charity's policy on reserves

It is the policy of the church to maintain unrestricted funds, i.e. funds not committed or invested in fixed assets, at a level that equates to approximately three months unrestricted expenditure. This allows sufficient funds to enable the ongoing work of the church to be maintained. The General Fund at 31st March 2025 was above the required level.

Total church funds were in surplus at the year-end.

The church has no donated facilities.

Links with other charitable organisations

- The Church partners with Tisbury Bible College in Motherwell and provides pastoral care to residential students attending courses there. There were no students in the year.
- A member of the Church is on the board of CMC (India).
- A family associated with the Church serve "Logos Hope" – A ship owned by a Christian charity which specialised in the distribution of educational resources mainly in less affluent areas of the world. They currently run the main book distribution depot in Florence USA.
