Trustees' Annual Report for the year ended 31st December 2024

Aims and Objectives

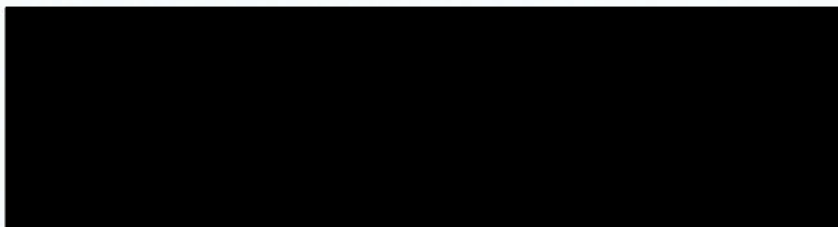
We are a church congregation. Our objectives, as enshrined in our constitution of 1st May 1961, as subsequently amended, are to proclaim the gospel of Jesus Christ as the Word of God in the strength of the Holy Spirit and on the basis of the Old and New Testaments.

Specifically, in its proclamation of the Gospel, its pastoral care and social work, the Congregation recognises its responsibility towards all German-speaking persons residing permanently or temporarily in the western half of Scotland, the eastern half being the responsibility of our sister congregation in Edinburgh/Aberdeen.

Administration

The ultimate governing body of the Charity is its membership, in the form of the Congregational Assembly, which makes decisions at its Annual or Extraordinary General Meetings. The day to day management of the Charity's affairs is vested in a committee known as the Church Council. All members of this committee act as Trustees and thus as formal owners of the congregation's assets on its behalf.

Activities

Regular church services continued to take place monthly in the Belmont Room of Kelvinside Hillhead Church, mostly on Saturday afternoons.

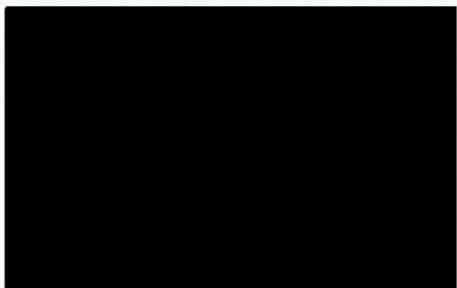
Consent from OSCR was given on 22nd November 2023 both for the change of name of our sister congregation in Edinburgh/Aberdeen (SC009066) to "German Speaking Congregation in Scotland", and for our union with that congregation, by way of Glasgow congregation being wound up after having transferred all our assets to that congregation.

Following preparatory work going back several years, this union finally went ahead this year, taking effect de facto from January 2024. This was duly formalized at our first joint AGM on 4th May 2024, when a new revision of our constitution was adopted.

Membership of this joint congregation stood at 113 (20 in Glasgow, 93 in Edinburgh/Aberdeen).

Financially, all our expenses throughout the year were met directly from Edinburgh, while all our readily accessible funds were run down to a zero balance at year end, and transferred to Edinburgh. We retained only some £632k in fixed term investments that were to mature during 2025. We nevertheless considered even those assets transferred by virtue of the fact that the new committee consisted of all committee members of the originally separate congregations. Meanwhile (at time of writing, September 2025) those funds have also been transferred.

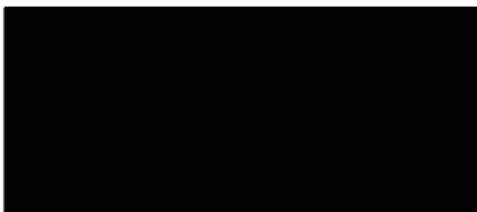

Independent Examiner's Report to the Trustees of the
German Speaking Congregation in Glasgow

I report on the accounts of the above charity for the year ended
31st December 2024 which are set out on the attached two pages.

The charity's trustees are responsible for the preparation of the
accounts in accordance with the terms of the Charities and Trustee
Investment (Scotland) Act 2005 and the Charities Accounts
(Scotland) Regulations 2006 (as amended). The charity trustees
consider that the audit requirement of Regulation 10(1)(d) of the
Accounts Regulations does not apply. It is my responsibility to
examine the accounts as required under section 44(1)(c) of the Act
and to state whether particular matters have come to my attention.

My examination is carried out in accordance with Regulation 11 of
the 2006 Accounts Regulations. An examination includes a review
of the accounting records kept by the charity and a comparison of
the accounts presented with those records. It also includes
consideration of any unusual items or disclosures in the accounts,
and seeks explanations from the trustees concerning such matters.
The procedures undertaken do not provide all the evidence that
would be required in an audit, and consequently I do not express
an audit opinion on the view given by the accounts.

In the course of my examination, no matter has come to my
attention which gives me reasonable cause to believe that in any
material respect the requirements (to keep accounting records in
accordance with Section 44(1)(a) of the 2005 Act and Regulation 4
of the 2006 Accounts Regulations, and to prepare accounts which
accord with the accounting records and comply with Regulation 9 of
the 2006 Accounts Regulations) have not been met, or to which, in
my opinion, attention should be drawn in order to enable a proper
understanding of the accounts to be reached.
