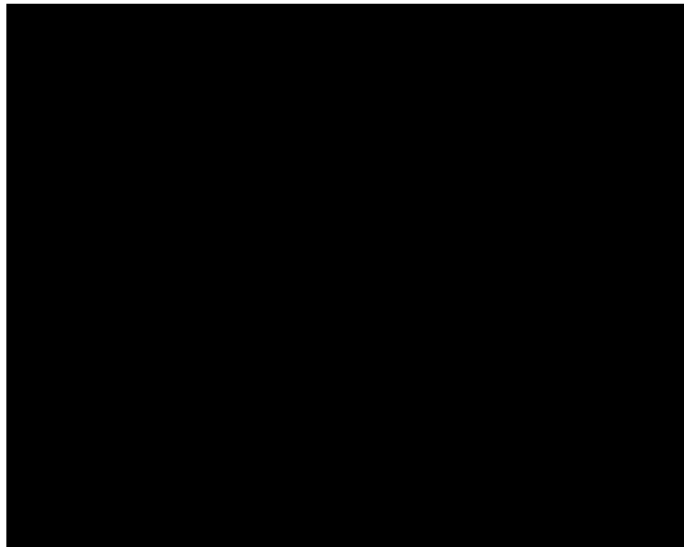

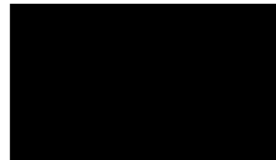

## Trustees' Annual Report

The trustees submit their annual report together with financial statements for the year ended 31 December 2024.

### Structure, Governance and Management

#### Governing Document

Since 2008, Coupar Angus Abbey Church of Scotland is administered in accordance with the terms of the Unitary Constitution. (Deed signed October 2007.)

#### Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills.

The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

#### Organisational Structure

The Kirk Session meets a minimum of five times per year for ordinary business with additional meetings called as required, and is responsible for all aspects of the life of the congregation in terms of pastoral well-being, and all matters relating to fabric and finance. Members of the congregation who are not elders but who have the skills and commitment to contribute to the management affairs of the church are invited to become involved in the work of the Kirk Session through groups and committees as required.

#### Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people of every parish of Scotland through territorial ministry. It co-operates with other churches in various ecumenical bodies in Scotland and beyond.

#### Achievements and Performance

A hard financial year again with the inflation rates and cost of living. This has resulted in higher costs all round for everyone and the running of the finances of the church, however glad to say another storm weathered and we are progressing onward, with the help of all the volunteers and generosity of the congregation. Many thanks to all for their support.

We are at present without a minister many thanks to Worship Readers who have stepped forward with their services and keeping Sunday services going strong.

Over the year the teas and coffee after service have proved successful and many stop to chat and enjoy each other's company and fellowship. Not to forget those that help running this. The Soup Lunches also have proved to be popular and attendance increased each time, these at present are running twice a month and will run until the end of March 2025 where the volunteer's will have a well-deserved break until next season begins again.

Our Friendly Fridays are as popular. Held on 1<sup>st</sup> Friday of the month these have been busy bringing fellowship and a welcoming afternoon with teas, coffee, biscuits and cake. The charity shop although only run for a week was successful, this will be run again but for two weeks mid-2025. Confirmation of dates will be notified through posters and intimations at church services.

There are changes afoot within the church and the aim is to have them completed by end 2025 it is planned further information will be forthcoming over the next year to keep us informed.

#### Financial Review

The principal source of income is from offerings and donations, amounting to £32,428 (2023 - £23,540) plus gift aid recovered amounting to £4,821 (2023 - £7,189) which in total equates to 82% of our overall income.

The other income generated from fundraising, charity shop income, bank interest and use of premises amounted to £8,020 (2023 - £6,923). Our total income is therefore £45,269 (2023 - £37,652).

“Other income” was used to disclose the payments of £1,893 owed by Bendochy from their share of expenses.

The Church recorded a surplus in the year of £7,209.

#### Restricted Funds

*The Abbey Church Development Fund* was created to control income and expenditure relating to the development of the sanctuary in any way. All funds from specific fund-raising activities are placed here and can only be spent in relation to such development.

The Children's Ministry receives no financial support from the Church and pays for the use of the church building. Its income mainly comes from weekly subscriptions, with occasional small donations from individuals. Although the congregation has no claim or access to these funds, in the event of these groups being closed down any residual funds will be divided equally between Coupar Angus Abbey Church of Scotland (SC014438) and Bendochy Parish Church of Scotland (SC004358).

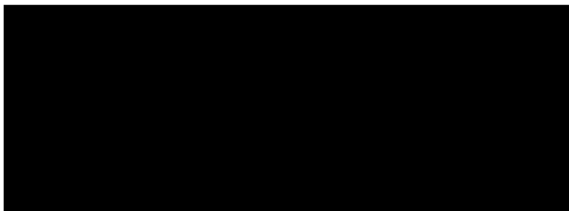
#### Reserves Policy

The Church intends to maintain a reserve fund sufficient for 3 months expenses. As further funds become available this will rise to 6 months.

#### Statement of Trustees Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

## Independent Examiner's Report

### Respective Responsibilities of the Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the 2006 Accounts Regulations does not apply. It is our responsibility to examine the accounts under section 44(1) (c) of the Act and to state whether particular matters have come to our attention.

### Basis of independent examiner's statement

Our examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006 (as amended). An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently we do not express an audit opinion on the view given by the accounts.


### Independent examiner's statement

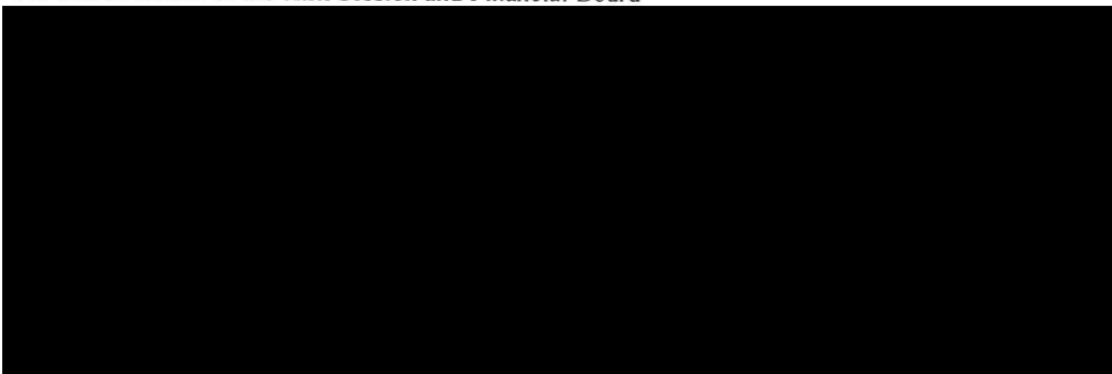

### **Notes to the Accounts**

#### **1) Accounting Policies**

**(a) Basis of accounting**

The accounts are prepared under the historical cost convention, in accordance with applicable Accounting Standards, the 2015 Statement of Recommended Practice and the Charities Accounts (Scotland) Regulations 2006.

There is no difference between the surplus on ordinary activities in the Receipts and Payments Accounts and its historical cost equivalent.

**(b) VAT**

The Church is not registered for VAT and therefore the expenditure is shown inclusive of VAT.

**(c) Heritable Properties**

Heritable properties, consisting of the Church, Halls and Manse, are not recorded in the accounts. The title deeds are held by the Church of Scotland General Trustees.

**(d) Funds**

Normal fabric repairs and maintenance are charged to the General Fund, extraordinary repairs and improvements are met from the Fabric Fund and by special fund raising efforts.

#### **2) Trustee Remuneration and Related Party Transactions**

No trustee or person related to a trustee had any personal interest in any contract or transaction entered into by the church during the year and no remunerations were paid to any other trustees during the course of the year.

#### **3) Minister's Stipend**

All Church of Scotland congregations contribute to the national stipend fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For 2024 the minimum stipend is £31,642 and the maximum stipend (after 5 years and subsequent years of service) is £38,884.
