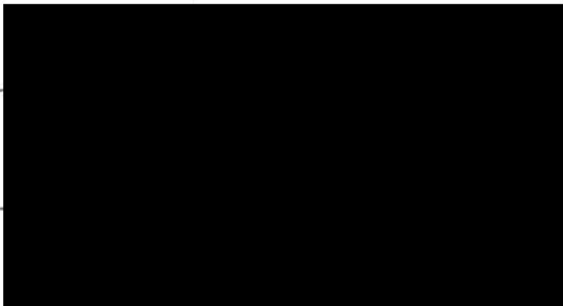

#### 5. Trustee Remuneration and related Party Transactions

During the year the Locum Ministers were reimbursed expenses of £1,663 in respect of travel and other expenses and £3,195 was paid in respect of ( Council Tax for the Manse and Church Refuse Collection).

No Trustee or person related to a trustee had any personal interest in any contract or transaction entered into by the charity during the year.

#### 6. Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all minister's stipends and employer's contributions for national insurance , pension and housing and loan fund. Minister's stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £ 31,642 and the maximum stipend (in the fifth and subsequent years) £ 38,884
