TRUSTEES' REPORT

STRUCTURE, GOVERNANCE & MANAGEMENT

Governing document

The Church is administered in accordance with the Deed of Constitution Unitary Form.

Recruitment and Appointments of Trustees

Members of the Kirk Session are the charity Trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills and commitment to contribute to manage the affairs of the church. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session, which meets nine times a year, and as required, is responsible for the spiritual and financial affairs of the church. Certain responsibilities were delegated to the Property Committee and Finance Group.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Activities, Achievements and Performance

Worship Services:

Worship Services are held weekly on Sundays: 09.45 at Valleyfield Community Centre, followed by 11.00 at Culross Abbey. Refreshments and fellowship follow the High Valleyfield Church Community Centre services. Joint Holy Communion Services were held on four occasions at High Valleyfield. During Holy Week we attended evening services in the different Cluster Churches. In 2025 we joined with other churches in the Cluster on a few occasions for joint Sunday worship. As part of this, a very well attended service was hosted by us at Culross Abbey. We were invited to join Limekilns Church for their celebration of 200 years in the church building. The Rt Rev Rosie Frew, Moderator of the Church of Scotland, preached on that special occasion. We led the Remembrance Service at the Culross War Memorial at 11.00 and the Service, Remembrance and laying of wreaths at the village War Memorial at High Valleyfield Club in the afternoon. At Christmas, we attended a Candle Service for the bereaved at Tulliallan & Kincardine Church. Our annual Watchnight Service on 24th December at 11.30pm was held in Culross Abbey. Members of the congregation and community participated in this Service.

Baptisms, Funerals and Marriages - During 2025 there were – 2 Weddings, and 5 Funerals

High Valleyfield Church Café — The Café is open on Tuesday mornings: 10.00 – 11.30, and is now held in Valleyfield Community Centre — tea and coffee, scones and biscuits are served. Members of the community and congregation meet and enjoy a time together each week.

Harvest Home Meal with Entertainment — This annual event took place in Oakley Church, organised jointly by Carnock & Oakley Parish Church and ourselves. Invitations were sent to all the Cluster Churches and there was a fair representation at this very enjoyable event. After a lovely meal, with lots of catching up around the tables, a Scottish Country Dance Group entertained, providing opportunities for listening to the rousing music and for dancing. It was a very enjoyable event, bringing together the different congregations in the Cluster.

West Fife Villages Cluster — We are part of this Cluster, along with Saline & Blairingone, Carnock & Oakley, Limekilns with Cairneyhill and Tulliallan & Kincardine originally with the hope of forming a Union of the six churches. However, during 2025, Saline & Blairingone, Carnock & Oakley and Tulliallan & Kincardine agreed to form a Union of their three churches. The Union, West Fife Trinity Church of Scotland, became effective on 1st January, 2026. Meanwhile, Limekilns, Cairneyhill and Culross & Torryburn are in discussions about forming a Union, with the agreed name of West Fife St Mungo's Church of Scotland. No decision regarding a Union can take place until Culross Abbey is sold.

Property — Culross Abbey — Sunday Worship is held weekly at 11.00. The Presbytery listings for churches in Fife, show Culross Abbey as 'B' listed, which means 'to close, let or otherwise be disposed of by the end of 2027'. In August the Abbey was advertised for sale on the open market. The closing date was 27th September and several offers were submitted and one accepted. This offer did not finalise though because of the high cost of insuring the building. We are currently in communication with other interested parties who submitted offers.

High Valleyfield Church — Weekly Sunday Worship at 09.45 now takes place at Valleyfield Community Centre. The Kirk Session had to take the difficult decision to close High Valleyfield Church building in 2025. It was deemed unfit for purpose with several major health and safety issues. The last service was held there on Easter Sunday. The Services and activities have been moved to Valleyfield Community Centre where we have been made most welcome. Presbytery has given the High Valleyfield Church a 'B' listing means that 'it should remain open meantime'. With this in mind, plans were put in place sometime ago to rebuild the rear of the building and upgrade it to a satisfactory standard. Now, the final decision on this will be made by the new Union Kirk Session in conjunction with Presbytery once Culross Abbey is sold and, that is, assuming a Union does take place.

Mission Together — This group has been formed within the Cluster to promote mission activities in the Cluster. They have a number of initiatives being considered. One already in place is to hold Lego Clubs for primary age children within all parts of the Cluster. So far, two sessions have taken place in the Culross & Torryburn Parish, at Valleyfield Community Centre, and were well received by the children who attended.

Fundraising — Special offerings were uplifted for Christian Aid in May and £701 was sent to that Appeal. The Remembrance Day retiral offerings in aid of ERSKINE amounted to £170, including donations received at the Remembrance Service in Valleyfield Community Club.

Summary/Future – Again we say, we continue to be in challenging times. We continually seek God's grace and guidance and future plans for us. We thank all who have supported us throughout the year. We especially thank Sandy Muirhead, Reader and Session Clerk, who has led most of our services in 2025. We also thank Mrs. Margaret Dow our Interim Moderator for her support.

FINANCIAL REVIEW

Principal source of donated income is weekly offerings – 0.03 % decrease.

Change in numbers of Gift Aid donors - increased by 0

Changes in giving by Standing Order - increased by 1

The income and expenditure on the individual funds are stated in Note 1 to the Accounts.

Reserves Policy

The Church held unrestricted and designated funds and no endowment funds at the end of the year. In addition, it has fabric fund capital held on its behalf by the Church of Scotland with a market value of £514,040 and fabric fund revenue £2,123. It is the Trustees' policy to hold sufficient reserves of at least approximately six months' expenditure including investments at Market Value. At the year end the Church held unrestricted and designated funds of £40,173 and £2,826 in Restricted Funds, the purposes being shown in Note 1. On 11th December, 2025, the Growth Fund Investments were sold and details of this are shown in Appendix B.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.


Basis of independent examiner's statement

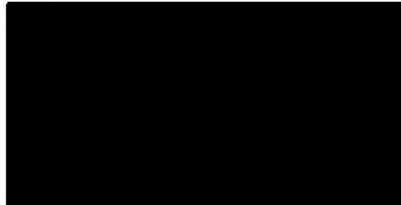

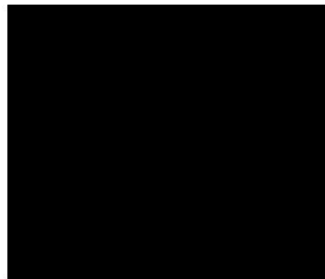

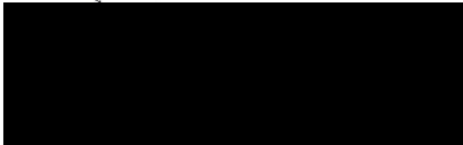

Fundraising — Special offerings were uplifted for Christian Aid in May and £515 was sent to that Appeal. The retiral offerings in aid of ERSKINE uplifted at Remembrance Sunday Services amounted to £127 including donations made at the Remembrance Service in Valleyfield Community Club.

TRUSTEES' REPORT (continued)

Activities, Achievements and Performance (continued)

Support Culross Abbey Regeneration Trust was wound up in 2023 and a very generous donation of £40,135 was made in the previous year to the Church's General Fund.

High Valleyfield Church Café — The Café is open on Tuesday mornings: 10.00am — 11.30am and serves tea and coffee, scones and biscuits. Members of the community and congregation meet and enjoy a time together each week.

Harvest Home Meal with Entertainment — This annual event took place in Oakley Church, organised jointly by Carnock & Oakley Parish Church and ourselves. Invitations were sent to all the Cluster Churches and there was a good representation at this very enjoyable event. After the meal, a Scottish Country Dance Band entertained, providing opportunities for listening to the rousing music and dancing. An enjoyable, sociable and successful evening.

West Fife Villages Cluster — We remain part of this Cluster, along with Saline & Blairingone, Carnock & Oakley, Limekilns with Cairneyhill and Tulliallan & Kincardine. Representatives from each of the churches met on several occasions during 2024. However, the Transition Group which was originally constituted to explore a union of all six churches was disbanded early in 2024 when Carnock & Oakley, Saline & Blairingone and Tulliallan & Kincardine expressed a desire to form a union together, separate from the others. Towards the end of the year the Mission Director for Fife Presbytery suggested that in addition to the union of those three churches there should be a union of Cairneyhill with Limekilns and then a linkage of the united charge with ourselves. This will no doubt be discussed further in 2025.

Property — Culross Abbey — Sunday Worship is held weekly at 11.00am. The Abbey is open daily to accommodate the many visitors, from near and far, who wish to visit. **High Valleyfield Church** — Sunday Worship weekly at 09.45am. This building is also our 'Hall' where meetings, etc., are held.

The Presbytery listings for churches in Fife, which specifically relate to our situation are – **Culross Abbey 'B'** listing, which means 'to close, let or otherwise be disposed of by the end of 2027'. The uncertainty around this decision is causing considerable concern for us and the surrounding communities. We continue to seek a new future for this spiritual, historic, and beautiful sanctuary. **High Valleyfield 'A'** listing, which means "remaining open meantime." Considerable structural work is required to bring this building to an acceptable standard. Plans have been prepared to replace the rear portion of the building and we remain in discussions with Fife Presbytery Property Group regarding this matter.

Summary/Future — We continue to have a challenging time. We continually seek God's guidance and plan for the future and are working towards this. We thank the Ministers who have supported us throughout the year. We especially thank [REDACTED] Reader and Session Clerk, who has led most of our services in 2024. We also thank [REDACTED] our Interim Moderator for her support.


Reserves Policy

The Church held a modest amount of unrestricted and designated funds and no endowment funds at the end of the year, but it also holds investments with a market value of £6,061 and a further £11,401 in restricted funds. In addition, it has fabric fund capital held on its behalf by the Church of Scotland with a market value of £491,968 and fabric fund revenue £6,907. It is the Trustees' policy to hold sufficient reserves of approximately six months expenditure including investments at Market Value. At the year end the Church held unrestricted cash funds of £17,643. The Church also held £11,625 in Restricted Funds which have been provided for the purposes specified in Note 1.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

INDEPENDENT EXAMINER'S REPORT

Independent Examiner's Report to the Trustees of Culross & Torryburn Parish Church

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 7 to 12.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations).

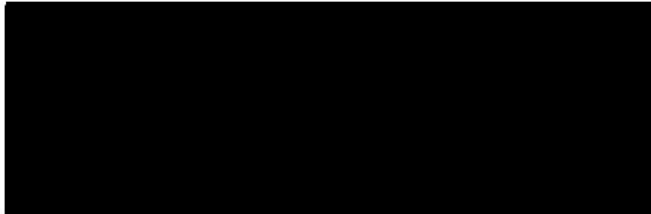
