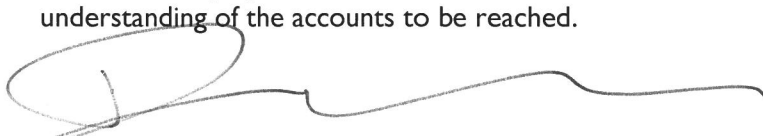
#### **Basis of independent examiner's statement**

### **Trustees' Annual Report Year ended 31 December 2025**

#### **Structure, Government, and Management**

The trust, which is a recognised charity in Scotland, is operated under the rules of its Trust Deed dated 17th May 1989. The management of the trust is the responsibility of the Trustees who are elected and co-opted under the terms of the Trust Deed.

#### **Recruitment and Appointment of Trustees**

The trust endeavours to elect and co-opt in line with the requirements of the trust deed.

#### **Objectives and Activities**

The principal object of the trust to operate a Heritage centre within the Church of Scotland Manse, Iona with a view to repair, renovate and maintain that property. There have been no changes in objectives in the year.

#### **Achievements and Performance**

Despite challenging conditions on Iona this year -poor weather and ferry cancellations leading to fewer visitors to the island -we maintained a steady income from sales and donations and rent from the cafe. We continued to expand the range of products on offer.

We recruited a manager for the centre to start in January 2026, and we also gained one new trustee.

#### **Financial review**

During the year the charity generated a surplus of £17,110, (2024 – surplus £3,869) all of which was unrestricted, resulting in total cash reserves of £51,613, (2024 - £34,503), all unrestricted.

#### **Plans for future periods**

With a manager now in place, we aim to grow visitor numbers and increase income through sales and new income streams.

Plans are for the manager to update the point-of-sale systems, apply for new sources of funding and improve the exhibit and our publicity.

We aim to do some fundraising specifically for building repairs.

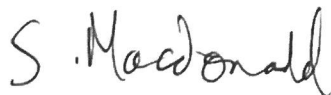
#### **Reserves Policy**

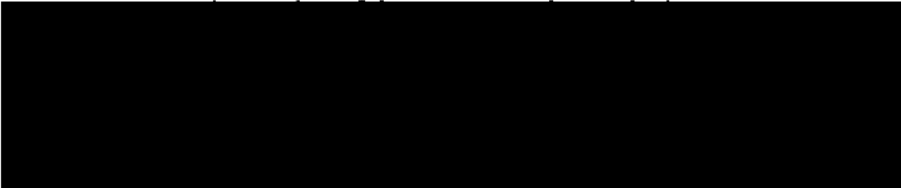

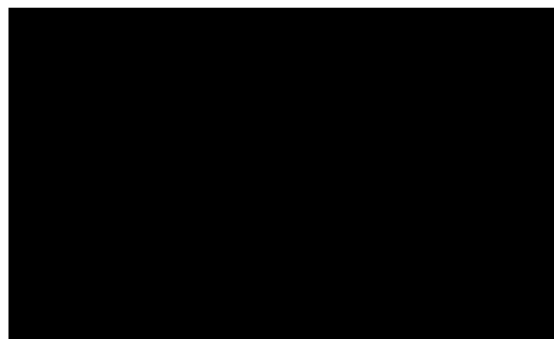

**Objectives and Activities**

The principal object of the trust to operate a Folk Museum within the Church of Scotland Manse, Iona with a view to repair, renovate and maintain that property. There have been no changes in objectives in the year.

**Achievements and Performance**

We undertook a small refurbishment early in the year, redecorating the gift shop and updating the display. We also refreshed and improved the range of products on offer. This resulted in an increase in sales.

Construction of the shepherd's hut was completed in time for the summer season and has provided a useful resource for the running of the café.

**Financial review**

During the year the charity generated a surplus of £3,869, (2023 – deficit £10,620) all of which was unrestricted, resulting in total cash reserves of £34,503, (2023 - £30,634), all unrestricted.

**Plans for future periods**

We aim to continue to expand sales in the gift shop, and to get the Good Box functioning to increase donations. The aim is to increase revenue sufficiently for us to be in a position to recruit a manager who will develop more income streams, improve the exhibit and oversee the running of the shop.

Due to retirement and change of circumstance we lost 4 trustees in 2024, we will endeavour to recruit more in 2025.

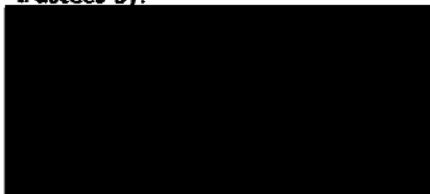

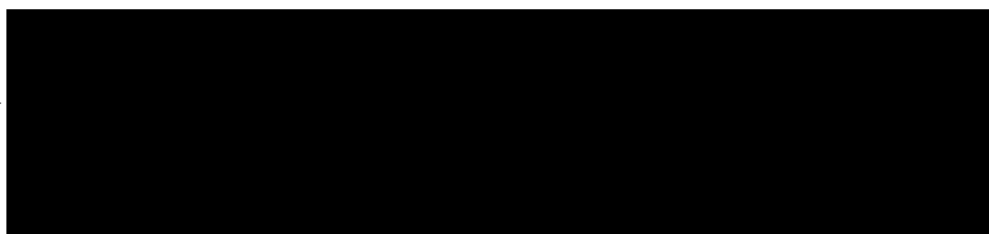
