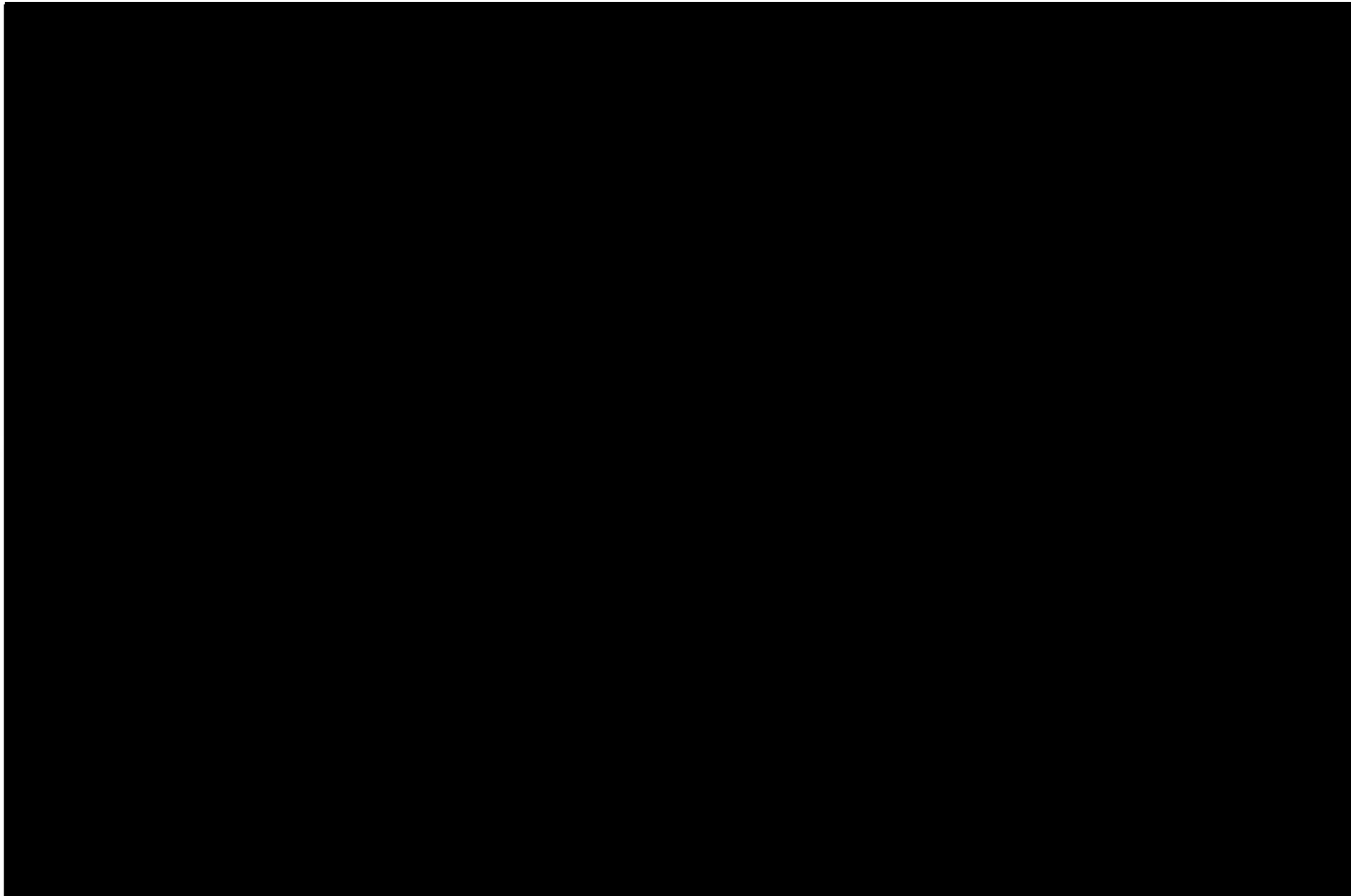

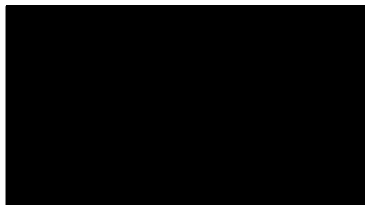

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Model Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills.

Currently, St Rollox Church, being a vacant charge, is supported by an Interim Moderator appointed by The Presbytery of Glasgow. The Interim Moderator is a member of St Rollox Church Kirk Session for the duration of the Interim Moderatorship

The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Board Members are then appointed at the Stated Annual Meeting and serve for a period of three years after which they must seek re-election at the next Stated Annual Meeting.

Organisational Structure

The Kirk Session, which meets normally six times a year, is responsible for spiritual affairs within the church.

The Congregational Board is responsible for the temporal affairs of the church. It is chaired by the minister or a designated member, elected from its membership, and normally meets six times in a year. Certain financial and fabric responsibilities are delegated to the Finance Teams and Property Teams as appropriate.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

The Congregation has been steadfast in our weekly Sunday service attendance.

There were new members who joined the congregation in 2024. This included 6 young people and 4 adults, publicly professing their faith to take on the membership of St rollox Church.

As a congregation, we have benefitted from the leadership and guidance of the pulpit supply with the engagement of the young people in leading praise and worship by showcasing their God given talents.

We are still going through the process of the Presbytery Mission Plan and there has been changes to the membership of Cluster 1F in terms of the different congregations.

St Rollox was also involved in the Sighthill Community Christmas Carol and tree lighting event as choirs.

Despite the uncertainties of 2024, we have witnessed the grace and mercies of God at St Rollox in 2024

Financial Review

2024 proved to be a difficult year for St Rollox Church from a financial point of view. In particular, the General Fund Year End balance showed a drop in the closing value compared with 2023 (£9150 v £12565). This was disappointing, though it is important to appreciate that we never the less met all our commitments for the year and the closing balance of £9150 is a positive position.

A brief summary analysis shows that the General Fund regular income dropped from £44894 in 2023 to £42343 in 2024.

At the same time, our costs, especially Energy Costs, increased from £39519 in 2023 to £45758 in 2024. We are subscribers to General Trustees Energy contracts which, after a 3 year fixed rate, introduced new suppliers and new rates from Sept 2023 for Electricity and from April 2024 for Gas.

Both handovers experienced difficulties and indeed our 2024 Accounts includes Electricity Charges from 2023 amounting to more than £1300 billed to us in 2024.

The Congregational Board continues to oversee the status of our Restricted Funds, each of which is meeting it's purpose.

As the costs associated with running our new building become clearer after the Covid interruption, and significantly increased contributions are demanded in 2025 from our Central Church, the Board has already planned a financial review during the 1st quarter of 2025

Reserves Policy

St Rollox Church' financial policy is to make best use of the gifts received through God's grace and goodness for the furtherance of his kingdom. Consequently, the Board has not formulated a specific 'Reserves Policy' to build up and store funds, but, mindful of any known future expense, simply applies wise and prudent application of the gifts received.

Statement of Trustees' Responsibilities

The Trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The Trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2016. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of St Rollox Church of Scotland:Glasgow

I report on the accounts of the charity for the year ended 31 December 24 which are set out on pages 6 to 11.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

Basis of independent examiner's statement

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006 (as amended). An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Purposes of Unrestricted Funds

General Fund: This fund supports the everyday operational work of the church

Purposes of Restricted Funds

Outreach Development Fund through TMF: St Rollox Church and Torrance Parish Church have a long standing friendship and as part of this, TPC's members who donate to TPC's Mission Fund (TMF), may direct their donation to any of the TPC Mission options. Those TPC members selecting St Rollox as their choice of Outreach Support, are the donors to St Rollox of this generous annual donation. The objective for St Rollox congregation is to engage in new activities and ventures aimed at making Christ's name better known amongst our new, developing community in Sighthill.

St Rollox Congregational New Church Build Fund: This Restricted Fund has been set up to finance the fitting out of the new church building with the necessary equipment for worship, fellowship and outreach. Increasingly, the fund will also provide financial support for ongoing building maintenance and repair costs

CPO Compensation Fund: Under the terms of the CPO covering the move from No 9 to No 70 Fountainwell Road, the congregation was permitted to claim for compensation in respect of very specific costs incurred.

As these funds were unplanned in terms of our budgeting for 2023, we opted to use them to carry out long outstanding improvements to the church manse in preparation of a new ministerial appointment. A small balance remains which will be used in time

5. Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale which is related to years of service. For the year under review the minimum stipend was £31642 and the maximum stipend in 5th and subsequent years of service was £38884

6. Unbilled Property Maintenance

The annual service and maintenance of all Gas Related Systems, including gas mainline check, main gas boiler, underfloor heating and ventilation interlock, was carried out and certified. However we have not yet been billed for the work.

The annual emergency lighting service and maintenance was commenced and we now await replacement parts to be fitted followed by the final check. Thereafter we shall be billed.

7. Furniture and Equipment

Using funds held within our New Build Fund, during 2024, we improved the facilities at the car park with parking instruction signs at a cost of £684

8. Financial Impact of Ministerial Vacancy

The congregation has been without a full time minister since August 2022, so 2024 is the second full year of operating under the Pulpit Supply process. The congregation has been delighted with the support and preaching from both PS Ministers. Nevertheless, the vacancy situation impacts many of the costs associated with running the church.
