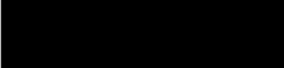
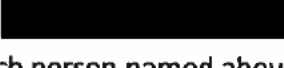

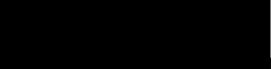

Structure, governance and management

Type of governing document

Deed of Constitution of the Commission of the Assembly of the Free Church of Scotland.

Aims and Affiliation

The Free Church of Scotland has more than 100 congregations in Scotland, as well as one in London and three in North America, and sister Churches founded by mission work in India, Peru and South Africa. The Church also has a full time degree awarding college in the heart of Edinburgh for the training of Ministers and other Christian workers and sustains an extensive Missionary programme relative to the size of the church.

Dating from 1843 but with its roots in the Reformation, it owes its distinctive title to its historical struggle to remain 'free' from state interference in its internal affairs. It has close and active relations with many other Reformed churches of Jesus Christ throughout the world and stands firmly in the tradition which accepts the Bible in its entirety as the Word of God and, therefore, derives its forms of teaching, worship, ministry and government from it. The main emphasis of our worship is the preaching of the gospel - the good news of a free and sovereign salvation through Jesus Christ alone.

The Free Church of Scotland is a Presbyterian church adhering in its worship and doctrine to the position of the Church of Scotland at the Reformation. There is an explanatory document which explains the origins of the Church and which gives the historical background to the Church coming into being in 1843 and lists documents in which is embodied its constitution.

Elgin Free Church of Scotland is a congregation of the national Free Church of Scotland working towards the common aims set out above. The congregation is within the Inverness, Ross and Lochaber Presbytery and is authorised by the Church to have a minister paid from the central funds of the Church. The Church building, halls and Church Manse are the property of the congregation and are held in trust by locally elected congregational trustees.

Trustee recruitment and appointment

The Finance Committee exercises its discretion in determining the most appropriate method of electing new trustees. Any election must involve the communicant membership of the congregation. There is no fixed term for Trusteeship. Prior to their appointment, new trustees would have served the church for some time in various roles and would be familiar with the church's values, its aims and objectives as well as its day-to-day operations. As part of their induction programme, new Trustees are required to understand their statutory responsibilities.

Summary of the main activities in relation to these objectives

During the year, the church met regularly for worship and carried out various activities in pursuit of the above stated aims. Church services continue to be broadcast on-line with the use of social media allowing members and adherents to worship together. The congregation continued its commitment to support the National Free Church of Scotland both spiritually and financially.

Financial review

Reserves – Results for the year

Now that Elgin Free Church of Scotland have linked with Burghead Free Church of Scotland both congregations share a minister and each congregation contributes to the stipend for the minister. This has allowed Elgin Free Church to build up some reserves, allowing the trustees to plan for the future. Both congregations also share an assistant minister, a missionary from U.S.A who is financed by his home congregation in St Louis, Missouri. Each church remains a separate financial entity with separate Finance Committees.

As a result, there was surplus for the year of £24,055 with church held funds amounting to £34,966 at the year end. That consisted of the General Fund having a surplus amounting to £26,648 and the Fabric Fund Account (Restricted) a surplus of £47. The Designated Fund (Restricted)(Charitable Donations) was closed with the funds being donated to charity in 2023.

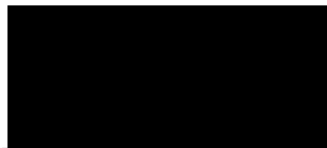
The trustees are satisfied with the level of reserves retained by the charity.

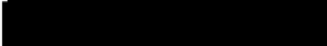

Report of the Independent Examiners to the Trustees for the year ended 31 December 2024

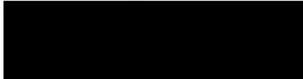
Basis of independent examiner's statement
