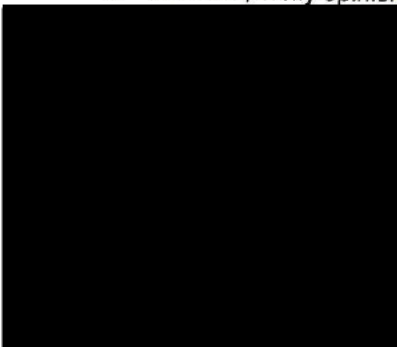
#### BASIS OF INDEPENDENT EXAMINER'S STATEMENT
