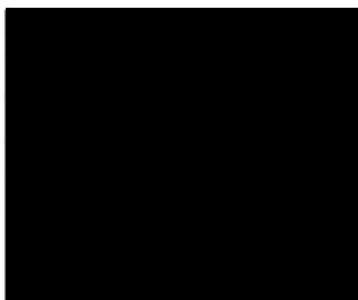

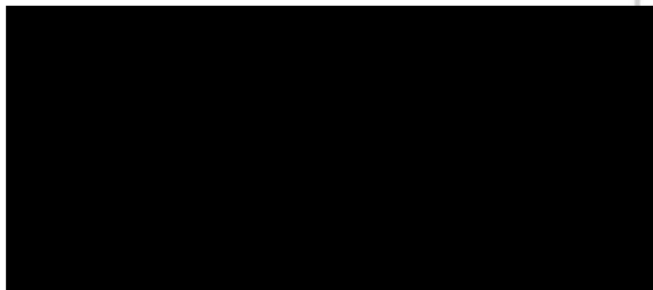

### **Trustees' Annual Report**

**Year ended 31 December 2024**

### **Structure, Governance and Management**

#### **Governing Document**

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

#### **Recruitment and Appointment of Trustees**

Active members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by

#### **Organisational Structure**

The Kirk Session is chaired by the minister, or such other nominee as authorised, and meets every six weeks. With our unitary constitution, it is responsible for the spiritual and temporal affairs of the church including all matters relating to mission, ministry, pastoral care, property and finance.

#### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical In 2024, St Paul's has continued to hold a weekly service of worship every Sunday, running a small Sunday School, as well as letting the premises to several community groups, including St Paul's Youth Forum which is lead by our Youth Team Leader and involves a number of our congregation.

#### **Achievements & Performance 2024**

**Fabric:** Our fabric expenditure continued to be similar to 2023 with main fabric costs being: 5 year inspection of Church Halls - Emergency lights hall and church -new RHS and isolater switch for Church electrical supply -Total cost £2363. Manse bathroom floor covering replaced £581 - and all ridge tiles on roof repointed £800. New chairs and trolley for Church Hall £1369. All other costs are annual maintenance and repair.

Despite the fact that we still have no Minister of Word and Sacrament or Locum support now almost 4 years, we continued to provide regular Sunday Worship in person and online under the leadership of 3 Elders (including our MDS Neil Young) who are accredited by Glasgow Presbytery to lead Worship without a Minister. We continue to involve members and friends to lead prayers and readings ensuring an all inclusive Worship. A number of our members are volunteers and involved in various groups.

2024 continued to be a year where we hoped that our cluster could finally move forward, but we are still waiting.

There are still a lot of discussions and decisions to be made before that can finally happen.

We are hopeful that 2025 will be the year when the implementation of our 3 Churches comes together and we are allowed to call a Minister.

Our Adult group regularly meet and support each other on Monday evenings.

The Lunch Club has continued to grow with numbers between 40 & 50 each week enjoying lunch and a wee game of bingo and a few outings

Our main hall is used for children's birthday parties on Saturday during the day.

The youth programme continued to offer a diverse range of activities and challenges for young people, supporting and encouraging them to try new things under the leadership of our MDS Neil Young and his staff. Our MDS is involved with Chaplaincy leading religious observance at Smithycroft Secondary School, leading assemblies and and working with over 1000 students over the year. Neil also meets with senior pupils weekly, supporting pastoral care and senior management.

#### **Risk Management**

The trustees formally review the policies in place to manage the risks the Church faces at their annual meeting to approve their report and the accounts. Steps are taken to ensure the management of these risks is strengthened where necessary.

#### **Financial Review**

The detailed accounts for the year ended 31 December 2024 are on pages 6 to 10 of this report. The accounts have been prepared on a cash basis.

#### **General Account**

The General Account shows an excess of income over expenditure for the year of £766. Offerings at £7,553 were down £851 or 10% in the year. Income from use of premises increased by £385 to £19,545. We withdrew £11,057 from our deposit with the Church of Scotland to pay for the property repairs. Total income increased by £381 to £38,435.

General Account expenditure reduced by £2,140 to £37,669. Maintenance costs accounted for £13,279 of that figure, a reduction of £7,072. We also paid £2,573 to the Church of Scotland Giving to Grow scheme. Other expenses includes £1,000 for our part of the costs of the 2023 Christmas Lunch. Cleaning costs increased by £1,742 to £2,854 while security costs fell by £2,091 to £706. All other changes were under £700.

The Trustees continue to be extremely grateful for the financial support offered to the congregation by the Church of Scotland.

#### **Restricted Fund**

Funds are held to support the work of the Chifubu School in Zambia

#### **Reserves Policy**

It is the Trustees' policy to hold reserves of approximately nine months expenditure including designated funds. At the year end the Church held unrestricted funds of £27,685, of which £2,253 had been designated for fabric. The total unrestricted funds represent about eight months' expenditure.

The trustees recognise that significant support will be required from the Church of Scotland to ensure the continued survival of the congregation.

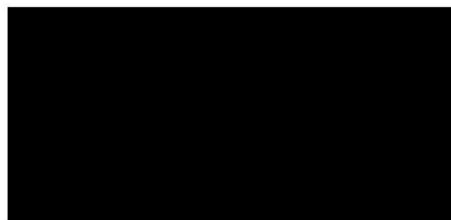
#### **Statement of Trustees' Responsibilities**

Charity law requires the trustees to prepare financial statements for each financial year which give sufficient detail to enable an appreciation of the transaction of the Church during the financial year.

The trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the charity at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended) and the General Assembly Regulations for Congregational Finance. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and/or detection of fraud and other irregularities.

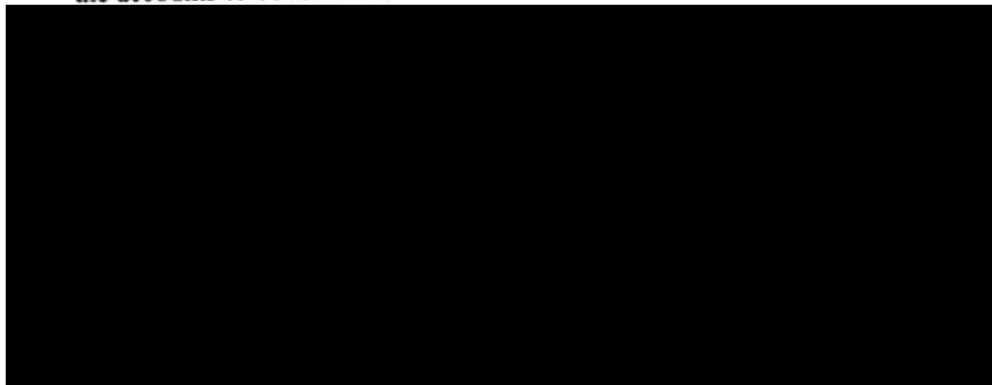
**Basis of independent examiner's statement**

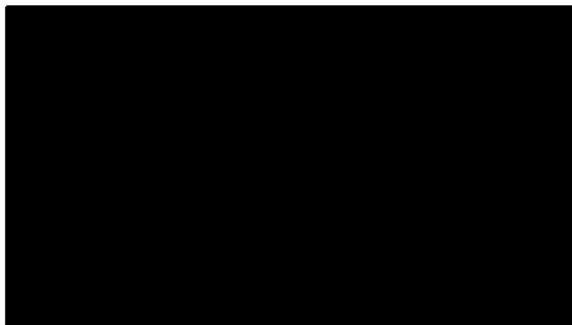

#### 5 Minister's stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £31,642 and the maximum stipend in the fifth and subsequent years £38,884.

#### 6 Collections for Third Parties

No formal collections for others were conducted during 2024 or 2023, although members regularly contributed to the foodbank at St Enoch's.

A donation of £Nil (2023: £100) was made to Lodging House Mission during the year plus additional in-kind donations at Christmas.
