Our purposes, as recorded in our constitution, are the advancement of the Christian faith primarily in Orkney and also throughout Scotland and the rest of the world by all means consistent with the teachings of the Christian Bible including worship, ministry, mission, prayer, witness, education, community service and the support of agencies and individuals and other charitable organisations involved in Christian missionary work and the relief of poverty or other social needs.

Activities and achievements

Over this past year, we have continued our weekly worship activities, including Sunday morning worship services, Sunday evening café church, weekly small groups, and monthly prayer meetings. These activities have all been in person, with the exception of some small groups which meet online as they find this an easier format for group participation, with the further benefit that it enables people from other islands in Orkney to take part. We also continue to livestream our Sunday morning worship services, to allow folk to worship at home where this is necessary due to illness or infirmity, and we continue to record our services by video or audio, to allow people to watch/listen later. Our leader of Evangelism and Youth continues to work for us – his current fixed term contract runs until 15th March 2028.

The church preaching team has provided bible preaching and teaching during the time of vacancy. The church website was replaced with a new site that adds sermon audio files stored directly within the site, a church contacts login, address book and emailing facility, church calendar and rota reminders.

During the year Kirkwall Baptist Church provided premises and facilities for the local Salvation Army, whose building was undergoing major renovations and extensions.

Trustee remuneration and connected party expenses

Two Trustees received remuneration during the year: our Minister, Rev Tim Proudlove and the Leader of Evangelism and Youth, Fraser Scott.

A total of £3,389.67 (2024: £2,005.40) was reimbursed to six (four) Trustees or connected persons for a leaving gift and expenses incurred on behalf of Kirkwall Baptist Church.

In addition, one of our Trustees, Mark Berry, is a Trustee of Orkney Street Pastors. £600 (2024: £300) was donated to Orkney Street Pastors. Alan Scott is the manager of Orkney Foodbank. £480 (2024: £480) was donated to Orkney Foodbank. A connected person is a Trustee of Vital Talk Orkney. £480 (2024: £480) was donated to Vital Talk Orkney.

Financial Review

The church receives its funding from church members and adherents by way of offerings, Gift Aid and donations.

The financial statements for the year show receipts of £158,900.57 (2024: £128,329.95) and payments of £131,461.08 (2024: £113,649.78) with unrestricted funds of £148,982.33 (2024: £119,272.99) and no restricted funds (2024: £2,269.85) remaining at the end of the year.


Reserves Policy

It is the Trustees' policy to hold minimum reserves of approximately six months expenditure. At the year end the Church held unrestricted funds of £148,982.33 which satisfies this policy. This is an increase over the previous year however significant building repairs are expected.

Independent examiner's statement



1 Basis of Accounting

2 Nature and purpose of funds
