Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Board Members are then appointed at the Stated Annual Meetings and serve for a period of three years after which they must seek re-election at the next Stated Annual Meeting

Organisational Structure

The Kirk Session, which is moderated by the minister meets at need, and is responsible for spiritual affairs within the Church. The Congregational Board is chaired by the minister and meets when deemed necessary during the year.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Regular Activities

The Church gathers together for worship each Sunday at 10am and also at 6.30pm. There is a Sunday School provided during the morning service and a crèche for the very young children is also available. There is a family service once a month to which Boys' Brigade/Girls' Assn. attend and all are encouraged to take an active part. The Brigade/Assn. is booming with approx. 16 members who meet once a week for crafts, cookery film nights, trips out, and fun and games. The Scripture Union group meet Monday at lunch time in the local Primary School during term time. There is a study group meet on Tuesday afternoons and Wednesday for study and discussion. A very active Knit-wits, open to all, donated knitted goods to various charities including Prem baby unit. The Church is open to visitors daily all year round. A "warm space" together with refreshments is available each Thursday pm. The Faith, Hope and Charity shop, now in its 18th year is continuing to do well, a percentage of its profits is given to a number of Charities. For the church to have presence on the main street is vital, as it helps us to continue to build relationships with the Community and provides opportunity to communicate with locals and visitors alike. The shop also operates as a collection point for Wigtownshire Churches Basics bank, when closed an alternative is provided. This Christmas Eve due to inclement weather instead of carols on the main street the carol service was moved into the church, and a full congregation enjoyed the singing by members and locals alike. Refurbishment of the church by removal of the centre pews has made the space more user friendly their for groups and their activities.

Occasional Activities

Services in the open air are occasionally held in Whithorn and at the Isle of Whithorn. On Remembrance Day a service was held in the Priory followed by laying of wreaths at the War Memorial. This year's Christmas wreath festival in the church with families invited to bring along a wreath. A remarkable Nativity Service was held with around twenty youngsters taking part. A short Christmas Day family service was held. Many children enjoyed a visit by Calums Creatures with various exotic species to touch and learn about. The Church is a member of the Scottish Pilgrim Routes Forum.

Achievements and Performance

A calm Picnic area with tables has been developed on the Glebe Land for use of locals and visitors.

Blythwood Care: Shoebox appeal is supported by individual church members.

Fund Raising Events

Under normal circumstances most of the fund raising effort would be centred on the charity shop where a percentage of the net revenue is given to various local groups and other worthy causes.

Financial Review

Unrestricted voluntary income is lower than in 2023, due to an overpayment of gift aid refunds from HMRC in 2023 that was paid back in 2024. Income from fund raising activities was also slightly lower. Investment income has increased slightly from the 2023 level. Unrestricted expenditure was down by nearly 30% mainly due to a reduction in the contribution to Ministries & Mission. Grant income of £106,333 was received in respect of repairs to the church tower, of this £17,165 had been spent by the end of the year. Following the union of Whithorn Priory Church with Glasserton and the Isle of Whithorn £69,793 was transferred to these accounts. Total funds as at 31st December were £233,683 of which £93,090 is restricted.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted funds of £140,594, which represents approximately four years expenditure.

Statement of Trustees' Responsibilities

Charity law requires the trustees to prepare financial statements for each financial year which show a true and fair view of the state of affairs of the charity and its financial activities for that period. In preparing those financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operational existence.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Whithorn: St Ninian's Priory Church

We report on the accounts for the charity for the year ended 31st December 2024 which are set out under the Receipts and Payments Accounts.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is our responsibility to examine the accounts as required under section 44 (1) (c) of the Act and to state whether particular matters have come to our attention.

Basis of independent examiner's statement

Our examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently we do not express an audit opinion on the view given by the accounts.


