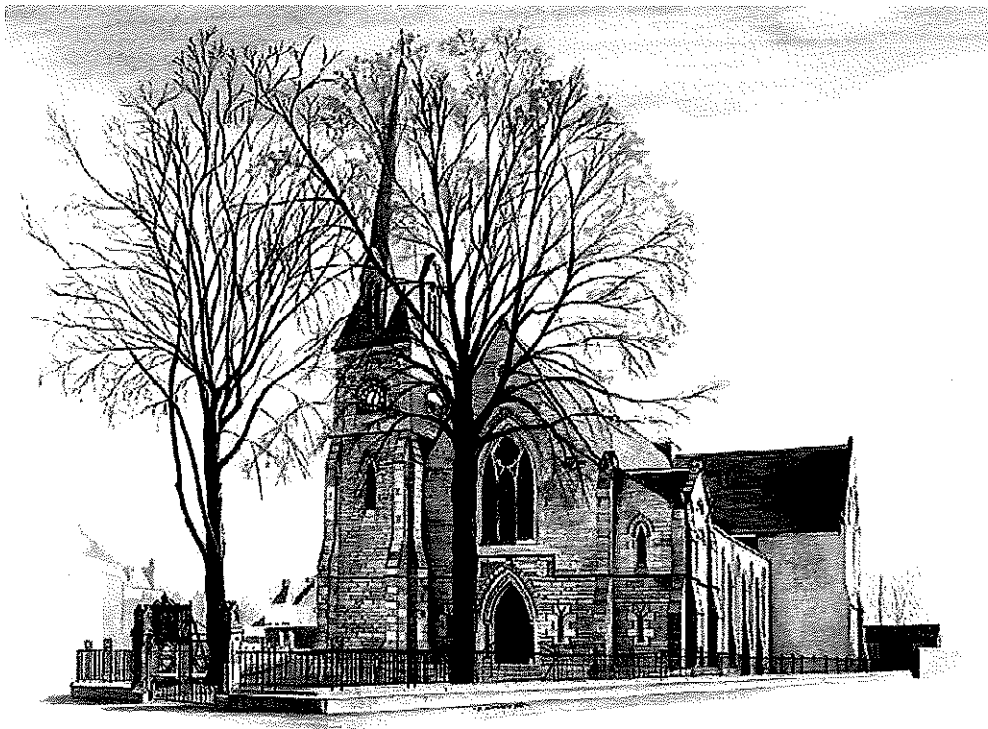

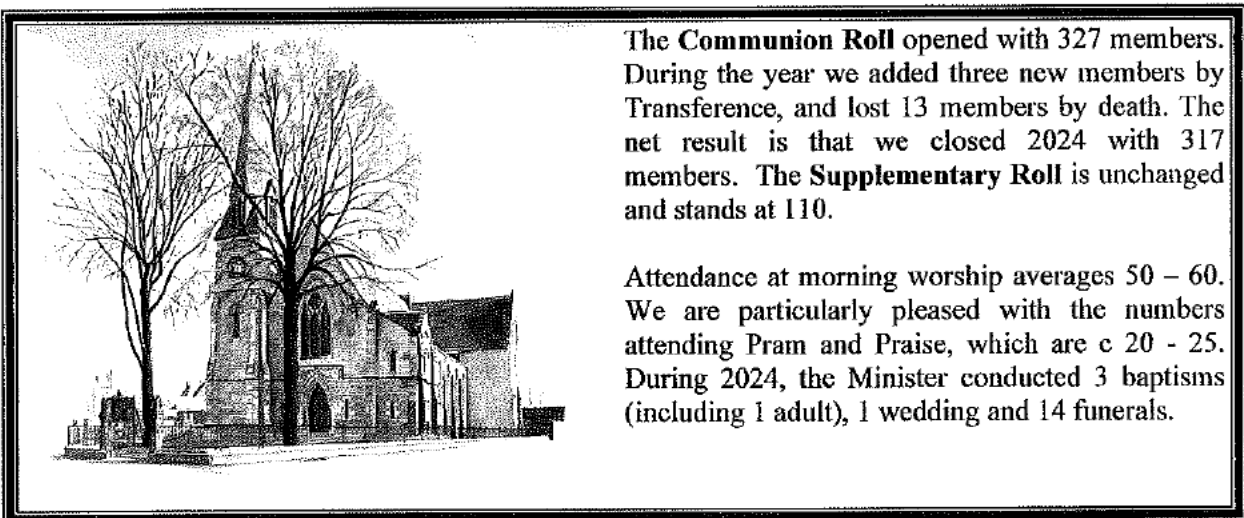



1. Trustees

The Trustees of the Congregation are the Minister and active members of the Kirk Session, ie Elders. They are responsible for leadership, nurturing the spirituality of the congregation and its members, caring for the spiritual welfare of the parish and parishioners, encouraging members to participate in the worship and life of the congregation and promoting mission and evangelism in the parish. Elders are chosen from those within the Congregation deemed to have the appropriate qualities to perform the duties of the office.

The church operates under the Unitary Constitution, where the Kirk Session is responsible for all aspects of church life and witness.

2. Minister's Review of 2024

Friends, we have journeyed through many changes and challenges and we are still here, still worshipping together, still sharing our faith - so well done everyone. Our church has a long way to go in the sense of finding new ways of reaching out into our community. We still need your support, your ideas, and your prayers.

The path towards the union with Burnhead as part of the mission plan continues behind the scenes. Over the coming months we hope that we can have joint worship services, social events together, and pulpit swaps, to enable the friendship and fellowship to begin forming a cornerstone of becoming one church. If you have lost your way of coming to church and you find it hard to come back then be assured of a warm welcome. There is always a place here in this worshipping community. Remember that no matter the reasons of why we come or do not come to church, we gather together to worship God, not the minister, not the people that fills our pews - we worship God. So come to church no matter who you are, or how long it has been.. God is the one who has called you. God is waiting to welcome you home.

As we continue to journey together, remember that this is **your** worshipping community; you are called to be a part of it, so please come and support all that we do, offer to give a hand, be a friendly face, support the work that is happening - and let's be the beacon of hope in this parish, and walk in faith with Christ. 3. Property Matters

The preparation of our Annual Property Report provides an opportunity to reflect on the year passed, as well as a look forward to the year ahead.

At Uddingston Old Parish Church (UOPC), the requirement to maintain the properties and grounds continued, though this last year focused primarily on the works within the Boiler Room. We concluded the exercise with Presbytery in relation to the replacement of the existing church boilers, followed their guidelines in terms of obtaining quotations and the detail of the specification, and so on. We instructed the works in April, with a site start in early June and completion in August. Repairs were carried out to the gas supply pipe in February.

A historical roof leak from the valley gutter was subject to various investigations and tests, before remedial works were undertaken to reroute the drainage above ground. After further on-site tests, the internal surfaces damaged by these leaks, primarily in and around the gent's toilet area and entrance vestibule off the ramp, were prepared and made good. Various fixtures and fittings within the toilets were replaced.

- We replaced the existing corridor lights with new LED fittings; tested the emergency lighting (and replaced the emergency fittings in the side sanctuaries); PAT testing was carried out.
- A CCTV system was installed by a local company, Ferguson Security Services.
- Large TVs were installed within both side sanctuaries; and the decoration of both areas was undertaken later in the year.
- Firepoint carried out their annual maintenance of the fire extinguishers in March.
- The annual servicing/ tuning of the Organ, and piano in the large hall, was also carried out.
- The testing of the ladder providing access within the clocktower was undertaken in October, and a new removable section obtained to comply with recommendations.
- A Lightning Conductor Test was undertaken by Balmore Specialist Contracts in February.

SG and Sons Roofing LLP undertook the clearing of the lower-level perimeter gutters and valley gutters at the start and end of the "growing season"; and repositioned slipped slates, and replaced missing slates, as and where required.

McKay Landscapes continued their good work in maintaining the church grounds throughout the year, and slabbed the area around the Defibrillator. Grow Uddingston added colour and floral variation to the milestone garden, together with the various tubs placed around the church grounds. At the Manse, McKay Landscape undertook the maintenance of the front garden area, together with general garden tidy-ups at the start and end of the season. They completed the replacement of the slabs and ancillary works to the driveway, and the pathway to the front entrance.

Internally, works were undertaken to the master bedroom by way of flooring, plasterwork and then redecoration and a new carpet laid; the kitchen and utility areas were decorated, together with the hallway to the bathroom off the half landing. The EICR works, and the PAT testing of specific items were carried out by the electrician.

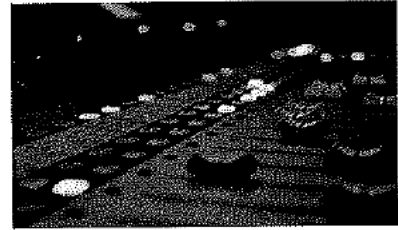
Looking ahead, proposals were prepared to widen the entrance to the car park, and both Planning Permission and Listed Building Consent have been obtained from four contractors, and discussion is ongoing with Presbytery wrt the works.

Time will tell what 2025 holds for us all at UOPC, but I can guarantee that work to the properties and grounds will continue. (Ken Storrier)

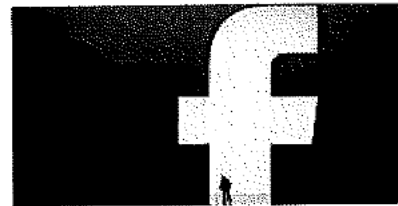


Managed by our Webmaster [REDACTED] the church website is an excellent channel for letting folk within the congregation, parish and beyond know what's happening in the church. It can be found at:

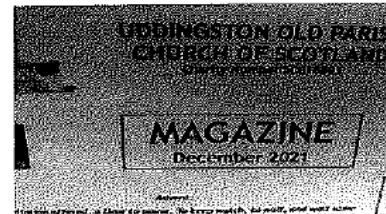

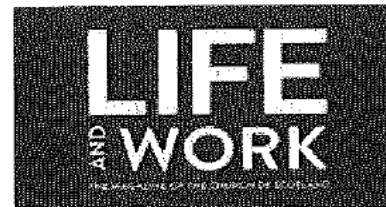

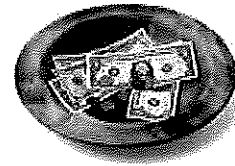

2. Charity Support

Retiring Offerings at Communion Services are donated to charities approved each December (but this may be amended in order to respond to crises arising that require immediate support). These, and other retiring offerings taken in 2024, are as follows:



£1,166 to Christian Aid
£ 165 to Lodging House Mission
£ 272 to Macmillan Cancer Care
£ 218 to St Andrew's Hospice
£ 445 to Wordoff Robins Music
£ 215 to Poppy Scotland
£ 218 to SSAFA Lanarkshire

Our annual Loose Change over Lent collection raised £1,389 for Wateraid. Donations from after-service teas and coffees raised the sum of £1,826 for Glasgow City Mission.

Income of **£5,250** from the William Simmons Bequest was distributed as follows:

- £1,500 to Mary's Meals
- £1,500 to the Sunshine Centre in South Africa
- £1,000 to Kilbryde Hospice
- £ 625 to PHEW (Parental Help Evenings and Weekends)
- £ 625 to the Maggies Centre at Monklands Hospital

During 2024 we continued our long association with the Foodbank, whose aim is to provide an emergency supply of meals to individuals and families who find themselves struggling to put food on the table in times of economic crisis. Any money donations go towards buying in low stock non-perishable food items, toiletries, fresh bread, fresh fruit and veg, fresh eggs, cheese, butter and pet food. In the winter we buy hats, scarves and gloves for our service users.



During 2024 we were able to supply tea and coffee to Church groups and loyal supporters. Thanks to the Guild, Pastoral Care team and Community Café, who promote fairtrade by using our tea, coffee and sugar at their meetings and events. After a gap of a few years, we were able to return to the sale of Christmas cards in support of Transform Trade. This venture was well supported. Thank you to everyone who has supported Fairtrade during this year. (Mima Herd).

3. Pastoral Care and Outreach



The Pastoral Care Team ran two courses this year, a Basic CPR and Defibrillator training course, with 32 people attending, and a Dementia Awareness course with 14 people attending. Both courses were very informative and useful. At Easter and Christmas, with help from several members of the Kirk Session and Congregation, we distributed gifts to 40 members in care homes and those who are housebound.

Pastoral Care also offers transport to church, hospital appointments and visiting in hospital. We also transport people to the Monday Club and the Community Café. Our volunteers have been extremely well-used this year, and at times we have struggled to fulfil the need. We would welcome more volunteers to share the load. A number of prayer shawls have also been given to various members of the congregation and the wider community. We are grateful to all those who take time to knit the shawls and we know the recipients feel comforted and loved. The Twixmas lunch held in December was attended by over 60 people, they were served a three-course lunch by BB Company Section boys and GB officers and girls. The lunch was prepared by members from the community cafe and congregation. Donations of groceries, toiletries and £333 were given to The Lodging House Mission in Glasgow. ()

The Monday Club, continues to go from strength to strength with a varied programme, plus scrabble every week and trips to the theatre and seaside. It is great to welcome people from the local community, local care homes and primary school and witness the intergenerational interactions. The Monday Club also presented a concert in October as part of the 150 anniversary celebrations. This was really well attended and a donation of £450 was given to Nordoff Robbins Music Therapy Charity. (Mary Fox)



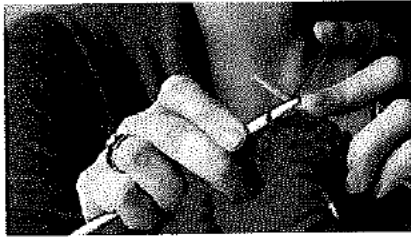
Our Café continues to provide freshly made soups and home baking every Friday for no charge. There is a donation box, and this funds any outlays and allows us to donate to charities. This last year we donated to the following causes: Water Aid, The Lilies Graham Trust, Motor Neurone Disease, Chest Heart & Stroke, Breast Cancer, Multiple Sclerosis, Spina Bifida and Poppy Scotland, as well as donations to Uddingston Old Parish Church to recompense them for the use of the premises.

Usually 40 -50 attendees, and recently residents from Rosepark Home have been bringing residents to join us. George Rodger provides musical entertainment once a month.

Once again, I have to say that the Café would not be possible if it wasn't for the hard work and enthusiasm of the volunteers - thank you all so much. 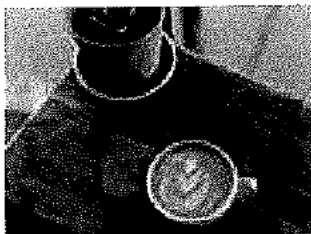
The Knitters Group meet 11-1 on Fridays and are increasing in numbers. Everyone welcome.

Coffee Break: Coffee break continues to meet regularly on Tuesday mornings from 10 – 11.30, in our Godly Play space. This year we have welcomed new faces, parents and carers, babies and toddlers who share in play; and using recently-upgraded Audio-Visual, enjoy a selection of action rhymes. Parents/carers with babies and toddlers, as well as mums-to-be, are welcome on Tuesday mornings to share in a happy, safe and informal space to meet others over tea/coffee.

Coffee, Cake and Colouring-in: We have enjoyed meeting monthly during the year, and many colourful works with intricate patterns have been produced. We relax over a cup of tea/coffee, and share friendship and fellowship. The group meets on the second Wednesday of each month, from September to May. ()

4. Children and Young People

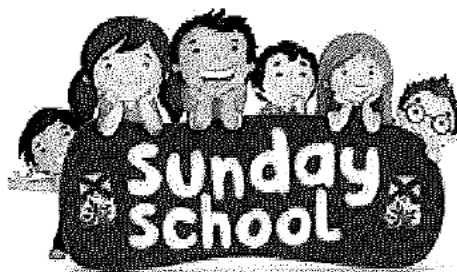
Sunday worship for our young folk and their families



Pram and praise is a style of Sunday worship aimed at families and children under the age of 5. We gather at 10am in the sanctuary with the Sunday school at the beginning of our worship, and then move to the relevant space which for pram and praise is our godly play space. It a flexible space, and often on a Sunday morning can be a busy space. At the moment we have around 20 families

who join us for worship at 10 am. Our young children learn about God and the bible stories using songs, stories, crafts, prayers and a feast. Many thanks must go to [REDACTED] and the team, and [REDACTED] who organises the hospitality aspect. We could do with more helping hands who could lead the stories etc, so if this interests you, come and speak with the minister or join us to see what we actually do... these young people and their families are part of our church just now and it is a blessing to journey with them all as they grow in faith. ([REDACTED])

The Sunday school numbers have increased this year with lots of boys and girls moving up from Pram & Praise. We have 14 regular attenders who have been coming since September. We have been looking at Friends as our theme, and learning who were Jesus's friends. The boys and girls have started to collect their spare change for the WaterAid jars and have been working hard on the nativity. ([REDACTED])



Our current session has seen an increase in membership across both the Junior and Company Sections, with the Company having a roll of c70 boys across all three Sections – together with a complement of 14 staff and helpers. So far this session our boys have enjoyed a trip to laser quest, bowling, Christmas parties, movie nights and a sleepover (Junior Section).

Looking forward into the latter half of the session, we have plans for the Junior and Company Section to visit Pinkston Outdoor Water Centre, which proved a huge hit last session, together with continuing our badge work. All being well, we also hope to be able to present our first Kings Badge in May 2025. The Company's annual coffee morning was also a massive success, with the total raised exceeding £1,400 - our thanks go to the Church, Kirk Session and members for their continued support, not only to this event, but also to the Company as a whole. The numbers in 2024 were – 20 primary school girls; 10 high school girls; 8 staff. Our Juniors took part in our Divisional Netball competition & had a fantastic day out meeting new friends. On World Kindness Day the girls handed out small gifts they had made & organised around the village as their Act of Kindness. The girls & staff have donated 54kg to the food bank. Have donated filled Shoes boxes to the Blythswood Care, all filled with love & care for strangers in need. We had a

trip to Hamilton Town House in December to see the pantomime Mother Goose. Christmas crafts & movie night enjoyed by all. We have two young leaders who are working towards completing their Silver Duke of Edinburgh Award this session. Lots more fun & activities on each & every Thursday evening. ([REDACTED])

5. Adult Organisations



During 2024 the Guild has continued meeting on a fortnightly basis on a Tuesday afternoon, with numbers attending remaining between 20 & 24. We were delighted to welcome a few new members to our numbers. The meetings in the first part of the year began with a recording of 'Highlights from The Annual Gathering of the Guild' held in Edinburgh the previous September. We also had a very professional presentation about the Guild

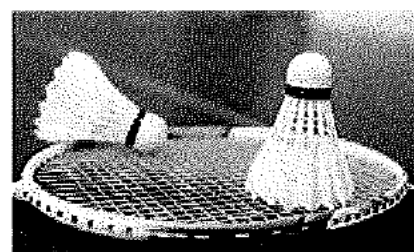
Project 'Home for Good' which we were supporting this year. A representative from the Scottish Charity Air Ambulance came along and gave us an insight into the workings of the charity and also told us about its history. We had our popular 'Afternoon at the Pictures' and held a very successful fund raiser and Daffodil Tea at which we were entertained by the Harmony Singers. We brought the meetings for the first part of the year to an end with a lunch at Angels. In October we began a new three-year Strategy entitled 'Let Us Build a House' with the Theme for the year being 'Sure Foundations'. We heard from our Minister [REDACTED] on the theme, and also welcomed back our old friend [REDACTED] with her talk on Scotland's Greatest Female Explorer - [REDACTED]. We held another successful evening Fund Raiser with Taylor Fashions. We had a return visit from [REDACTED] who gave us an update on the success of the Kazunzu Project in Tanzania sponsored by the Vine Trust. The 2024 session was brought to a close with another very enjoyable and successful Christmas Celebration organised by [REDACTED]. Our grateful thanks to all who have supported the Guild over the past months especially to our Leaders and Committee. ([REDACTED] Secretary)

The Fellowship has been meeting every second Monday since October, when we meet to enjoy a varied and interesting programme, including such topics as "Royal security", "Trekking in Nepal" and many others. We concluded this half of the session with our annual Christmas Dinner at the Angels Hotel, where we enjoyed an excellent meal and a good 'blether'. Our weekly attendance, unfortunately, has been reduced to about 10 to 12 people as age, illness and the very cold weather takes its toll.



A more visual campaign is needed to try to recruit some new members into our ranks for next session. Having said that, the members who do come attend regularly and I thank them for their continuing support. On an historical note, the Men's Fellowship was founded in 1963 and has been meeting regularly ever since, so it is worth the effort to try to attract some new members for the future. The numbers attending the Badminton Club have fluctuated over this session, but we still have enough most nights to enjoy lively games and socializing. 6. Financial Review

It is the Trustees' policy not to hold reserves within the General Fund. Each year is budgeted to break even, and the balance on the General Fund represents the accumulated variance from that budget.

The Fabric Fund is a reserve fund to cover major repair and improvements to the Church buildings, Halls and Manse.

The Sunday School and Guild Funds represent the working accounts maintained by these organisations.

At the year end the Church held unrestricted funds of £56,482 of which £62,984 had been designated for Fabric Fund and £3,152 for the Sunday School and £2,063 for the Guild. The small deficit on the General Fund of £17,287 is deducted from the other funds in arriving at the unrestricted funds total. This represents less than two months income or expenditure.

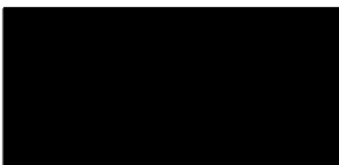
The church also held £40,196 of restricted funds which have been provided for the purposes specified in Note 13.

Charity law requires the trustees to prepare financial statements for each financial year which show a true and fair view of the state of affairs of the charity and its financial activities for that period. In preparing those financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently
- make judgments and estimates that are reasonable and prudent
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements; prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operational existence

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

6. Independent Examiner's Report to the Trustees

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 14 to 28.

Respective responsibilities of trustees and examiner

The charity's trustees consider they are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

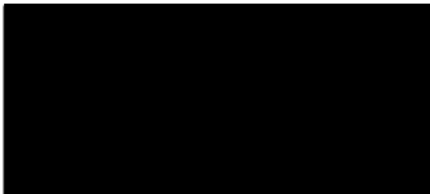
Basis of independent examiner's statement

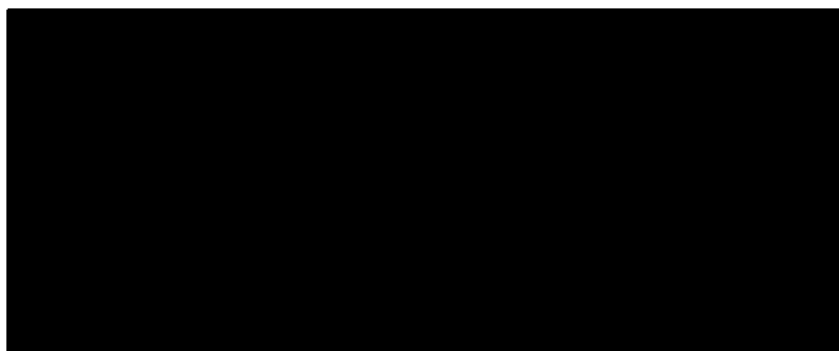

Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

Basis of preparation

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2015, the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended)

Funds

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income therefrom is used for the purpose defined in accordance with the objects of the charity. Unconditional bequests are treated as endowments until their allocation is determined by the Trustees in line with the charity's purposes

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Incoming resources

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Accounting Policies (Continued)

Tangible fixed assets

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Church, halls and manse, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the statement of financial activities in the period in which the liability arises.

All tangible fixed assets costing in excess of £5,000 having a value to the charity greater than one year, other than those acquired for specific purposes, are capitalised. Depreciation is provided on a straight-line basis to write off the cost or initial value, less residual value, of tangible fixed assets over their estimated useful lives:

Investments

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year. All investments are with the Church of Scotland Investment Trust therefore ensuring that they are professionally and ethically managed. Our aim is to ensure long term growth in both value and income to provide to protect against the effects of inflation. While there can be short term hiccups due to international events, in the longer term this strategy is being achieved.

Taxation

Uddingston Old Parish Church of Scotland is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.
