ACTIVITIES

Again, applicants whose submission had some potential merit did not take up our offer of support and mentorship to improve the quality of their proposed work. The amount of quality GI research undertaken in the hospitals has been reduced due to service modification, and therefore this did not meet the criteria for which the benefactor established the trust. The trustees feel that they need to reconsider the aims of the trust, and we have arranged a meeting to review our approach and discuss options.
