Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Unitary Deed of Constitution.

Recruitment and Appointment of Trustees

Under the terms of the Unitary Constitution (UC) all the affairs of the congregation are dealt with by the Kirk Session and only the elders are the legal Charity Trustees of the congregation.

The Kirk Session members are the elders of the church and are chosen from those members of the congregation considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by the Presbytery.

Organisational Structure

The Kirk Session, which meets nine times a year, has 15 active Elders (8 male and 7 female). During the year Dickson Jacobs submitted his resignation as an active Elder due to his relocation away from Glasgow. In terms of the Basis of Parish Grouping, agreed during 2021 with the constituent congregations of Knightswood Anniesland Trinity (KAT), elders of both congregations have met during the year in Council to make joint policy decisions.

Objectives and Activities

The Church of Scotland is Trinitarian in Doctrine, Reformed in Tradition and Presbyterian in Polity. It exists to Glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national church, it acknowledges a distinctive call and duty to bring the Ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other churches in various ecumenical bodies in Scotland and beyond.

In addition to Sunday morning worship at 11am in our Sanctuary, the service continues to be made available on Zoom for the benefit of those who are too frail to attend or who are still reluctant to attend in person due to the continuing impact of Covid. Zoom is available both online or by phone and while there is a steady core of 3/4 people telephoning in weekly, the number online fluctuates from none to potentially 4.

Weekly prayer meetings, involving members of both St David's and KAT congregations, have also continued on Zoom and are valued by those attending.

The number of younger children and teenagers attending St David's continues to decline. There are currently no Sunday groups running for these age groups although any younger children attending are encouraged to join together at the front of the church during the service where a worksheet is provided for them to complete and/or colour in.

The Thursday afternoon Coffee Group set up in 2022 continues to be well attended and is much appreciated by all those who come along for coffee, biscuits, and a chat.

The 'Thy Kingdom Come' Prayer initiative was run between Monday 22nd and Friday 26th May when the church was open on six occasions to allow people to come in and use the material made available to pray for the needs of people in our Community, our Country and around the World.

The English Class, for asylum seekers and refugees living within the community and which had to be stopped due to the Covid pandemic, has restarted in the Church Halls on Friday mornings. Unfortunately,

the re-starting of the crèche and fortnightly shop, which previously ran alongside the English class, was not practicably possible. This class is much welcomed and appreciated by those attending.

The Discipleship Group continues to meet fortnightly, except in the summer months. There are two healthy groups meeting: one in person in the church hall in the afternoon and the other by Zoom in the evening.

During Holy week, joint services were held with KAT on Maundy Thursday and Good Friday, as well as an early morning service in Knightswood Park on Easter Sunday, which was followed by breakfast in the St David's Church Hall. An Advent Sunday joint service was held on 3rd December where we shared the sacrament of Communion. Other joint services were held in March, where a retiring offering was taken for the work of Comfort International, and in August for Souper Sunday. Elders from both congregations were involved in leading worship at the Souper Sunday service for the Church of Scotland HIV Programme which was followed by a soup and sandwich lunch prepared by members of both congregations. In addition to the joint Services, there have also been a couple of occasions where the ministers of St David's and KAT have undertaken a pulpit exchange and led worship in their counterpart's congregation. St David's continues to share in joint services with the six other denominations in the Knightswood Fellowship of Churches, although these have been reduced in number for the current session.

The WhatsApp Fellowship Group has continued to enable members to keep in touch and provides a conduit for sharing information and encouragement with each other.

The following lets continued to meet in our premises: Badminton, Line Dancing, Narcotics Anonymous, Brownies and Disabled Guides. The halls have also been let out for a number of private functions throughout the year. Our Outreach group has restarted film nights, followed by a meal, to bring people together. The all-age congregational Christmas Party also resumed in December, to which members of the KAT congregation were invited. This was well supported by members of the congregation who enjoyed a varied programme of entertainment during the afternoon.

Due to structural problems within their Anniesland Campus, Clyde College approached us for a let to run from 8th February to 31st March, to facilitate the running of several classes. This let was beneficial to both parties and led to a further let of our premises by Clyde College to run three coffee mornings as part of their Gateway to College course.

Achievements and Performance

During 2023 our Membership numbers continued to decline, due to 5 deaths, while 1 new member was added to our Roll during the year by Kirk Session Resolution. There are 125 members on our Membership Roll plus 14 Adherents.

In early 2023 a Mission Team was set up within St David's to explore potential for future outreach within the community. This could mean serving community organisations by renting them accommodation or it may also involve initiatives which we take ourselves to serve particular groups identified in the community audit. We are currently developing our ongoing relationship with Linkes and looking for other potential community groups to engage in conversation. Whatever initiatives are taken, these should build friendships and relationships between members of the United congregation and those beyond our walls, in the hope of creating pathways into faith.

Offerings of members have remained remarkably stable over the year, reflecting a high level of commitment by the worshipping congregation. Monthly offerings for world causes, in which the congregation has an interest, were resumed following Covid restrictions with offerings taken up for Scripture Union Scotland, Christian Aid Week, the annual Harvest offering for Tearfund and the Christmas Lodging House Mission appeal for Glasgow's homeless. An additional offering was also taken up to support the Disaster Appeal following the Turkey/Syria Earthquake.

At the Parish Grouping Council (PGC) meeting on 15th February 2023, it was agreed that the existing World Mission teams of the two congregations would join to constitute a single World Mission Team.

This team has met subsequently to progress consolidation of work being done by the two individual congregations. Additionally it was decided, and approved by the PGC, that the twinning, which had been proposed previously between Temple Anniesland and the congregation of St Saviour's, Sukkur in Pakistan, should be progressed by KAT.

The PGC has met regularly to discuss and consider the difficult decisions to be made affecting governance, worship and life of the congregations. During 2023 the main drive has been on which of the three buildings should be retained by the joint congregation going forward. Following considerable debate on the merits of each of the buildings, a congregational vote was held in March to determine which would be retained and which disposed of. Unfortunately, no clear decision was reached following the vote. While both St David's and KAT voted in favour of retaining the St Margaret's building and disposing of the Anniesland building, the margin in favour was very narrow in the KAT congregation. Because of the closeness of the vote, and approaches made by a few individuals with concerns relating to the vote, Presbytery arranged a further series of meetings with the PGC to discuss the way forward. It was agreed during these meetings that it was unlikely that re-running the vote would obtain a clear result, and attention was turned to exploring the alternative option of seeking arbitration. Presbytery outlined to the PGC the idea of an independent group making decisions about the buildings, culminating in a formal document called the Scheme of Delegation being produced for approval. At the PGC meeting on 23rd August 2023 no objections were raised to putting the scheme before the congregations for a congregational vote on 10th September. Following meetings of both congregations on Sunday 3rd October, to allow members to ask questions about the proposal, the vote went ahead on the 10th September and was approved by both congregations. The vote was confirmed by Presbytery at their October meeting with a team of three people selected to undertake the task of reviewing all existing documentation and speaking to both congregations. A time scale of 6 months has been set for this task to be completed and a proposal put to Presbytery by the team. It is anticipated that this will be brought before the May Presbytery meeting for approval.

Trustees' Annual Report Cont 2023. Financial Review

Financial Review

Our principal source of income is from Members offerings. The total offerings (Freewill and Gift Aid) were down from £47756 to £42146, a decrease of £5610, which is still a very good performance. Tax recoverable from Gift Aid was down by £3194, from £12262 to £9068. We ended the year with a very small deficit, but we have to take into account, a Legacy of £54733, which masks the true picture.

Reserve Policy . Funds Held. Unrestricted £11149, Investments £63151, Restricted £15723.

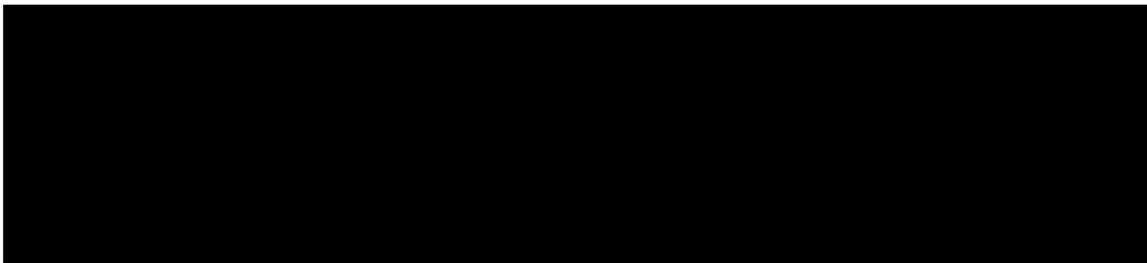
Basis of independent examiner's statement

for the year ended 31 December 2023

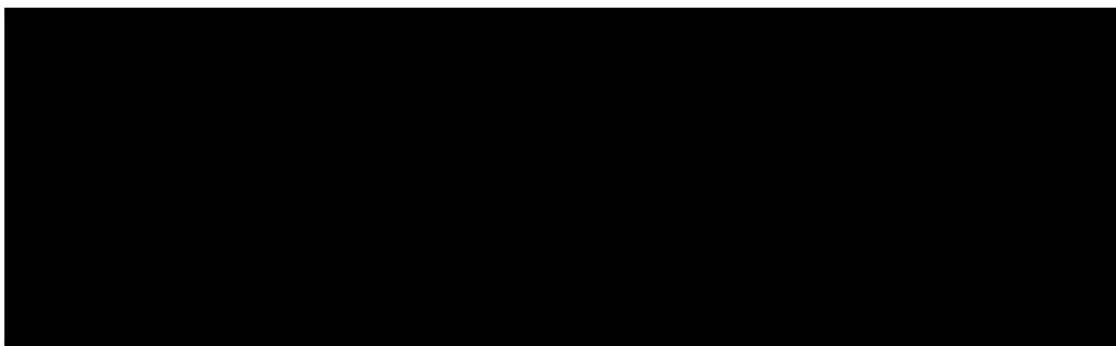

6. Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £30,135 and the maximum stipend (in the 5th and subsequent years) £37,032.
