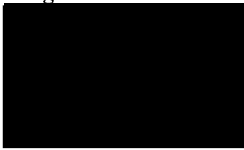

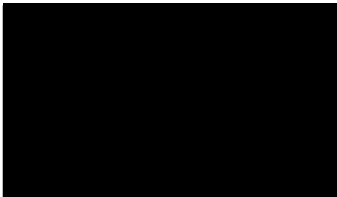

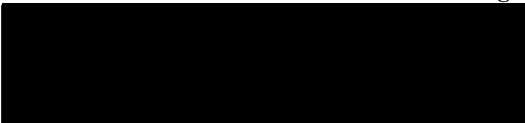
Trustees Review of the year

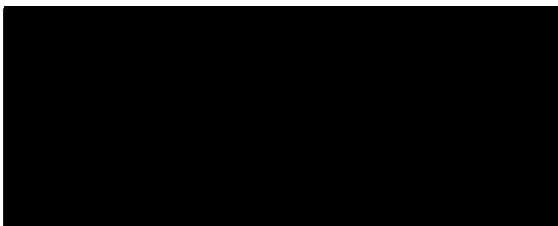
