Summary of the main activities in relation to these objects

The focus of our activities over this year has been directed towards the sale of the Land and Buildings.
This year has perhaps been the most difficult in our history.
Having secured a Buyer in September 2025, with a verbal agreement to purchase, the Buyer's Solicitor has created delay after delay, resulting in ongoing overheads with no opportunity to generate income from hiring out Halls etc.
This year no Group or Individual approached, or was identified by the Church for Benevolence.

We provide monthly support for our own local Evangelist [Minister] to help enable him and his family to work with the Glenrothes Congregation in promoting the Christian Faith, although this support has been sporadic.

During this financial year our main achievement has been to keep the doors open for Worship and Fellowship.

Since the Summer of 2025 our desire to provide facilities for the Community has been curtailed by the week to week uncertainty over the future of the Building.

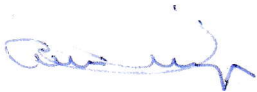
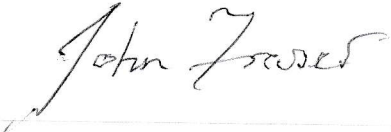
