Structure, governance and management

Type of governing document

The charity is an unincorporated association and is governed by its adopted constitution. The charity, while totally independent, is a chartered member of British Youth for Christ, an umbrella organisation which provides support and guidance to all Youth for Christ centres throughout the UK.

Our constitution is currently in need of a full review and refresh. It is intended to do this as soon as practicable.

Under the terms of the charity's constitution, the trustees are responsible for the governance and strategic direction of the charity.

Though not eligible to vote, our Youth Worker is normally invited to attend Board of Trustees meetings to provide input relative to the Charity's front line youth work.

Trustee recruitment and appointment

Potential trustees are identified by or to the Executive Committee and a completed volunteer application form is received from the prospective appointee. An initial interview is carried out by a member of the Committee and if the outcome is favourable, references and PVG checks are carried out.

Following the favourable completion of such checks, a recommendation is made to the full Executive Committee. Only after the approval of the full committee will the appointment to the Committee be made.

Under the charity's constitution, there must be a minimum of five and not more than nine elected trustees. Meetings and proceedings may operate with a quorum of three members of the Trustee Body.

It has proved extremely difficult to identify and recruit additional Trustees. As such our Board is operating below the required number of Trustees. It is not felt however that this has had a negative impact on the governance of the Charity. All decisions made and the day-to-day governance is routinely and accurately documented.

Objectives and activities

Charitable purposes

The advancement of religion, the advancement of citizenship or community development and the advancement of public participation in sport, primarily among children and young people.

Where necessary we partner with other charities and agencies.

Summary of the main activities in relation to these objects

The charity's primary focus area of operation has been within the Tillydrone area of Aberdeen. Indications are that the activities focus may change in mid to late July 2025.

While the area demographic continues to gradually change, it remains an area impacted by relatively high levels of unemployment, low income, a general lack of amenities, coupled with drug / alcohol abuse. This in turn has a knock-on impact on the children and young people of the area with whom we work.

The charity has employed full time Youth Worker whose primary role has been the oversight, provision (with the help of volunteers) and expansion of personal support (peer discussion/activity groups, one-to-one support, social and team skills etc); mentoring and sports (football training, PANNA Cage football, five-a-side football, outdoor games sessions); group teaching and discussion on Christian faith and practice; for young people within our local area. Attendance at all activities by young people is entirely discretionary on their part.

Achievements and performance

Summary of the main achievements of the charity during the financial period

Throughout the year we continued to experience a high level of interest and engagement from young people and school teaching staff, towards the groups and activities we are involved in.

The young people value the opportunity of having safe spaces where they can chill out and have fun with their friends and peers and also to access the personal support and one-to-one discussions available to them.

Attendance at groups and activities has remained steady and with some activities has grown. Our relationship with the staff and pupils of our local primary school has remained strong.

Financial review

Brief statement of the charity's policy on reserves

The charity's reserves are currently held in three bank accounts in place with The Bank of Scotland.

Outwith pre-approved running costs, no major expenditure can take place without the prior approval of the Board of Trustees.

Strict control is kept of all funds, with a financial update being provided by the Treasurer at the monthly Board of Trustees meeting. Financial records are audited annually by an independent auditor.

Our core funding currently comes from regular personal donations, church support and a charitable foundation. Funding has remained relatively stable throughout the year.

Details of any deficit

A small deficit of £58 was recorded at the end of the 2024 financial year. This is an improvement on the previous year.

Office accommodation and building facilities within Tillydrone is made available free of charge by The Lighthouse Support Centre.

Donated Services Provided by Charity

All of our activities within our focus area are provided free of any charge.

Other optional information

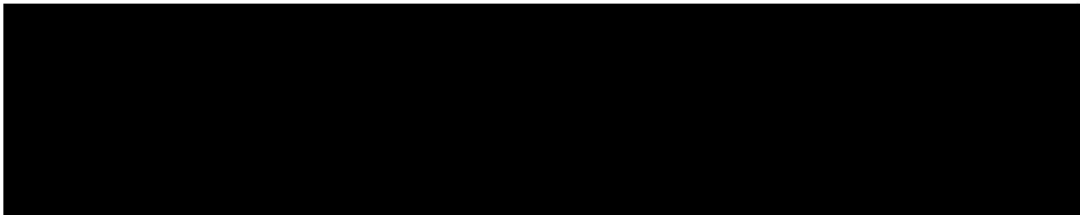
