Objectives and activities

Charitable purposes

To actively engage and support young people in their personal development, empowering them to make a positive contribution to society. Young people work in partnership with adults; work together based on the values of Scouting (Integrity; Respect; Care; Belief; and Cooperation); enjoy what they are doing and have fun; participate in indoor and outdoor activities; learn by doing; share in spiritual reflection; take responsibility and make choices; undertake new and challenging activities; and make and live by their promise.

Summary of the main activities in relation to these objects

The main activities of the Scout Group were providing fun, challenge and adventure to young people through a balanced program of activities, events and experiences based around subject areas we call Program Zones, starting in the Squirrels (age 4-6 years) and continuing through Beavers (6-8 years), Cubs (8-10 1/2 years) and then to Scouts (10 1/2 -14 years) by way of indoor and outdoor activities, weekly meetings and adventurous activities including camps in Scotland and abroad, allowing young people to progress through the Program Zones and record their achievements.
Scouts and Explorer Scout Young Leaders also enrolled in the Duke of Edinburgh (DofE) Award Scheme. Young Leaders volunteering in the Scout Group qualified for the Scottish Government's Saltire Awards.

Achievements and performance

Summary of the main achievements of the charity during the financial period

During the year a surplus has been recorded of £14,121 reflecting the continued high levels of membership across all the Sections during this year. The Charity has also benefited in the year from generous Donations, the return of fund-raising events and the Gift-Aid claims for prior years having been received.

The successful recommencement of fund-raising events at the Scout Centre in November 2024 was well attended by members and families but also members from the local community.

Continued improvement program for the upgrade of the Scout Centre has commenced, with focus on immediate repairs and assessment of the electrical circuits and heating systems. The essential maintenance and refurbishment of Scout Centre is paramount to the activities of the Charity.

A Safe Scouting Premises Audit and Risk Management Register was set up following the guidelines issued by The Scout Association.

Young people gaining Chief Scout's Awards and Duke of Edinburgh Awards. All sections of the Charity returned to a full schedule of events during 2025 with all attending outdoor camps.

The number of young people attending all sections has increased during this year with a waiting list in place for all sections. The Committee and Sections continue to look for new volunteers to continue the success of the Charity.

Financial review

Brief statement of the charity's policy on reserves

The funds represent income earned but not yet utilised in supporting charitable activities. At 31 March 2025, the charity held £68,581 at the bank including £2,611 held by the Beaver Sections; £5,846 held by the Cub Sections; and £7,559 held by the Scout Section. Gift Aid of £4,000 is due to be claimed from HMRC for the financial year.

Ongoing development, maintenance and repairs of the Scout Centre can be significant, and the Trustees have decided to hold a Reserve Fund of £25,000, now classified as a Restricted Fund, on a 95 day notice with the bank. The Trustees will review the amount held annually but consider this to be appropriate to meet significant financial repairs to the property such as:

(a) maintenance and repair of part of the roof of the building which is flat;
b) Electrical Installation and Condition Report (EICR) mandatory testing and inspection of circuit boards, wiring and electrical accessories, works have commenced but will continue through 2025.

The reserves policy maintained is compliant with the guidelines provided in the Charities Accounts (Scotland) Regulations 2006 (as amended).

The Trustees did not receive any remuneration or expenses from the Charity during the year and are not paid any expenses for attendance at meetings.

The reimbursement of expenses is restricted to receipted expenditure incurred on behalf of the Charity.

Other optional information

The Scout Group, established in 1909 and part of Scouts Scotland, is a voluntary uniformed youth organisation. The Group has been twinned with a Norwegian Sea Scout Group, near Stavanger since 1977 and since 2015 has partnership agreements with 3 schools in Gomel, Belarus. Stavanger and Gomel are 2 of Aberdeen's twinned cities.

As at 31 January 2026, the membership of the Group was 207 youth members and 49 adult volunteers, in 2 Beaver Scout Colonies; 3 Cub Scout Packs; and 1 Scout Troop. A waiting list exists for those of age to join the appropriate sections, this currently sits at 19 for Squirrels, 36 for Beavers, 16 waiting to join Cubs and no currently waiting to join Scouts. The Trustees have reviewed and are supportive of extending the Charity activities to include the commencement of a Squirrel Colony in 2026.
