Fife: Forthview Parish Church of Scotland Report of the Trustees

The trustees present the annual report and accounts for Fife: Forthview Parish Church of Scotland (formerly Dalgety Parish Church of Scotland) for the year ended 31 December 2024. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations on Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland effective from 1 January 2019.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. Our mission is to *"encourage people to follow Jesus Christ"*

Mission Statement

Our church and our people aim to look after Forthview members, responding to their worship needs, and to spread God's word together. We will reach out and take God's Word and His Work to all in our communities and treat people with love and respect. We aim to build Christian foundations for young people and create an environment in which all can learn of God's work.

Vision

Our vision is of Fife: Forthview Parish being a Christian Church with a meaningful relationship with the community, helping enrich everyone's relationship with God, and offering our ministry for all age groups.

Objectives

1. To develop a Ministry Team that shares our Vision for Forthview Parish.
2. To use our collective talents for team ministry (including our congregations) to achieve our Vision.
3. To increase our worshipping congregation, building from five separate congregations to one engaged and active Forthview congregation.
4. To be visible seven days a week.
5. To be part of community life and events.
6. To recognise and respond to injustice (deprivation, poverty, loneliness, and other hidden needs in our communities).
7. To create a resilient church community through engaging new and different people, and assisting them to find a purposeful place, building skills and confidence through our church's activities.
8. To care for our world through attending to our local environment.
9. To be known for our positive role and relationship with our communities.

2024 Overview – Achievements and Performance

1. Establishment of the United Congregation and Ministry Team

On 1 January 2024, Fife Forthview Parish Church came into being as a combination of the following Legacy Parishes – St Fillan’s Aberdour, Dalgety, Inverkeithing, North Queensferry and Rosyth. On 20 January 2024 the Service of Union was held by Presbytery. This formal beginning of a new union allowed the start of the calling (recruitment) of Ministers. The Presbytery Plan stated that three Full-time Ministers of Word and Sacrament could be called. A nomination committee, representing the whole congregation, was elected and recruitment of the Ministers was put into motion. The three ministers were recruited to work within a Team Ministry setting, covering the five legacy parishes. [REDACTED] preached as Nominees and were both elected as Ministers Elect in November 2024, for the Ministry Team. A third applicant [REDACTED] was confirmed as a Nominee at the same time. [REDACTED] would preach in 2025. [REDACTED] was inducted on 12 January 2025, [REDACTED] on 19 January 2025 and [REDACTED] on 11 April 2025.

2. Ministry and Worship

During 2024 the congregation of Fife: Forthview were in Vacancy with [REDACTED] continuing to serve Inverkeithing and North Queensferry and providing Pastoral Care for Inverkeithing, North Queensferry and Dalgety (January to August 2024) as Associate Minister. In September 2024 [REDACTED] took over this role. [REDACTED] was Locum Minister for Rosyth and provided Pastoral Care for those in Rosyth. St Fillan’s Aberdour and Dalgety experienced a great range of Ministers providing Pulpit Cover on Sunday Mornings, thanks to a combination of regular and visiting Ministers, Readers and the Worship teams from both communities.

In the lead up to Easter, Lent Studies were held in Dalgety and North Queensferry buildings. Ecumenical Lent Studies were held, via Zoom, by Rosyth. A Quiet Day during Lent was also offered, as well as a Holy Week reflection area within Dalgety.

Holy Week Services were conducted in each of the churches being led by [REDACTED]. [REDACTED] Easter Day services were held across the Parish, with Morning and Evening Worship also included.

On Remembrance Sunday a 2 Minute Silence was held across the Parish. The Royal Naval Association, Rosyth and West Fife, attended the Inverkeithing Service of Remembrance, Dalgety held a Parade and outdoor service with the uniformed organisations. St Fillan’s Aberdour held a communal Act of Remembrance at the War Memorial on 11 November and a full Remembrance Service on 10 November in the Church Hall. This was a joint Service with St Columba Church Aberdour and was well attended by both Churches and the Community. [REDACTED] was invited to take the Remembrance Service at HMS Cochrane which was attended by Naval and Civilian personnel.

During 2024 a variety of services were provided: Sunday Morning, Café Church, Messy Church, Monthly Mid-week Communion Services, Communion within a Sunday morning service – at least 4 times per year. Christmas Eve and Christmas Day Services were held across the Parish.

Prayer Groups meet regularly during the year.

Services at Dalgety are live streamed each week and a DVD/CD produced and delivered to those who are housebound.

90 P7’s joined in the Easter Code event from two Primary Schools within Dalgety, where the event allows a chance for young people to hear and ask questions about the events of Holy Week, Jesus’ Ministry and why Easter is important to the Christian faith. This was led by [REDACTED] and a team of Volunteers.

2 Ministry and Worship (continued)

All P6's from both Primary Schools heard the Christmas Story and took part in related activities at a Bubble Gum and Fluff event held in Dalgety in December.

A Service at Henderson House continues to take place on a regular basis, twice each month. There is also a service at Dalgety Bay Care Home monthly. Services at both locations are led by the [REDACTED]

Our Church of Scotland Guild Group continues to meet twice monthly and their member numbers continue to rise, with new faces from the congregations joining in. A varied programme is offered, and they continue to raise funding for the Guild projects.

Across the Parish, there were 6 Weddings, 41 Funerals, 4 Baptisms including 1 Adult Baptism and 2 Blessings of Children.

The Congregational Roll had 1,051 members and 74 Adherents at 31 December 2024.

3. Stewardship and Community Outreach

There is a Foodbank, under the auspices of the Trussel Trust, in Rosyth three times weekly run by volunteers from the congregation and others. Food donation boxes are also located in Inverkeithing, Dalgety and North Queensferry buildings.

St Fillan's Church is open to the public on a daily basis all year round. St Fillan's participated in Open Doors in 2024, welcoming 211 visitors over two days. The Annual Aberdour Flower Festival was held in St Fillan's for the first few days as part of the Aberdour Festival. Inverkeithing is now open to the public every Tuesday until 1pm and also took part in Open Doors in 2024. The Annual Inchcolm Pilgrimage from Aberdour took place in September.

St Fillan's have a Family Fun Team who held events at Easter, in the Summer and at Advent with a total of 40 primary school age youngsters participating. They continue to have a good relationship with the local primary school. Inverkeithing ran a Lego Club for young people from the community during the Summer holidays.

All areas across the Parish hold regular weekly or monthly Coffee mornings which are very well attended. There are monthly talks/film shows held at the Rosyth Coffee afternoon. McMillan Cancer Care Coffee Mornings are held annually. A Coffee Morning is held once a month in Friary Court, Inverkeithing. Fairs and Lunches are held regularly across the Parish and are well advertised and supported. All events are open to all.

Christmas Cards are delivered by St Fillan's to every house in Aberdour and to members out with the village.

4. Pastoral Care

Pastoral Care was provided by the Associate Ministers and Ministry Team as well as Elders in each of the areas of the Parish. Dalgety also have Bereavement Group volunteers. Their Bereavement Group continues to meet twice per month.

Flowers are delivered weekly to those in the Community.

5. Communications

A weekly Order of Service is now produced by the Fife: Forthview office for Aberdour, Dalgety, Inverkeithing and North Queensferry. Rosyth produce their own Order of Service and this is also emailed out weekly to those who are housebound and those who have requested this by email.

Each worshipping community in the Parish have their own Facebook page which gives up-to-date, relevant, information.

A website was required as a priority to host the Parish Profile and provide a common site for the five churches. It was designed and created by members of the five churches and went live on 7th May with the inclusion of the Parish Profile. The Rosyth website was integrated into the Fife: Forthview website in August, Inverkeithing in October and North Queensferry in November, St Fillan's will be integrated in January 2025 with Dalgety following later in 2025. The usage has gradually increased and over 2024 there have been 7.5K page views and 2.2K active users. These numbers will increase significantly once St Fillan's and Dalgety websites are integrated into the Forthview website. During 2024 the website had active users from 40 countries, including 74% from the UK and 13% from the US, followed by Germany, Ireland, and China. Most users access the website from a mobile phone (56%).

6. Financial Review

The Charities of St Fillan's Church Aberdour, Dalgety Parish Church, Inverkeithing Parish Church, North Queensferry Church and Rosyth Parish Church were united into Fife: Forthview Parish Church on 1 January 2024. Dalgety Parish Church's Charity Number SC020926 was retained for the United Charge and the ceasing Charities were deleted from the OSCR Register from that date.

The union has been accounted for using the acquisition method. This means that the funds transferred from the ceasing congregations are disclosed as the 'Transfer of union balances' under 'Other income' within the Statement of Financial Activities. The comparative figures in the 2024 Accounts are those for Dalgety Parish Church only.

Total income for the year was £813,550, including £399,510 transfer of union balances. Total expenditure was £510,284. This resulted in a surplus of £303,266 before gains on investments but a loss of £96,244 excluding the union balances.

Donations and legacies of £233,406 account for 57% of total income excluding union balances. There has been a decrease in regular giving of approximately 8% compared to the combined totals of all five churches in 2023. This is not unexpected during unions, particularly when all charges are vacant, but the demographic of the congregation is also contributing to a gradual decline in regular income, as noted in the Reserves Policy.

Income from use of Church Premises, Equipment and Halls was £62,328, 15% of total income excluding union balances. This is a good source of income across the congregation and also an important feature of Community Engagement, as are the various cafes and fundraising events which take place regularly in all locations. £19,133 was raised from these in 2024.

6 Financial Review (continued)

Restricted income includes £12,500 grants from the Presbytery Mission Fund to support Youth Work and Bereavement Projects which will progress in 2025.

£50,582 was received from the General Trustees, drawn down from the funds held by the General Trustees in the Consolidated Fabric Fund. This covered the Inverkeithing Church Stonework Projects and other Fabric Expenses. Rental income from the Inverkeithing / North Queensferry Manse which is credited to the Consolidated Fabric Fund revenue account is helping to fund the very significant energy charges at Inverkeithing.

Total expenses for the year were £510,284. This compares to £372,353 for all Churches combined in 2023. All categories of expenditure were higher than 2023. The most significant components of expenditure were: Giving to Grow Contributions, £143,270; Building Costs, £237,249; and Salaries, £42,213. Building Costs included a number of significant property projects – the replacement of a moveable partition wall in Dalgety Church, manse maintenance and refurbishments prior to the appointment of new Ministers, and essential repair and maintenance work across all locations. These costs were partly offset by caretaker donations for the manse in Aberdour and savings in Manse Council Tax. The property projects were funded from Designated or Restricted Reserve Funds as appropriate. Heat and Light charges within the General Fund were 75% higher than 2023 reflecting a 98% increase in electricity prices in October 2023 and 103% increase in gas prices from March 2024.

7. Investment Policy and Performance

It is the Trustees' policy to place surplus funds in Savings Accounts with the Banks and with the Church of Scotland Investors Trust to enhance Investment Income. Reserves for long term liabilities are invested in the Trust's Growth or Income Funds, and cash likely to be needed in the short to medium term are placed in the Trust's Deposit Fund.

Dalgety's units in the Growth Fund were sold during the year to generate cash for their property projects. 5,003 units were sold at a unit price of £6.40, realising a gain of £2,852.

At 31st December 2024 1,190 units, with a market value of £7,592 were held in the Growth Fund. 4,355 units with a market value of £48,167 were held in the Income Fund.

8. Risk Management

The Trustees have prepared a Risk Assessment document which considers the potential risks faced in various elements of congregational life, including finance, property, health and safety, the church as an employer, and its management and governance. The document incorporates a mitigation strategy and the relevant containment actions. The contents of this document will be reviewed in detail when the new Ministry Team is in place and all operational groups are formalised.

9. Reserves Policy

The charity Trustees have considered the reserves required taking into account current and future liabilities, potential financial risks and the current economic environment. The Policy has been updated to reflect the requirements of the united congregation. General and Designated Funds from all churches have been combined where their purpose and objectives were the same.

The key components of the Reserves Policy are:

Working Capital of approximately £50k is needed to maintain operational liquidity day to day – for Giving to Grow payments, utility bills, salaries, office costs and routine fabric maintenance etc. This is held in the General Fund.

The **Designated General Reserve Fund** is to provide adequate cover for loss of income or additional expenditure due to unforeseen circumstances, and gradual loss of income due to concerns about the demographics of the organisation. Approximately 3 months general fund expenditure is currently held for this purpose based on the 2025 budget. At December 2024 an additional amount has been set aside as contingency for loss of regular income from standing orders not yet transferred to the United Congregation Bank Account.

The **Designated Fabric Fund** is to provide cover for non-routine fabric expenditure. This fund together with the restricted repairs funds and funds held by the General Fund Trustees should address the major fabric risk.

Priorities for 2025

The immediate priority for 2025 is the Induction of the Ministry Team. Rev Andrea Fraser, who will be based in Aberdour and Dalgety, and Rev Sarah Smith, who will be based in Rosyth, will be inducted in January 2025 with the Rev Elané Sassenberg, who will be based in Inverkeithing and North Queensferry, being Inducted after her Maternity Leave finishes.

Once the team are in place they will be working with the Trustees and congregations to identify their short term, medium term and long-term goals for Fife: Forthview and the worship and pastoral needs of the whole Parish.

We will be working to have stronger relationships with local schools, particularly the new High School in Rosyth, the Naval Establishments and other organisations within the Parish.

Dalgety plan to relaunch a Sunday School which folded due to Covid and the Ministry vacancy. Rosyth have a small Sunday School and they plan to work on increasing the numbers.

Inverkeithing and North Queensferry will be starting up some new activities and projects for the community such as a Bible Study, music groups and support groups.

Structure Governance and Management

The congregation is a charity registered in Scotland, number SC020926 and is administered in accordance with the terms of the Model Deed of Constitution (Unitary Form)) and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The ministers, who are members of the Kirk Session, are elected by the congregation and inducted by Presbytery.

The Kirk Session is chaired by an Interim Moderator or Moderator appointed by Presbytery. The Moderator will be one of the team ministers, confirmed when the full team is in place. Kirk Session meets at least six times in a year. It has oversight over the whole life and service of the church within the Fife: Forthview Parish and has responsibility for the spiritual and temporal oversight of the congregation's affairs. It is supported by operational teams covering finance, property, safeguarding, communications and roll keeping.

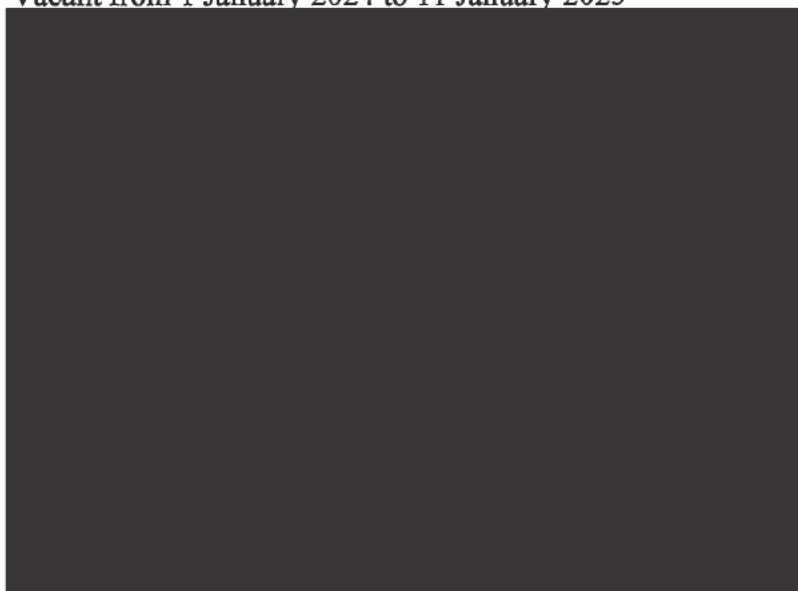

Trustees' Responsibilities in Relation to the Financial Statements

The charity trustees are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in Scotland requires the charity trustees to prepare financial statements for each year which show a true and fair view of the state of affairs of the charity and of the income and expenditure of the charity for that period. In preparing the financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the method and principles in the applicable Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operational existence.

The trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charity's transactions and disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the charity and financial information on the congregation's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

Auditor

Thomson Cooper were appointed as auditor of the church and a resolution proposing that they be re-appointed will be put to a General Meeting.

Independent Auditor's Report to the Trustees of Fife: Forthview Parish Church of Scotland

Opinion

We have audited the financial statements of Fife: Forthview Parish Church of Scotland (the 'charity') for the year ended 31 December 2024 which comprise the Statement of Financial Activities, the Balance Sheet, the Statement of Cashflows and notes to the financial statements, including significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 *The Financial Reporting Standard applicable in the UK and Republic of Ireland* (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2024, and of its incoming resources and application of resources, for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and

Basis for opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

In auditing the financial statements, we have concluded that the trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the charity's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Responsibilities of trustees

As explained more fully in the trustees' responsibilities statement set out on page 12, the trustees are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

We have been appointed as auditor under section 44(1)(c) of the Charities and Trustee Investment (Scotland) Act 2005 and report in accordance with regulations made under that Act.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Extent to which the audit was considered capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

We gained an understanding of the legal and regulatory framework applicable to the trust and the industry in which it operates and considered the risk of acts by the trust which were contrary to applicable laws and regulations, including fraud.

Our audit procedures were designed to respond to risks of material misstatement in the financial statements, recognising that the risk of not detecting a material misstatement due to fraud is higher than the risk of not detecting one resulting from error, as fraud may involve deliberate concealment by, for example, forgery, misrepresentations or through collusion.

We also addressed the risk of management override of internal controls, including testing journals and evaluating whether there was evidence of bias by the trustees that represented a risk of material misstatement due to fraud.

Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) effective from 1 January 2019 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (as amended). They are prepared on an Accruals basis.

The financial statements are prepared in sterling, which is the functional currency of the church. Monetary amounts in these statements are rounded to the nearest £.

Fife: Forthview Parish Church meet the definition of a public entity under Financial Reporting Standard 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

Fund accounting

Funds are classified as either restricted, endowment or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the Trustees' discretion to apply the fund.

Going concern

The Trustees consider that there are no material uncertainties about the ability of the charitable company to continue for at least the next 12 months, and therefore has adopted the going concern basis in preparing these financial statements.

Recognition of income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

Recognition and allocation of expenditure

Expenditure is included in the Statement of Financial Activities on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure.

Fabric Expenditure

Routine fabric repairs and maintenance are charged to the General Fund. Extraordinary repairs and improvements are met from Designated and Restricted Fabric Funds or funded from the Consolidated Fabric Funds held by the General Trustees. Funds received by way of special donations and fund-raising efforts are allocated to the appropriate Restricted Funds.

Fixed Assets

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Churches, halls and manses, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the Statement of Financial Activities in the period in which the liability arises.

All tangible fixed assets costing in excess of £5,000 having a value to the charity greater than one year, other than those acquired for specific purposes, are capitalised. Depreciation is provided on a straight-line basis to write off the cost or initial value, less residual value, of tangible fixed assets over their estimated useful lives:

Central heating boilers and controls	10 years
Office equipment	5 years

Investments

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year.

Taxation

Fife: Forthview Parish Church is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held with the Church of Scotland Investors Trust.

Debtors

Trade and other debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any discounts due.

Creditors

Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £31,642 and the maximum stipend (in the fifth and subsequent years) £38,884.

9. Trustee Remuneration and Related Party Transactions

During the year one trustee received reimbursement of expenses incurred totalling £96. Two Assistant Ministers received reimbursement of travel and other expenses totalling £4,549. (2023: £394). The Locum Minister received £14,171 in fees and £1,096 reimbursement of travel expenses. (2023: Nil).

One Trustee was paid £2,139 salary and pension scheme contributions for employment as a weekend caretaker (2023: nil). No other Trustee received any remuneration or reimbursement of expenses during the year.

Designated Youth Work	Funds set aside for use by Sunday School and other Youth Groups.
Fellowship Fund	Funds for use by members of the congregation to find fellowship, host speakers and undertake projects.
