**Trustees' Report for the year ended 31 August 2025**

Hutchesons' Choral Society is governed by a constitution which is available for inspection.

**Object**

The object of The Society shall be to educate the public in the arts and sciences, and in particular the art or science of choral music, by the presentation of concerts and other activities.

## **CHAIRPERSON'S REPORT**

As usual the choir restarted rehearsals at the beginning of September after the summer break. Recruitment of new members to the choir was quite successful and the total number of members in the choir increased to 78, up by 6 on the previous year.

The season of 2024-25 was the third year following the period of the Covid pandemic in which the operation of the choir could be considered to be completely normal in terms of the attendance of rehearsals and the performing of concerts.

The autumn concert was performed on 24<sup>th</sup> November 2024 at St Margaret's Church in Newlands, Glasgow. The programme of music was comprised of 'Magnificat' by J S Bach and excerpts from 'The Christmas Oratorio', also by Bach. The concert was well attended and generated concert receipts of £1726. Feedback from the audience was enthusiastic and very positive.

The spring concert was performed on 30<sup>th</sup> March 2025 at St Margaret's Church in Newlands, Glasgow. The programme of music was comprised of a selection of opera choruses. The concert was again well attended and generated concert receipts of £2609.

Since choir funds were in a healthy state, there was only minor fundraising activity during the year.

The general view of the committee is that the choir has weathered the storm of the pandemic and has emerged in a healthy state and able to continue our development. The choir has an excellent musical director in Tim Rhodes, excellent piano accompanist in Jane Williamson, a strong and active committee and an enthusiastic membership. Recruitment of new members is looking encouraging for the coming year and finances are in good shape.

## TREASURER'S REPORT

### Resources

Many of the resources used by the Choral Society are provided free by Hutchesons' Grammar School. This normally includes the performance and social event venues and janitorial support. The Choral Society is extremely grateful to Hutchesons' Grammar School for their continued support.

The major weekly rehearsal costs for the choral society are normally:

Musical Director: £80 / rehearsal

Piano Accompanist: £50 / rehearsal

The other main costs are associated with paying for the services of soloists and orchestra at the concerts in November and March and for the provision of musical scores.

For the reported year 2024/2025 the accounts show a healthy surplus and the general funds are sufficient to give the choir long-term stability. The aim of the committee is to maintain funds at a level approximately equal to the level of annual payments, which is now about £11,000. This ensures that significant setbacks or unexpected circumstances, as experienced during the pandemic, can be managed without the choir having to stop operating. The above stated policy has been maintained for many years now with good success.

## Independent Examiner's Report to the Trustees of Hutchesons' Choral Society

I report on the accounts of the charity for the year ended 31<sup>st</sup> August 2025.

### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities
