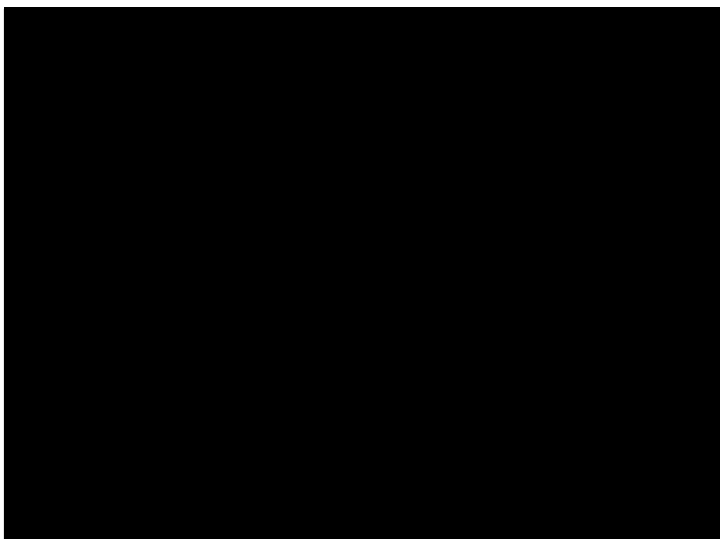
Report of the Trustees For The Year Ended 31 March 2025

OBJECTIVES AND ACTIVITIES

Charitable purposes

The purpose of the association is to provide a centre and transport for the use of elderly and special needs residents of Burray and South Ronaldsay. This is made possible with funding from Orkney Islands Council and self-funding.

Summary of the main activities in relation to these objectives

The association provides lunches to the elderly and special needs residents in the community and a place where they can socialise with each other. The Marengo Centre's wheelchair adapted minibus also provides an invaluable service for those who may be unable to travel on conventional transport.

Summary of the main achievements of the charity during the financial period

As a charitable organisation, we are extremely grateful to receive our annual funding award from Orkney Islands Council and also the much valued donation from other sources including Orkney Renewable Energy Burray aerogenerator £1,000 and in our week at the Blue Door, we managed to raise £1,379.03 along with our ongoing source of funding from "Bingo at the Marengo"

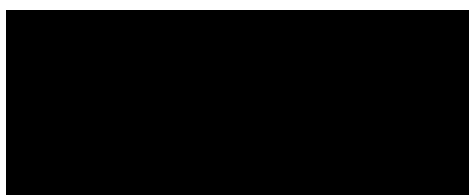
One major expense was in relation to the Marengo Centre's wheelchair adapted minibus that required to have a rear door replaced along with several other essential repairs.

Throughout this period our user numbers have increased to a healthy level providing much valued services to the community of Burray and South Ronaldsay.

Independent Examiner's Report to the Trustees of Marengo Centre

I report on the accounts for the year ended 31 March 2025 set out on pages four to seven.

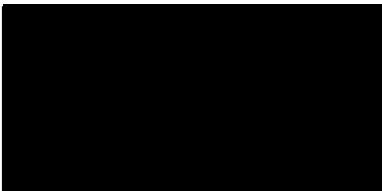
Independent examiner's statement
