REPORT OF THE MANAGEMENT COMMITTEE

Governing Document

The Sandwick Young Farmers Club is an unincorporated charity. As governed by our constitution, the club provides activities, which further personal development, cultural education and training of young people to make rural life more attractive to the young members of the community.

Charitable Purposes

To encourage new members to come along, especially younger members to advance the education and training of young people at large in rural issues, agriculture, home crafts and related subjects. To advance the development of active citizens through development of individuals involvement within their local community and leadership of their Young Farmer club. In the interests of social welfare of young people in rural Scotland (Orkney) provide and promote the provision of activities for recreation and other leisure time occupations which will improve their conditions of life and will assist in the development of their spiritual and mental capabilities and self-reliance and individual responsibility.

Trustee Recruitment and Appointment

The Club's trustees are appointed or reappointed at the annual general meeting and can hold office for a minimum of 1 year. Members of the committee shall retire annually at the AGM but the committee shall have powers to co-opt and appoint should a vacancy occur during the year. The Sandwick Young Farmers Club is run completely by volunteers and the management committee meets regularly throughout the year. The committee continues to be strong and meetings are fully attended.

Summary of the main activities in relation to these objects

We hold various events throughout each year which provides our members and the community with activities, opportunity to meet and develop within the community. We also hold various fundraising

as speech making etc. which enables our members to develop individually with various aspects.

Activities and Events

The club has enjoyed another strong year of community engagement, fundraising & competitions. The club had a strong showing at various Orkney district events such as the rally which in a great way

held an open stockholding competition as a means to raise funds for the club. We also organised a trap, pigeon & gun dog which raised funds and was a good way to include the community as was

shooting, games nights and an Isles trip to Sandness which was a great way to bond as a club.

In the forthcoming year the Management Committee are planning to promote the club more in the local community and try to attract new members to join

The clubs Management Committee are appointed by the members at our annual general meeting, which is held in March each year. The Chairman elected was Matthew Rendall, Secretaries –Alana Sinclair & Eilidh Tullock and Treasurer – Amy Neil.

Financial Review

It is the policy of the charity that unrestricted funds which have not been designated for a specific purpose should be maintained at minimum equivalent of six months expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in income, they will be able to continue the charity's current activities whilst consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout the year.

Independent Examiner's Report to the Management Committee on the unaudited financial Statements of the Sandwick Young Farmers Club.

I report on the financial statements of the Charity for the year ended 28/02/2026 as attached in the Trustees' Annual Report.

Respective responsibilities of the management committee and independent examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity's management committee consider that the audit requirement of Regulation 10 (1) (d) of the Accounts Regulations does not apply. Basis of independent examiner's statement

Notes to the accounts

Nature and purpose of funds held

Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. Restricted funds are those received with specific spending restrictions imposed on them by the donor. This year Sandwich Young Farmers received sponsorship from two local businesses to purchase club tops. Sandwich Young Farmers also raised £500 for MacMillan Cancer Support during the year.

Grants

Trustee remuneration

4 trustees received reimbursed expenses of £607 (2025: 7 trustees £2,652)
